ORDINANCE NO. 16-39

AN ORDINANCE TO AMEND VOLUME I, CHAPTER VII OF THE CODE OF THE TOWNSHIP OF NEPTUNE BY ADDING RESIDENT

HANDICAPPED ON-STREET PARKING ZONES ON WEBB AVENUE, LAWRENCE AVENUE AND ATLANTIC AVENUE AND REMOVING A HANDICAPPED PARKING ZONE ON MAIN AVENUE

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-21.7 – Resident Handicapped On-Street Parking, is hereby amended by adding the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Webb Avenue	1	South side of Webb Avenue beginning 90 feet west of the southwest intersection of Webb Avenue and Ocean Avenue
Lawrence Avenue	1	East side of Lawrence Avenue beginning 25 feet north of the northeast intersection of Lawrence Avenue and Main Avenue
Atlantic Avenue	1	North side of Atlantic Avenue beginning 43 feet west of the northwest intersection of Atlantic Avenue and Beach Avenue

SECTION 2

Volume I, Chapter VII, Section 7-21.1 – Handicapped Parking on Street, is hereby amended by *deleting* the following:

a.

The Lawrence Avenue parking zone being added to Section 7-21.7 of the Code as described in Section 1 above.

b.

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Main Avenue	1	South side of Main Avenue beginning 25 feet west of the southwest intersection of Main Avenue and New York Avenue

SECTION 3

This ordinance shall take effect upon publication in accordance with law.
