NOTICE OF PENDING CAPITAL ORDINANCE NO. 18-11 AND SUMMARY**

The capital ordinance, the summary terms of which are included herein, was introduced and passed upon first reading at a meeting of the governing body of the Township of Neptune, in the County of Monmouth, State of New Jersey, on April 9, 2018. It will be further considered for final passage, after public hearing thereon, at a meeting of the governing body to be held at the Township Municipal Complex, 25 Neptune Boulevard, Neptune, in said County, on April 23, 2018 at 7:00 p.m. During the week prior to and up to and including the date of such meeting copies of the full ordinance will be available at no cost and during regular business hours, at the Office of the Clerk for the members of the general public who shall request the same. The summary of the terms of such capital ordinance follows:

- Title:** CAPITAL ORDINANCE PROVIDING FOR ROADWAY IMPROVEMENTS TO HECK AVENUE, BY AND IN THE TOWNSHIP OF NEPTUNE, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING \$386,850 TO PAY FOR THE COST THEREOF, WHICH AMOUNT IS A TRANSPORTATION TRUST FUND GRANT RECEIVED OR EXPECTED TO BE RECEIVED BY THE TOWNSHIP FROM THE NEW JERSEY DEPARTMENT OF TRANSPORTATION'S FISCAL YEAR 2018 MUNICIPAL AID PROGRAM
- Purpose(s):** Appropriating the amount of \$386,850 for roadway improvements to Heck Avenue, by and in the Township, and all as shall be more particularly described in documents on file in the Office of the Clerk of the Township, said sum being appropriated being provided through a \$386,850 Transportation Trust Fund Grant received or expected to be received by the Township from the New Jersey Department of Transportation's Fiscal Year 2018 Municipal Aid Program

ORDINANCE NO. 18-12

AN ORDINANCE TO AMEND VOLUME I, CHAPTER VII OF THE
CODE OF THE TOWNSHIP OF NEPTUNE BY ADDING RESIDENT
ONLY HANDICAPPED PARKING ZONES ON MT. CARMEL WAY
AND BROADWAY

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-21.7 – Resident Handicapped On-Street Parking, is hereby amended by adding the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Mt. Carmel Way	1	South side of Mt. Carmel Way beginning 42 feet east of the southeast intersection of Mt. Carmel Way and New Jersey Avenue
Broadway	1	North side of Broadway beginning 49 feet east of the northeast intersection of Broadway and New Jersey Avenue

SECTION 2

This ordinance shall take effect upon publication in accordance with law.
