1. Budget Discussion

Mr. Bascom stated that the net debt of the Township is 0.572% and the goal is to be under 1%, which is within goal.

Mr. Bascom reviewed the trust fund accounts and the allowed spending on the specific accounts and their limitations.

Mr. Bascom reviewed the budget by page with the Township Committee. The Township Committee requested clarification on some of the not anticipated revenues such as Cannabis. Mr. Bascom stated they have a conservative number for the expected revenue because the market is still so new and the number of facilities has been changing in Neptune and surrounding areas.

Mr. Bascom stated the collection rate was 98.52% which is an excellent collection rate.

Mr. Bascom stated it was a planned increase in capital spending and the expenditure on debt payments has increased for this year.

Mr. Bascom noted that the Sewer Utility is in a favorable situation and this year we will not see an increase in sewer because of that.

Mr. Bascom stated the budget introduction will be scheduled for the March 25th meeting.

REPORT OF THE BUSINESS ADMINISTRATOR

The Business Administrator will report on capital projects and matters of general interest.

- Installation of Finger Docks at the Municipal Marina: The installation of new finger docks at the Municipal Marina has begun, although recent rainstorms and current high wind conditions have unfortunately delayed the process. Approximately 4 of the total 36 finger docks have been installed to date typically under optimal conditions we can install 3 or 4 in a single day. With the weather forecast looking much better in the coming days however, we expect to get the installations back on track.
- Homeless Encampment Issues: The Monmouth County Continuum of Care will hold its regular monthly case conference on Wednesday March 13th; at that time I expect to receive an update on the current population of the camp and the status of those awaiting housing. Since our last meeting, there have been additional Zoning violations issued and our Special Counsel is continuing to engage the attorney for the property owner in an effort to get them to assist in clean up of the property and removal of vacated campsites.
- Recognition for Neptune OEM Special Operations Team: The Township received correspondence today from the Toms River Police Department expressing their gratitude and crediting the Neptune OEM Special Operations Team for their efforts in responding to a suicidal individual at the Community Medical Center in Toms River on March 4th. The individual thankfully came down without incident and was referred for mental health evaluation.
- Cops vs. Kids Basketball Event: The Neptune Municipal Alliance is holding the 16th Annual Cops vs. Kids Basketball game tomorrow March 12th at 4pm at the Neptune High School gym. For anyone interested in watching our police officers take on students from the High School, there is a \$1 suggested donation and they will also have refreshments for sale.

Aliza Greenblatt Franklin Ave. Ms. Greenblatt stated she was happy to see the inclusion of resolution 24-156 that a resolution for the undercharge of the certificate of inspection, but noted the resolution was not included in the resolution packet. Ms. Greenblatt has stated that since the resolution was not available to the public, that the resolution cannot be considered this morning. Ms. Greenblatt stated that the charges are inappropriate because the properties should have been subjected to the fees for winter and Summer. Ms. Greenblatt encouraged the Township Committee to table the resolution.

M. Anthony stated the receipt of the resolution is not a violation of the open public meetings act. Mr. Anthony stated the shortfall was not due to the seasons of the property. Mr. Anthony stated occupancy did not occur in Winter.

Mr. Robinson stated Overlook is now reviewed "Overlook Manor" and has been booked as a venue through September. Mr. Robinson stated the property is being advertised as a venue

space on VRBO. Mr. Robinson also questioned the assessment of the property. Mr. Robinson asked where the Township Committee where they stand on this matter.

Mr. Anthony stated the special events ordinance was adopted at the last meeting and tonight the nuisance ordinance was introduced. Mr. Anthony stated it is his hope to have the short term rental ordinance for committee consideration shortly. The other matters will be addressed as zoning violations and be prosecuted in municipal court.

Mr. Robinson asked why an animal house ordinance with a bond requirement is not being considered.

Mr. McMillan asked what the bond amount is and Mr. Robinson stated Belmar has a \$2,000 bond.

Kevin Chambers Heck Ave. Mr. Chambers showed the Township Committee photos from a home that was burned by fire. Mr. Chambers stated the zoning use is for single family home and he believes the property is looking like a six-family home. Mr. Chambers stated there is work being done on the property without permits. The damaged structure is being used to complete new work. Mr. Chambers stated the property should be seeking variances through the Board of Adjustment. Ms. LaPlaca stated that the property received approvals through HPC and procured permits in July 2023.

Mr. Chambers stated there is a serious problem with zoning in Ocean Grove. Mr. Chambers stated the HPC is providing approvals and variances are being granted by the Zoning Officer rather than the proper jurisdiction at the Zoning Board of Adjustment.

Mr. Conn thanked the Committee for stopping by during the parade.

Brian Conn Hillside Shane Martins Mt. Hermon way

Mr. Martins thanked for tabling the resolution 24-156 and requesting the presence of Mr. Bascom at the township meeting. Mr. Martins stated there is a delay in response to OPRA requests and claimed that he would submit a new OPRA and would be hopeful that he would receive the responsive records before the next Township Committee meeting.

Reverend Ed Lee Sr. Drummond Ave.

Mr. Lee inquired about the property at 1710 West Bangs Ave. Ms. LaPlaca stated the matter is with the Redevelopment Attorney because the property is in a redevelopment zone. Ms. LaPlaca stated the Township is aware of the tank removal, but does not know what the intent is to move forward and has not received the correspondence from DEP.

Mr. Mitabell stated have because that the Town

Mark Mitchell Surf Ave.

Mr. Mitchell stated he is happy that the Township is reconsidering the ordinance. Mr. Mitchell stated he has been priced out of Ocean Grove and he believes the Short Term rentals are to blame. Mr. Mitchell stated he signed a lease that would have access for an additional 5 weeks. Mr. Mitchell stated the winter rental dates do not meet the needs of the community. Mr. Mitchell asked the Township Committee to change the dates of the Winter and Summer Seasons to meet the demand that is present in the area.

Matt Mitchell

Mr. Mitchell has been a part of the Ocean Grove Community since the 90s. Mr. Mitchell stated he is Pennsylvania half of the year, but he is still a resident of Ocean Grove as well and has been a volunteer and active in multiple organizations in Neptune Township. Mr. Mitchell stated the ordinance for short term rentals has greatly impacted his experience in Neptune and has made it so that his access to his rental for 56 days. Mr. Mitchell asked the Township Committee to reconsider the ordinance to make the tents and cottages long term.

Dan Muller Hillside Dr. Mr. Muller stated that 401 Overlook is advertising the property as a commercial venue, wedding and event venue for \$1,000 a day. Mr. Muller stated last year numerous complaints have been made on the property. Mr. Muller stated that in about a month, the property will be booked every weekend for events and parties. Mr. Muller asked the Township Committee to strongly consider the necessary changes.

Greg Davis

Mr. Davis was here to speak on the noise ordinance. Mr. Davis stated there is noise issues at the Elks Lodge. Mr. Davis has emailed the Township Committee on concerns about the events occurring at the Elk's Lodge. Mr. Davis stated his family has been in Neptune for a century. Mr. Davis asked that the Township Committee to consider an ordinance that would affect the issues being posed by the Elks Lodge such as the concerts being held at the Elks Lodge. Mr. Davis played a clip of what the noise sounds like during the music playing during the summer. Mr. Davis asked for a limit on the length and number of occurrences for the types of events being held.

Aliza Geenblatt Franklin Ave.

Ms. Greenblatt stated there are people occupying the cottages in the winter. Mr. Anthony stated he was advised by the Code department that the rentals took place in the summer only.

Ms. Greenblatt questioned the consistency of the applicability of the regulations. Ms. Greenblatt stated she believes that special treatment to the Camp Meeting Association. Ms. Greenblatt asked can an applicant apply in any way than online. Ms. Greenblatt stated the Township cannot produce receipt of payment. Ms. Greenblatt stated the figure provided by Mr. Anthony and Mr. Ciccone was not the figure that Mr. Bascom was aware of and there was a discrepancy. Mr. Anthony stated there was an error with the software and how the information was input. Ms. Greenblatt stated there were other properties affected. Ms. LaPlaca stated there were individual properties that had the same issues, but they were caught at the time of application. The unique nature of the tents and cottages was affected by the way the application was submitted and the software interpretation of the ordinance. Ms. LaPlaca stated that Mr. Bascom did a very thorough investigation.

Ms. Greenblatt asked if the ordinance is being reconsidered. Mr. Anthony stated the Township is still reviewing the information and drafting the ordinance

Eileen Michaels Seaview Ave. Ms. Michaels stated she does not believe the Township Committee does not have enough time to review the documents they are voting on and asked the Township Committee really review the information they are considering. Ms. Michaels requested that the Township Committee consider promotions and swearing ins at a time separate from the Township Committee so that they are given proper due and they don't intrude on the nature of the meeting.

Barbara Burns Ocean Ave. Ms. Burns asked questions on behalf of Richard Williams. Ms. Burns stated that Mr. Williams recorded the reasons for affirmative votes on the North End Development. Mr. Williams wanted to know what control we would lose, the relief that would be offered, control of the project, and reverting to the original redevelopment plan.

Mr. Cafferty stated that based on the comment, it is based on the assumption that the Township would win the case. Mr. Cafferty stated he was acting based on the information provided from the legal advice of Township Professionals.

Gary Brown Cardinal Rd.

Mr. Brown stated that 2 weeks ago, an OPRA request was submitted for the property and received reports from the Police Department and it showed that in 1 year there were 50 calls that included theft, EMS calls, mental health emergencies, noise, etc. Mr. Brown indicated that he did not receive a response from zoning and code on the request.

Cindy Kleibart Broadway Ms. Kleibart stated there have been numerous people who have said the Township Committee is not following up on complaints. Ms. Kleibart received a summons and complaint for a pod. The complaint was issued without due process and it was not properly addressed with the resident. Ms. Kleibart stated there is a dumpster owned by Gannon at 27 Broadway that is not permitted or has not been removed or enforced on.
