# RESOLUTION OF THE TOWNSHIP OF NEPTUNE APPROVING PINK BALLOON LLC FOR A CANNABIS BUSINESS LICENSE TO OPERATE AS A CLASS 5 CANNABIS RETAILER

**WHEREAS,** in 2020 New Jersey voters approved Public Question 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

**WHEREAS,** on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act," N.J.S.A. 24:61-31 et seq. (the "Act"), which legalizes the personal use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial personal use cannabis operations, use, and possession; and

WHEREAS, the Act establishes the following six marketplace classes of business licenses to be issued by the State of New Jersey Cannabis Regulatory Commission for the legal operation of cannabis establishments and other types of cannabis marketplace activity in the State: Class 1 Cannabis Cultivator; Class 2 Cannabis Manufacturer; Class 3 Cannabis Wholesaler; Class 4 Cannabis Distributor; Class 5 Cannabis Retailer; and Class 6 Cannabis Delivery; and

WHEREAS, section 33 of the Act (P.L. 2021, c. 16 §33, N.J.S.A. 24:61-46) and section 34 of the Act (P.L. 2021, c. 16 §34, amending N.J.S.A. 24:61-7) allows certain pre-existing State licensed Alternative Treatment Centers ("ATCs") to concurrently hold certain class(es) of the above-referenced State cannabis establishment license(s), thereby enabling such pre-existing ATCs to simultaneously operate as both a medical and personal use cannabis establishment so long as the ATC first obtains approval from the municipality in which the proposed cannabis establishment is to be located, by municipal endorsement or through a local licensing procedure and the ATC submits an expansion application to the Cannabis Regulatory Commission (the "CRC"); and

**WHEREAS,** section 31a of the Act, N.J.S.A. 24:6l-45a, authorizes municipalities to adopt ordinances and regulations prohibiting outright or limiting the number of any class of licensed "cannabis establishments" (defined in section 33 of the Act, N.J.S.A. 24-6l-33, as "a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer"), cannabis distributors, or cannabis delivery services allowed to operate within its municipal boundaries; and

WHEREAS, Pink Balloon, LLC wishes to operate as a cannabis retailer and cannabis delivery service within the Township of Neptune; and

**WHEREAS,** on February 28, 2022, the Neptune Township Committee passed Ordinance 22-10, which allows for Pink Balloon, LLC to operate as a recreational cannabis establishment within the Township of Neptune, including specifically as a "Class 5 Cannabis Retailer and/or Class 6 Cannabis Delivery service"; and

**WHEREAS,** on November 23, 2021, the CRC issued a memorandum to all ATCs in New Jersey regarding the expanded certification process for an ATC (the "Memorandum"); and

WHEREAS, in the Memorandum the CRC required, among other items, that an ATC seeking to submit an expansion certification provide proof of municipal approval, which must include, "[i]f the

municipality has a governing body, a resolution by that governing body that includes (i) The ATC's legal name under which they are registered to do business in the State of New Jersey; (ii) A determination that the municipality has authorized the type of cannabis business license being sought by the license-applicant to operate within its jurisdiction; and (iii) A confirmation that if the municipality has imposed a limit on the number of licensed cannabis businesses, the issuance of a license to the license applicant by the Commission would not exceed that limit."

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Neptune, County of Monmouth, State of Jersey, as follows:

- 1. The aforesaid recitals are incorporated herein as if set forth at length;
- 2. Pink Balloon, LLC is registered to do business in the State of New Jersey and is authorized to operate as an ATC by the CRC.
- 3. The Township of Neptune has specifically passed Ordinance 22-10, which allows Pink Balloon, LLC to operate both as a medical and personal use cannabis establishment, and specifically as a "Class 5 Cannabis Retailer and/or Class 6 Cannabis Delivery service" within the Township of Neptune's jurisdiction;
- 4. The issuance of a license to Pink Balloon, LLC by the State Class 5 Cannabis Retail by the CRC will not exceed any limits placed on the number of licensed cannabis establishments permitted to operate within the municipality;
- 5. The Township of Neptune supports the application of Pink Balloon, LLC and this Resolution may be relied upon by the CRC as proof of local support by the Township of Neptune of Pink Balloon, LLC's expansion certification;
- 6. The Township Clerk is hereby authorized and directed to provide a copy of this Resolution to Pink Balloon, LLC and to transmit a copy of this Resolution to the CRC; and
- 7. This Resolution shall take effect upon adoption in accordance with applicable law.

- 2. All costs for parts and materials will be billed at the rate paid by the Fleet Management Company plus ten percent (10%)
- 3. The Fleet Management Company shall bill the Borough for services on a monthly basis and payment shall be made to the Township within thirty (30) days of receipt of the bill. Failure to make payment or otherwise comply with the service procedures and terms and conditions of the agreement by the Borough may result in the Township terminating the agreement. Oliver and Monmouth Conservation Foundation, with acknowledgment from Neptune Township, entered into a Donation Agreement for the transfer of property on South Riverside Drive, Neptune Township, New Jersey, designated as Block 5303, Lots 2, 3 & 4 on the Tax Map of Neptune Township from Catherine S. Oliver to Monmouth Conservation Foundation, with the intent that once received by Monmouth Conservation Foundation, that the same would then transfer title to Neptune Township, per a Consultation of Services Agreement entered into between Neptune Township and the Monmouth Conservation Foundation on December 14, 2022 and extended through December 31, 2024 by Resolution #24-184; adopted by Neptune Township on March 25, 2024; and

WHEREAS, both the aforesaid Agreements and Resolutions were subject to a Title Search and Survey satisfactory to both the Monmouth Conservation Foundation and Neptune Township; and

WHEREAS, the Monmouth Conversation Foundation performed a Title Search through Western Technologies Group, LLC; certified to Trident Abstract Title Agency, LLC, which produced a Certificate of Title Search on April 1, 2024 with regard to the designated subject properties, and the aforesaid Certificate of Title Search indicated that all of the subject properties were claimed by the State of New Jersey as areas now or formerly below mean high water, as shown on the Tidelands Map, and are subject to a Riparian Claim, as they are not covered by the grant to Shark River Hills Co., and therefore, Catherine S. Oliver, owner of said properties, cannot transfer clear title at this time to the Monmouth Conservation Foundation; nor Neptune Township; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:11-3(a), the bid threshold is defined as the dollar amount at which contracts, pursuant to the Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11-1 <u>et seq.</u> ("LPCL"), may be subject to competitive bidding in which the contracting unit shall advertise for and receive sealed bids; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:11-3(c), the Governorof New Jersey shall adjust the bid threshold every five (5) years from the date of the effective date of P.L. 1999, c.440;and

WHEREAS, pursuant to the most current order of the Governor of New Jersey, the bid threshold for the awarding of contracts pursuant to the LPCL, for those contracting units with a designated Qualified Purchasing Agent ("QPA") on staff, was increased from \$40,000.00 to \$44,000.00 as of July 1,2020; and

WHEREAS, pursuant to Resolution No. 20-299, the Township previously adopted the \$44,000 bid threshold; and

WHEREAS, pursuant to New Jersey Local Unit Pay-To-Play Law, P.L. 2004, Chapter 19 ("Pay-to-Play Law"), contracts in the window between \$17,500.00, the Pay-to-Play threshold, and the current bid threshold ("Window Contracts") were required to be awarded by resolution of the governing body; and

WHEREAS, the Elections Transparency Act, P.L. 2023 Chapter 30, signed into law on April 3, 2023, permits a QPA to award contracts over the \$17,500.00 Pay-to-Play threshold but below the bid threshold without the need for approval by Resolution of the governing body; and,

WHEREAS, the Township supports the authority of the QPA to award contracts as described herein, with the intent of improved efficiency to include the ability to take advantage of marketplace conditions and improve timing of necessary acquisitions.

NOW THEREFORE BE IT RESOLVED, by the governing body of the Township of Neptune that Qualified Purchasing Agent Melissa Zucconi, as previously appointed via Resolution 22-109, is authorized to exercise contracting powers conferred to her pursuant to the Elections Transparency Act, P.L. 2023, Chapter 30.

# CALLING FOR THE MODERNIZATION OF THE OPEN PUBLIC RECORDS ACT (OPRA) AND THE SWIFT PASSAGE OF S-2930/A-4045

WHEREAS, in the 2002 "lame duck" session the Open Public Records Act (OPRA) was approved to make government records, "readily accessible for inspection, copying, or examination by the citizens of this State, with certain exceptions, for the protection of the public interest" while protecting "a citizen's right to a reasonable expectation of privacy"; and

WHEREAS, as local leaders we reaffirm our support and commitment to open and transparent government and public access to records, at the same time, we strongly support necessary reforms; and

WHEREAS, in the twenty years since the enactment of OPRA and with the advent of new technologies, we have witnessed unintended consequences and, in some cases, abuses of OPRA that place an unfair burden on local governments and taxpayers; and

WHEREAS, municipal staff and budgets are increasingly utilized to accommodate the requestors and commercial entities who inundate municipalities with public records requests to the extent that in some instances, additional personnel are hired primarily to handle such requests; and

WHEREAS, OPRA has become broadly construed in favor of access and the requestor who prevails in any proceeding in appealing a denial of access of records is permitted to collect exorbitant attorney's fees, which impacts the taxpayers and municipalities who must pay these fees; and

WHEREAS, municipalities have seen outside businesses and interests who abuse OPRA for marketing and commercial gains while utilizing municipal employees paid by the taxpayers for this benefit; and

WHEREAS, due to court decisions over the years, reasonable expectations of privacy have been diminished when it comes to the balance of transparency and OPRA perpetuates for-profit datamining, unsolicited marketing, and uncontrolled publications of records on internet search engines specifically designed to circumvent and bypass what few protective measures currently exist under OPRA, all while allowing the requestor to remain cloaked in anonymity, should they choose to exercise that option; and

WHEREAS, when commercial entities are constantly emailing OPRA requests looking for the latest lists of dogs licensed that month, inground pool permits issued, solar roof permits issued, etc., it causes our residents to not want to license their dogs, comply with permits, or interact with the municipality because they don't want to lose their privacy and/or have their information tracked and monetized for commercial purposes; and

WHEREAS, reforms to modernize OPRA are long overdue, among them: the need to address requests by commercial entities that utilize public records and the services of local government employees to generate profits, mandatory prevailing attorney fees, which created a cottage industry,

and to add language so that such fees are based on facts and circumstances and not an automatic granting; and

WHEREAS, Senators Sarlo and Bucco and Assemblyman Danielsen and Assemblywoman Flynn have introduced S-2930/A-4045, which makes commonsense reforms that do not hinder residents or journalists from using OPRA to access public records, but will protect citizens' personal information from disclosure, addresses the burdensome commercial requests and provide discretion when awarding prevailing attorney fees;

NOW, THEREFORE, BE IT RESOLVED, the governing body of the Township of Neptune in the County of Monmouth respectfully request the adoption of much-needed reforms to modernize and strengthen the legislative intent of the Open Public Records Act (OPRA) and urges the swift passage of S-2930/A-4045; and

BE IT FURTHER RESOLVED, as local leaders, we reaffirm our support and commitment to open and transparent government and public access to records but at the same time, we strongly support necessary reforms; and

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to Senate President Scutari, Assembly Speaker Coughlin, Senator Gopal, Aseemblywoman Donlon, Assemblywoman Peterpaul, Governor Murphy, and the New Jersey League of Municipalities.
