All dogs 7 months of age and older living in the Township of Neptune are required to be licensed pursuant to Ordinance #264 of the Township of Neptune. The current dog licensing period begins on July 1, 2018 and concludes on June 30, 2019. Renewal letters will be sent every year once your dog has been initially registered in Neptune Township. Application and payment must be submitted to the Office of Vital Statistics in person or by mail. The New Jersey Department of Health requires that all dogs be vaccinated by a licensed veterinarian.

**The owner must provide proof of the current rabies vaccination which must extend through at least ten months of the twelve-month licensing period (July 2020-May 1, 2021 or later). Rabies vaccinations expiring before May 1, 2021 will be returned to the owner and the owner must contact their veterinarian for a booster or medical exemption certificate.**

A list containing owners of expired dog licenses will be turned over to an Associated Humane Society Officer on September 2, 2019. Failure to comply will result in a summons for the owner of the dog. A court appearance will be required for **ALL expired rabies vaccinations**.
