The Township of Neptune, for itself, its successors or assigns, reserves onto itself the right to construct a sidewalk in the vacated properties and the right to construct, install, build, operate, maintain, use, repair, replace and relocate such public utilities and cable television facilities, within the described premises, which it may, at any time hereafter, deem necessary for the public health, safety, convenience and welfare, and the Township of Neptune shall further reserve onto itself the right to use, maintain, repair, replace and relocate all existing utilities and cable television facilities owned or controlled by it, located on or adjacent to, upon or through said lands, and further reserves onto itself an easement over. under, through and across the portion of lands described in Exhibits A through F as may be necessary or expedient for the purpose of maintaining, replacing, relocating, installing, levelling, constructing, repairing utilities, mains and appurtenances, if any, whenever there exists pipeline or appurtenances thereto beneath the surface of the aforesaid described lands, whether the same be owned by the Township of Neptune or the Neptune Township Sewerage Authority or public utility company.







WHEREAS, Labor Counsel has advised the governing body that although there is a legal fee shifting requirement in the case of OPRA, that there is no such fee shifting requirement under the Common Law, and that the Plaintiff is not entitled to legal fees in the instant matter; and
