BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-7.8 – Parking Prohibited During Certain Hours on Certain Streets, is hereby amended by adding the following:

Ocean Avenue	East	6:30 a.m. – 8:00 a.m. Thursdays From April 15 – October 15	Entire Length
Ocean Avenue	West	6:30 a.m. – 8:00 a.m. Fridays From April 15 – October 15	Entire Length
Main Avenue	North	6:30 a.m. – 8:00 a.m. Thursdays From April 15 – October 15	Between New York Avenue and Central Avenue
Main Avenue	South	6:30 a.m. – 8:00 a.m. Fridays From April 15 – October 15	Between New York Avenue And Central Avenue

SECTION 2

Main Avenue	North	6:00 a.m. – 8:00 a.m. 1 <sup>st</sup> and 3 <sup>rd</sup> Fridays of the Month	Entire Length
Main Avenue	South	6:00 a.m. – 8:00 a.m. 2 <sup>nd</sup> and 4 <sup>th</sup> Fridays of the Month	Entire Length
Main Avenue	North	7:00 a.m. – 8:00 a.m. on Thursdays	Between New York Avenue and Central Avenue
Main Avenue	South	7:00 a.m. – 8:00 a.m. on Fridays	Between New York Avenue And Central Avenue

Volume I, Chapter VII, Section 7-21.7 – Resident Handicapped On-Street Parking, is hereby amended by adding the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Heck Avenue	1	South side of Heck Avenue beginning 103 feet west of the southwest intersection of Heck Avenue and Ocean Avenue
