NOTICE OF FINAL ADOPTION OF BOND ORDINANCE NO. 16-08 AND SUMMARY

The bond ordinance, the summary terms of which are included herein, has been finally adopted by the Township Committee of the Township of Neptune, in the County of Monmouth, State of New Jersey on March 14, 2016 and the twenty (20) day period of limitation within which a suit, action or proceeding questioning the validity of such ordinance can be commenced, as provided in the Local Bond Law, has begun to run from the date of the first publication of this statement. Copies of the full ordinance are available at no cost and during regular business hours, at the Clerk's office for members of the general public who request the same. The summary of the terms of such bond ordinance follows:

Title: BOND ORDINANCE PROVIDING FOR LOFFREDO FIELD IMPROVEMENTS, BY AND IN THE TOWNSHIP OF NEPTUNE, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING \$600,000 THEREFOR (INCLUDING A \$250,000 MONMOUTH COUNTY OPEN SPACE GRANT) AND AUTHORIZING THE ISSUANCE OF \$332,500 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF

Purpose(s): Improvements to Loffredo Field, including, but not be limited to, reconstruction of the football fields, drainage improvements, a sprinkler system, and other related improvements

Appropriation: \$600,000

Bonds/Notes Authorized: \$332,500

Grant: \$250,000 Monmouth County Open Space Grant

Section 20 Costs: \$80,000

Useful Life: 15 years

ORDINANCE NO. 16-09

AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET
APPROPRIATION LIMITS AND ESTABLISH A CAP BANK FOR
PURPOSES OF INTRODUCING THE 2016 MUNICIPAL BUDGET

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Neptune in the County of Monmouth finds it advisable and necessary to increase its CY 2016 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.5 % increase in the budget for said year, amounting to \$1,106,364.46 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Neptune, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2016 budget year, the final appropriations of the

Township of Neptune shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$1,106,364.46, and that the CY 2016 municipal budget for the Township of Neptune be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

SECTION 1

Volume I, Chapter VII, Section 7-21.7 – Resident Handicapped On-Street Parking, is hereby amended by adding the following:

Lawrence Avenue	1	East side of Lawrence Avenue beginning 25 feet south of the southeast intersection of Lawrence Avenue and Broadway
Surf Avenue	1	South side of Surf Avenue beginning 40 feet east of the southeast intersection of Surf Avenue and Beach Avenue

This ordinance shall take effect upon publication in accordance with law.

ORDINANCE NO. 16-11

AN ORDINANCE AUTHORIZING A DEED OF EASEMENT FOR
UTILITY PURPOSES WITH JERSEY SHORE UNIVERSITY
MEDICAL CENTER, BLOCK 1201, PORTION OF LOT 3, AS
SHOWN ON THE TAX MAP OF THE TOWNSHIP OF NEPTUNE

WHEREAS, Jersey Shore University Medical Center made an application to the Planning Board of the Township of Neptune for site plan approval related to the construction of a site known as Hope Tower, which required a permanent 10 foot wide utility easement conveyed to Hope Tower from Neptune Township for purposes of installing, repairing and maintaining an underground communication/security conduits/cables system between the hospital and the Neptune Township Police Department; and

WHEREAS, the Grantee has prepared a Deed of Easement aforesaid, which was reviewed by the Township Attorney, a true copy of which is attached hereto and made a part hereof as Exhibit "A".

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Neptune, County of Monmouth and State of New Jersey, that pursuant to State Statute allowing municipalities to accept, seek and provide property for public use, the Township hereby authorizes and accepts and approves a Deed of Easement for utility purposes on Block 1201, a portion of Lot 3, as shown on the official tax map of the Township of Neptune between Jersey Shore University Medical Center and Neptune Township for purposes of providing communications/security lines between the hospital and the Neptune Township Police Department, as set forth more fully in Exhibit A attached hereto, which the Township Committee approves and is willing to provide to Jersey Shore University Medical Center; and

BE IT FURTHER ORDAINED, that all ordinances or parts of Ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency; and

BE IT FURTHER ORDAINED, that this ordinance shall take effect immediately upon final passage and publication as provided by law.
