

TOWNSHIP COMMITTEE MEETING – JUNE 12, 2017

Mayor Brantley called the meeting to order at 6:00 p.m. and requested the Deputy Clerk to call the roll. The following members were present: Robert Lane, Jr., Kevin B. McMillan, Carol Rizzo, Nicholas Williams and Mayor Michael Brantley.

Also present at the dais were Pamela D. Howard, Deputy Municipal Clerk; Vito D. Gadaleta, Business Administrator; and Gene Anthony, Township Attorney.

Mayor Brantley announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press on January 5, 2017 and The Coaster on January 12, 2017, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk.

The following items were discussed in open session:

The Committee discussed the grant opportunity for a dog park. Mr. Gadaleta stated he sent out an email a week ago to everyone and the Township has a short window to get an application in. He stated a location was needed.

Mayor Brantley questioned what were they trying to accomplish and would it be appropriate to have more than one park.

Mr. Gadaleta stated this park would allow the dogs to run off the leash and one park would probably eat up most of the grant money.

Mr. McMillan stated it was a great idea and suggested Sunshine Park.

Mr. Anthony stated residents might not want it in their back yards.

Ms. Rizzo stated it was really recreational and owners don't have to worry about their dogs being hit by a car. She stated she was in favor of it.

Mr. Gadaleta suggested Loffredo Field because it was centrally located.

Mr. Williams stated there was a dog park on Marconi Road in Wall and they train dogs for competition and some of our residents go there. He stated he would ask Leanne Hoffman to do a viability study.

Ms. Rizzo asked a series of questions about the drafting of the RFQ for the Historic Architect.

Mr. Gadaleta explained the normal process was to go for an RFQ and look at qualifications and vet them based on work in similar communities. Then they would put out a detailed RFP to provide us with a cost estimate for the historic district. It would be advertised in our official newspaper, League of Municipalities and the website presentation of New Jersey. It would be due by June 22nd and would be vetted by our professional members and the governing body and then they would decide.

Ms. Rizzo questioned whether campers could be parked on the street.

Mr. Gadaleta stated the Township did have an ordinance which addressed vehicles in excess of certain sizes.

The Committee reviewed their calendar of events.

AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS ACT

Mr. McMillan offered the following resolution, moved and seconded by Mr. Lane, that it be adopted:

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and,

WHEREAS, this public body is of the opinion that such circumstances presently exist,

THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune, County of Monmouth, as follows:

1. The Public shall be excluded from discussion of and action upon the hereinafter specified subject matters.

2. The general nature of the subject matter to be discussed is as follows:

Personnel – Employee termination

3. It is anticipated at this time that the above stated subject matters will be made public when matters are resolved.

4. This Resolution shall take effect immediately.

The resolution was adopted on the following vote: Lane, aye; McMillan, aye; Rizzo, aye; Williams, aye; and Brantley, aye.

The Committee entered executive session for discussion on closed session matters.

The Committee returned to the Meeting Room for the regular portion of the meeting.

Mayor Brantley called the meeting to order and requested the Deputy Clerk to call the roll. The following members were present: Robert Lane, Jr., Kevin B. McMillan, Carol Rizzo, Nicholas Williams and Mayor Michael Brantley.

After a moment of Silent Prayer and the Flag Salute, the Mayor asked the Clerk to indicate the fire exits.

The Clerk stated, "Fire exits are located in the rear of the room and to my right. In case of fire you will be notified by bell and or public address system, then proceed to the nearest smoke-free exit"

APPROVAL OF MINUTES

Mr. Williams offered a motion, seconded by Mr. McMillan, to approve the minutes of the meetings held on May 8th and May 22nd. All were in favor, except Mr. McMillan who abstained on the May 8th meeting due to his absence.

REPORT OF THE CLERK

The Clerk stated that the following reports and communications are on file in his office:

Notification from the NJDOT that the Township was awarded a Transportation Trust Fund grant for improvements to Neptune Blvd.

Notice of public hearing on an amendment to the Land Development Ordinance of the Township of Wall.

COMMENTS FROM THE DAIS

Mr. McMillan stated he visited Tommy Miles Church and he's been a pastor for 19 years.

Mr. Lane stated he attended the Boomer and Carton Show and attended the funeral of Patrick Dougherty. He also attended the MURC meeting, ribbon cutting ceremony for Brewton's formerly Carmella and the fishing tournament. At the tournament the kids had a great time and he would like

to do it again next year. He thanked both Wegmans and Walmart for their donations.

Ms. Rizzo stated she attended the Police Memorial, Ocean Grove Homeowner's meeting, Memorial Day Parade. She stated she really enjoyed the police memorial and thanked the police who put their lives on the line. She stated on May 31st she started to set up meetings with the high school and Jersey Shore Hospital for employment opportunities. They've set up a pilot program for the young people to get employment and of the 35 that were present 14 have signed on to interview and continue the process.

Mr. Williams stated on May 22nd he attended the Police Memorial and he did veterans service at the memorial park, participated in hooked on fishing and after that he did three consecutive weddings. He stated he would be presenting a proclamation on June 18th at the memorial service for Herb Herbst. He invited others to attend.

Mayor Brantley recognized Pamela Renee, councilwoman Neptune City. He stated he missed the police memorial but has attended it in the past and it's a wonderful recognition. He stated he walked in the Memorial Day Parade which was well attended. He announced the Mayor's Ball would be held on July 23rd and everyone will have a great time. He attended the grand opening of Brewton's, then Hooked on Fishing. He suggested doing Hooked on Fishing every year because the kids really enjoyed it.

Mr. McMillan commended Pamela Renee for joining them at the Police Memorial.

PUBLIC COMMENTS ON RESOLUTIONS

Hank Coakley requested an explanation of Resolution #17-274.

Mr. Gadaleta explained that the project included elevation of crown in the road on S. Concourse because there was a low spot in Bry's parking lot.

Dorothy Argyros questioned what the encroachment was that was mentioned in Resolution #17-255.

Mr. Anthony explained that everyone on S. Concourse was on the encroachment and they are saying to them that they cannot keep in the right a way so they lease to have an agreement. With this particular one it is paver blocks and fencing.

Mrs. Argyros commented on Resolution #17-258 by stating that she was disturbed that Katie Lee Thomas died in our jails. She also questioned what a Public Safety Officer was as mentioned in Resolution #17-262.

Mr. Gadaleta stated it was for a per diem EMT.

Mrs. Argyros questioned what Resolution #17-263 was for and whether there were matching funds.

Mr. Gadaleta stated it was a clean communities grant that was set up Statewide and the Township gets it every year and there's no matching funds.

Mrs. Argyros questioned Resolution #17-266 was for and how did it benefit the Township.

Mr. Gadaleta stated it was a program that did extensive online search for grants and assist them in applying for grants.

Diana Harris commented on Resolution #17-260 which pertained to the temporary interns. She questioned what advertisement method was used and suggested they make sure that it got out more public.

Mr. Gadaleta stated he was not sure exactly how it was advertised because it came out of Human Resources. He also stated two additional interns were hired today.

Ms. Harris commented on Resolution #17-263 and asked out of the money was it being used for employment and advertised.

Mr. Gadaleta stated yes and he was working with the high school who were accepting application and they were hiring. He also stated that Jersey Shore University Medical Center and the school were trying to hire students as well.

Ms. Harris questioned who were handling grants since Monique Burger left.

Mr. Gadaleta stated all Department heads were writing or collaborating on it.

Ms. Harris stated Alpha Liquor Store was not on the resolution this evening and questioned why.

Ms. Howard stated they have not received tax clearance.

ORDINANCE NO. 17-15 - ADOPTED

Mr. Williams offered the following ordinance, moved and seconded by Mr. McMillan, that it be adopted:

ORDINANCE NO. 17-15

AN ORDINANCE TO AMEND VOLUME I, CHAPTER XII, OF THE CODE OF THE TOWNSHIP OF NEPTUNE BY ADDING SECTION 12-6 ENTITLED "INVASIVE PLANTS"

The Mayor requested public comments on the above ordinance and they were as follows:

John Sampinich stated his neighbor planted bamboo and it grew out of control and onto everyone else's property. They hired crews to remove it but he was not sure how much the Township can do to solve the problem because it was evil. He stated his property was infested and he wasn't sure how to handle the problem.

Mayor Brantley suggested he give his contact information to Mr. Gadaleta to see if we can address this.

Kate Sharp, 6 Hampton Ct. stated she had bamboo and there was bamboo on Township property and questioned whether they would address it.

Mr. Gadaleta stated they would.

Ms. Sharp stated the ordinance was very broad and felt that it could be used for harassment. She also felt that it would be hard to enforce. She wanted it more about bamboo and less about plants.

Mayor Brantley stated if she had bamboo and it was not impacting your neighbor then there was nothing they could do.

Janel Jones, 807 Stamford Drive stated she just received a call from a resident whose neighbors have these invasive plants and she was 100 percent behind this ordinance. She questioned how would it be enforced.

Mr. Anthony stated it would be enforced the same way as any of our code enforcement cases.

Eileen Kean 53 Broadway stated she supported this ordinance and her neighbor has it. She questioned what remediation does she have if its already pre-existing but no encroaching her property.

Mr. Anthony stated she could take civil action which is trespassing. He stated they could not be penalized if it's not trespassing.

Mayor Brantley stated every bamboo is invasive.

Joyce Klein, 105 Mt. Hermon Way stated she was wondering whether the ordinance could be tightened up. She stated despite being in favor, what would they do with Rugosa Rose at the beach.

Mr. Gadaleta stated it's all on Camp Meeting Property and it is not an issue and it's not an encroachment.

Ms. Klein questioned what would happen if someone else plants it.

Mr. Gadaleta stated he's had it on his property and it hasn't grown like bamboo. He stated he's never seen it move out from where he planted it.

Mrs. Argyros questioned whether they were making a political problem that should be between neighbors. She stated this was unconstitutional and they were just trying to get revenue and it is insane.

Sandra Solley, Birdsall Road Farmingdale, questioned why would they do this if they have BOCA Codes.

Mr. Anthony stated property maintenance is even broader.

Ms. Solley questioned where could someone purchase bamboo.

Mr. Gadaleta stated it could be purchased from various location.

Jen Croombs questioned how they were going to enforce this ordinance.

Ms. Rizzo stated all you have to do is make a call and state that it is not yours and code enforcement will come out.

Janet Passano stated bamboo has been a horror and her trees are being strangled. She stated she was for this ordinance and felt strongly that if it is passed it will affect her friendship with her neighbor. She suggested they educate and notify people of this ordinance.

Mr. McMillan suggested putting it in the newsletter.

Mr. Gadaletta stated the newsletter goes out in one week and it can go in there.

Ms. Passano stated she felt strongly about mailings.

There being no further comments, the Mayor closed the public hearing.

The Mayor requested public comments on the above ordinance and they were as follows:

Joyce Klein, 105 Mt. Hermon Way, questioned whether these would be used to prevent fires in Ocean Grove.

Ms. Rizzo stated she wanted these to be for locked sites and completely surrounding the property.

There being no further comments, the Mayor closed the public hearing.

AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT THE LAND DEVELOPMENT ORDINANCE OF THE TOWNSHIP OF NEPTUNE BY ADDING THE DEFINITION OF EXEMPT DEVELOPMENT AND AMENDING THE DEFINITION OF MINOR SITE PLAN IN SECTION 201

The Mayor requested public comments on the above ordinance and they were as follows:

Kevin Chambers, 58 Heck Avenue, stated the real reason this ordinance was designed was to perpetrate illegal zoning and the Township has no legal right to do so. He stated the Township has been in contempt of court for prior court cases.

Mayor Brantley stated they were trying to make Neptune more business friendly and trying to make it where they don't have to come to us for minor things.

There being no further comments, the Mayor closed the public hearing.

Mr. Gadaleta stated this ordinance mirrors an ordinance adopted by Middletown. He stated this has to do with us being more business friendly.

Jack Braeden, 94 1/2 Heck Avenue, stated the Planning Board or Sub-Division Committees of the Planning Board can make approval of the sub-division because they have authority. The Land Use Administration has been violating the law and the Township is allowing it. He stated the Committee doesn't have the authority to do it and Kevin Chambers was correct and has been for years.

Mr. Gadaleta stated he was talking about minor sub-division and this ordinance is talking about development not going before a board. He stated once again they are trying to be more business friendly.

WHEREAS, Adeline A. Napolitano, with property located at 404 West Concourse, Neptune Township, New Jersey, and more specifically identified as Block 5608, Lot 7, (formerly Block 558, Lot 3.16) on the tax map of the Township of Neptune has requested a Revocable License Agreement be entered into between Neptune Township, and Adeline A. It was settled in 2014 and currently there is another lawsuit of Christine Savage and Elena Gonzales. She stated Elena Gonzales should not have to endure the harassment and the harasser should have been removed and not her. She questioned what were they doing to prevent harassment in the Police Department. She stated there should have been training and literature passed out. She stated Ms. Gonzales should not have resigned and she would be sending a letter to the Justice Department because this was a violation.

Kennedy Buckley, stated Ms. Rizzo asked a lot of good questions regarding the RFQ in Neptune. He questioned who was going to pick up the fees.

Mr. Gadaleta stated they would provide for a professional and explained the process in which it would be handled.

Rev. Lee, 12 Patricia Drive, questioned how many properties were involved as mentioned in Ordinance #17-22.

Mr. Gadaleta stated it may be three.

Mr. Lee questioned whether there would be enough money.

Mr. Gadaleta stated maybe/maybe not they would have to see.

Mr. Lee stated over the Memorial Day weekend his neighbors were noisy but the police took care of it.

Diana Harris, 17 Willow Drive, thanked Mr. Lane, Ms. Rizzo and friends in Ocean Grove for attending the meeting exploring our differences.

Ms. Harris asked if she could have a list of properties they were talking about.

Mr. Gadaleta told her to reach out to him and he would tell her.

Ms. Harris questioned the status of School House Square.

Mr. Gadaleta stated he thought we had someone but no further communications.

Ms. Harris questioned whether they had any other developers.

Mayor Brantley stated they slowed it down until they got a redevelopment attorney on board.

Ms. Harris questioned whether the streetscape has slowed down as well.

Mr. Gadaleta stated the trees are due to be delivered and the old ones removed and the lights will go up.

Ms. Harris asked wither Mayor Brantley and Mr. McMillan has read the Turner Report.

Both Committee members said no.

Ms. Harris questioned how did they know if the accreditation company was affective if they never read the report.

Mr. Anthony answered her question.

Mr. McMillan stated they are required to do training and they all have to sign off along with employees.

Barbara Byrnes, questioned whether they've considered hiring a Preservationist and not just an Architect. She stated AIA doesn't certify Architects. She clarified what she felt were guidelines and standards. She requested they follow the standards and gave meeting dates for the HPC if they wanted to come for non-technical review. She stated she wasn't clear what this person would bring to expedite this process. She stated they needed real clarity and suggested they use professionals in town who has expertise.

Joyce Klein, 105 Mt. Hermon Way, stated she took a look at the RFQ but was a little concerned because it doesn't mention Ocean Grove specifically. She was concerned with the individual who would review. She stated members of Township Committee were not professionals and asked them to consider members o the HPC. She also questioned when they were going to get 18 parking spaces.

Mr. Gadaleta stated they should get the spaces next week.

Robert Lamiot, 86 Asbury Avenue stated he supported comments regarding the RFQ and he had strong interactions with the HPC and he would recommend that they be involved.

Sondra Solley questioned what did they do with the recyclables once they pick them up.

Mr. Gadaleta stated they are taken to a recycling facility but he was not sure of the name because we just switched to them.

Pamela Renee, 91 Third Avenue Neptune City, thanked the Township for the vehicle and stated she enjoyed attending the police memorial.

Jack Braeden, 94 ½ Heck Avenue, agreed that the process before the HPC was painless and the problem came when he came before the Planning Board. He also stated at the last meeting the residents were complaining about the condition of the North End and Ms. Rizzo said that she would send Code Enforcement out to take a look into it. He stated he felt the Township was their caretakers. He stated Ms. Rizzo was wrong in saying the Camp Meeting was responsible.

Ms. Rizzo stated they were responsible to take care of it and leave it to administration to take care of it.

Mayor Brantley stated the HPC is important to us and we are not trying to dismantle them. We are not gutting the guidelines we are trying to start a process.

Dorothy Argyros, 2100 Rutherford Avenue, stated the Savage and Gonzales up a second time because no one got fired or hurt. She stated this time it could be punitive damages and if so the

guilty party has to pay. She also stated it was illegal to use code enforcement to get revenue. She read an article to the Committee.

Jen Coombs followed up on bail reform.

Mr. Gadaleta stated it's taking time to get information and there are additional cost to have bail reform.

Jeanne Schaeff, 90 Mt. Hermon Way, stated it was good to hear they supported redevelopment. She was confused by the RFQ but supported both Barbara and Joyce in the fact that an architect doesn't make sense and she was concerned with the language and how general it was. She stated she was concerned the RFQ will not attract what they need.

Hank Coakley, Valley Road, questioned when were they going to remark the roads for speed bumps in the hills.

Mr. Gadaleta stated newly installed speed tables are not up to expectations and they will be readjusted then they will be striped.

Mr. McMillan offered a motion, seconded by Mr. Williams to adjourn. All were in favor.
