AN ORDINANCE TO AMEND VOLUME I, CHAPTER VII OF THE
CODE OF THE TOWNSHIP OF NEPTUNE BY ADDING RESIDENT
HANDICAPPED ON-STREET PARKING ZONES ON INSKIP
AVENUE AND BROADWAY AND REMOVING HANDICAPPED
PARKING ZONES ON ABBOTT AVENUE

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-21.7 – Resident Handicapped On-Street Parking, is hereby amended by adding the following:

| <u>Name of Street</u> | <u>No. of Spaces</u> | <u>Location</u> |
|-----------------------|----------------------|---|
| Inskip Avenue | 1 | South side of Inskip Avenue beginning 35 feet east of the southeast intersection of Inskip Avenue and Whitefield Avenue |
| Broadway | 1 | North side of Broadway (next to median) beginning 83 feet east of the northeast intersection of Broadway and Central Avenue |

SECTION 2

Volume I, Chapter VII, Section 7-21.1 – Handicapped Parking on Street, is hereby amended by *deleting* the following:

| <u>Name of Street</u> | <u>No. of Spaces</u> | <u>Location</u> |
|-----------------------|----------------------|--|
| Abbott Avenue | 1 | South side of Abbott Avenue beginning 50 feet east of the southeast intersection of Abbott Avenue and Central Avenue |

SECTION 3

Volume I, Chapter VII, Section 7-21.7 – Resident Handicapped On-Street Parking, is hereby amended by *deleting* the following:

| <u>Name of Street</u> | <u>No. of Spaces</u> | <u>Location</u> |
|-----------------------|----------------------|---|
| Abbott Avenue | 1 | North side of Abbott Avenue beginning 113 feet east of the northeast intersection of Abbott Avenue and Central Avenue |

ORDINANCE NO. 17-08

AN ORDINANCE AUTHORIZING THE CONTINUATION OF A LEASE AGREEMENT BETWEEN THE COUNTY OF MONMOUTH AND THE MONMOUTH COUNTY SHERIFF'S OFFICE AND THE

TOWNSHIP OF NEPTUNE FOR PROPERTY LOCATED AT 1825
CORLIES AVENUE

WHEREAS, Neptune Township (Landlord) owns property commonly known as 1825 Corlies Avenue (State Route 33), Neptune Township, New Jersey; and,

WHEREAS, on June 27, 2011, the Township Committee adopted Ordinance No. 11-30 which authorized a five year Lease Agreement between Neptune Township and the County of Monmouth and the Monmouth County Sheriff's Office for use as a communications facility; and,

WHEREAS, it is in the best interest of the Township to continue said Lease Agreement at the aforesaid address for an additional term of five (5) years commencing July 1, 2016, at an agreed upon annual rent to the Landlord from the tenant in the amount of \$150,000.00 in each of the first three years and \$160,000.00 in each of the final two years,

NOW, THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Neptune, County of Monmouth and State of New Jersey that pursuant to State Statute allowing municipalities to lease public property for public use the governing body hereby authorizes a continuation of a Lease Agreement between Neptune Township and the County of Monmouth and the Monmouth County Sheriff's Office for 1825 Corlies Avenue; and,

BE IT FURTHER ORDAINED, that the Township Committee authorizes the use of 1825 Corlies Avenue, Neptune Township, New Jersey and sets forth the requirements for the use of said property in the Lease Agreement.

BE IT FURTHER ORDAINED, that the Mayor and Clerk are authorized to execute a continuation of Lease Agreement.

BE IT FURTHER ORDAINED, that this Ordinance shall go into effect upon adoption and advertisement according to law.
