- 1. Mrs. Osepchuk introduced the application to the Commission and the Public.
- 2. Administration of Oath to Mr. Robert Dweck and Applicant's Attorney, William P. Gannon. Mr. Dweck and Mr. Gannon came forward and was sworn in by Jersey Shore Reporter.
- 3. Opening statement of the interested parties was given by Mr. William P. Gannon. Mr. Gannon introduced the proposed application to the Commission and the public. The applicant proposed to make certain repairs to the subject property that was damaged during Super Storm Sandy and other renovations not related to the storm damage. The Mr. Dweck gave a brief history about the property and its previous owners.
- 4. Administration of Oath to Stephen Carlidge and April Covath of Shore Point Architecture. Mr. Carlidge and Ms. Covath came forward and was sworn in by Jersey Shore Reporter. Mr. Carlidge and Mrs. Covath marked several exhibits mostly consisting of historic photos of the subject property.
