ORDER AND ANNOUNCEMENTS:

The meeting called to order by Deborah Osepchuk, Chairperson pm. APPLICATION(S) FOR REVIEWED:

1. HPC Application 2012-001 Block 26 Lot 410 also known as 27 Bath Avenue

The applicant submitted to replace the porch flooring of the existing second floor porch with new fiberglass decking, replace existing trim and facia where necessary and replace the bases of the existing columns. Motion made by Stephanie Ann Carr, seconded by Christopher Flynn and passed.

2. HPC Application 2012-100 Block 7 Lot 495 also known as 4 Ocean Pathway

The applicant submitted to remediate an outstanding side walk violation. The property owner replaced the existing slate sidewalk with new concrete material. Motion made by Leonard Steen to approve the replacement of the damaged slate with new concrete and install new slate in the location where the slate was not damaged, seconded by Stephanie Ann Carr and passed.

3. Application 2012-036 Block 122 Lot 1285 also known as 134 Mt Tabor Way

The applicant submitted remove and replace joist on the second floor, place the framing on the second floor, replace existing porch posts, replace the existing porch flooring as required with Mahogany Tongue and Groove flooring, repair sections of the existing porch railings, 6. Applicant shall be permitted to further remove and replace any addition rotted or damaged floor or porch supports as proposed. Applicant shall not utilize any pressure treated wood in the replacement. Motion made by Lucinda Heinlein to approve the application, seconded by Stephanie Ann Carr and passed.

4. Application 2012-110 Block 22 Lot 527.02 also known as 27 Olin Street

The applicant is proposing to install a new air condenser unit in the rear yard area attached to the existing building over existing bilco doors. Motion made to approve the application made by Christopher Flynn, seconded by Stephanie Ann Carr, and passed.

5. Application 2012-122 Block 112 Lot 1166 also known as 119 Clark Avenue

The applicant proposes to replace the existing first floor porch flooring and railings. Motion made by Stephanie Ann Carr to approved the application, seconded by Leonard Steen, and passed.

6. Application 2012-114 Block 26 Lot 412 also known as 23 Bath Avenue

The applicant proposes to replace elements of the existing second floor balcony, replace the existing second floor balcony deck, replace the current second floor railings, replace the existing second floor posts, replace the existing first floor railings, replace the existing first floor posts, install a new ceiling over the first floor porch, and remove the existing trim around the existing first and second floor porches and install Azek trim or trim wrapped in Azek. Motion made by Leonard Steen to approved the application, seconded by Christopher Flynn, and passed.

DISCUSSIONS:

A discussion was held in reference in reference to the application submitted by Sawbucks Contracting requesting to install a new ceiling fan on the first floor front porch at 23 Ocean Pathway (block 25 lot 452). The Commission members will revisit the application at next months meeting after investigating the appropriate type of fan to be installed.
