AN ORDINANCE TO AMEND VOLUME I, CHAPTER VII OF THE CODE OF THE TOWNSHIP OF NEPTUNE BY ADDING A RESIDENT ONLY HANDICAPPED PARKING ZONE ON TENTH AVENUE AND REMOVING A HANDICAPPED PARKING ZONE ON OCEAN PATHWAY

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-21.7 – Resident Handicapped On-Street Parking, is hereby amended by adding the following:

Tenth Avenue	1	North side of 10th Avenue beginning 222 feet east of the northeast intersection of 10th Avenue and Atkins Avenue

SECTION 2

Volume I, Chapter VII, Section 7-21.7 – Resident Handicapped On-Street Parking, is hereby amended by *removing* the following:

Ocean Pathway	1	North side of westbound Ocean Pathway beginning 168 feet west of the northwest intersection of Ocean Pathway and Ocean Avenue

ORDINANCE NO. 18-17

AN ORDINANCE TO AMEND VOLUME I, CHAPTER XII, OF THE CODE OF THE TOWNSHIP OF NEPTUNE BY AMENDING SECTION 12-5.2, ENTITLED, "DEFINITIONS RELATIVE TO ABANDONED PROPERTY, ACTIONS CONCERNING REPAIR, CLOSING OR DEMOLITION, AND RELATING TO THIS ORDINANCE"

BE IT ORDAINED by the Township Committee of the Township of Neptune that Volume I, Chapter XII of Code of the Township of Neptune entitled, "Vacant and Abandoned Properties" be and is hereby amended with regard to the Definition Section 12-5.2, as follows:

12-5 VACANT AND ABANDONED PROPERTIES

12-5.2 - Definitions Relative to Vacant and Abandoned Property, Actions Concerning Repair and Closing and relating to this Ordinance

A) As used herein;

10) "Public Officer" shall mean the officer, officers, board or body who is or are authorized by Ordinances adopted hereunder to exercise the powers prescribed by such Ordinances and by this Ordinance. In this case, the person so designated by Neptune Township pursuant to this Ordinance shall be the Director of Code and Construction or his or her designee. Notwithstanding any other provision of the law to the contrary, nothing shall prevent the municipality from designating more than one public officer for different purposes as provided by law. Wherever "Director of Code and Construction" is cited in this Ordinance, it will be with the understanding that it is the "Director of Code and Construction or his or her designee," unless State or Federal Law limits due to licensing or other means the action of a "Director of Code and Construction."

BE IT FURTHER ORDAINED that this Ordinance shall take effect upon final adoption and publication of the notice of the adoption as required by law; and

BE IT FURTHER ORDAINED, that all Ordinances or parts of Ordinances that are inconsistent herewith are repealed, but only to the extent of such inconsistency.
