### **SBA Working Capital Loan Deadline Approaching in New Jersey Due to Excessive Rain, Flash Flooding and Flooding from April 1, 2018 through June 21, 2019**

**ATLANTA** - The U.S. Small Business Administration is reminding small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations that **April 29** is the filing deadline for federal economic injury disaster loans in **New Jersey** as a result of excessive rain, flash flooding and flooding from April 1, 2019 through June 21, 2019.

The loans are available in the following counties: Atlantic, Burlington, Camden, Mercer, Monmouth and Ocean in **New Jersey**.

Under this declaration, the SBA's Economic Injury Disaster Loan program is available to eligible farm-related and nonfarm-related entities that suffered financial losses as a direct result of this disaster. With the exception of aquaculture enterprises, SBA cannot provide disaster loans to agricultural producers, farmers, or ranchers.

The loans are for working capital and can be up to \$2 million with interest rates of 4 percent for eligible small businesses and 2.75 percent for nonprofit organizations, and terms up to 30 years.

Applicants may apply online using the Electronic Loan Application (ELA) via SBA's secure website at [DisasterLoan.sba.gov](https://DisasterLoan.sba.gov).
