

PROJECT FLOOD ZONE

The property to be developed (Block 701 Lot 1) in Neptune Township can be found on the FEMA FIRM Panel 34025C0331F, effective date September 25, 2009. Per this panel a portion of the lot is within the AE zone and X zone. The AE zone represents areas that are subject to inundation by the 1% annual chance flood, and contains a base flood elevation determined by FEMA. Zone X are areas of 0.2% annual chance flood: areas of 1% annual chance flood with average depths of less than one foot or with drainage areas less than one square mile; and areas protected by levees from 1% annual chance flood. The lot also contains a floodway area within the AE zone. This floodway area is the channel of a stream plus any adjacent floodplain areas that must be kept free of encroachment so that the 1% annual chance flood can be carried without substantial increases in flood height.

The project will be submitted to the NJDEP for verification of the Flood Hazard Area Line shown on the plan, for the driveway connection which crosses the flood hazard area along the north edge of Route 35 and for the proposed sanitary main and manhole located in the same area. All work aside from the aforementioned driveway connection and sanitary sewer improvements will be kept outside of the Flood Zones mentioned. Included with this memo is a copy of the FEMA FIRMette showing the project lot.
