

Rich Robinson	Mr. Robinson spoke to the issues and new complaints for noise complaints at 401 Overlook.
Hillside Dr.	Mr. Robinson stated the animal house ordinance has no teeth. Short Term rentals need to be overhauled because they are causing numerous issues in town.
Dan Muller	Mr. Muller dealt with an event that went through the night until 9am the next day at 401
Hillside Dr.	Overlook Dr. Mr. Muller stated that the neighborhood sent a complaint to Airbnb, and they stated they could not do anything about the issue. Mr. Muller asked the township to look into this to see if there are not enough violations to revoke the mercantile registration.
Ed Yasser	Mr. Yasser stated he was here to address the construction of the Pole Barn on Riley Rd. Mr.
Waterview Ct.	Yasser stated the issues with the documents that were made publicly available regarding the pole barn. Mr. Yasser stated that he received documents through an OPRA request. Mr. Yasser stated the document provided was not accurate to the specifications and Mr. Yasser believed this meant the most up to date documents were not provided. Mr. Yasser stated the pole barn is larger than any house in the neighborhood.
Nancy Clarke	Ms. Clarke stated she is in favor of the pilot permit parking program.
Embury Ave.	Ms. Clarke asked if the federal money is now available for the bridge repairs at Wesley Lake and Ms. Clarke asked if this will affect the gates on the footbridges. Ms. Clarke stated that ICE is affecting the quality of life for many Neptune Residents. Ms. Clarke stated there was a rumor that ICE apprehended some undocumented immigrants, and the Police Dept stated they have no knowledge or involvement with ICE.
Ann Bishop	Ms. Bishop stated ICE was in Asbury Park Elementary school. Ms. Bishop is not in support
Franklin Ave.	of the pilot permit parking program. Ms. Bishop stated she was an advocate for the animal house ordinance. Ms. Bishop stated that Ocean Grove short term rentals supported the inclusion of Animal House Regulations. Ms. Bishop stated she was concerned that a child was included in the event held at 401 Overlook.
Louisa Pastor Broadway	Ms. Pastor stated concern about the ICE in the community. Ms. Pastor believed the Township should be educating the public on their rights when confronted by ICE. Ms. Pastor asked the Township Committee to look into having access to multi-language educational information.

Mr. Lane presented the proclamation to the school board.

Public Comment Resumed: Eleanor Kalasick Waterview Ct	Ms. Kalasick asked why it was positioned where the Riley Rd Pole Barn and she didn't believe that the equipment and pole barn would not be an effective location.
Gary Brown Cardinal Rd	Mr. Brown said it is frustrating that not one question was answered about the clothing bins. Mr. Brown thanked the police department for the positive impact they have for Neptune Township residents. Mr. Brown asked if the garbage pickup at the encampment is on hold until February. Ms. LaPlaca stated the pick up is supposed to be ongoing and will follow up with Code enforcement. Mr. Brown stated that Code Enforcement will be inundated with issues for clothing bins with this new ordinance. Mr. Brown stated that Municipal Clerk Ms. Siboni will be missed and was unhappy with the decision that the Township Committee made about Ms. Siboni's reappointment.
Donna Yasser Waterview Ct.	Ms. Yasser stated she is very happy that the Township is listening to feedback about the Riley Rd. Pole Barn. Ms. Yasser stated all related documents in an OPRA request seemed outdated in the response. Ms. Yasser inquired why or when the changes to this specification were made. Mr. Lane stated the project is halted until these questions can be answered.
Amy Heller Mt. Tabor Way	Ms. Heller addressed comments on animal house and short term rental ordinance. Ms. Heller was an advocate for the two (2) night minimum requirement. Ms. Heller is in favor of the animal house portion of the ordinance and would support the violations and penalties for the bad behavior at some short term rentals that are in Shark River Hills. Ms. Heller is strongly opposed to the pilot permit parking program. Ms. Heller was concerned with the vitriol this program is creating in the community, concerns about enforcement and community safety.
