Also present were Stephanie Oppegaard, Acting Business Administrator, William Bray, Township Clerk and Lester Taylor, Township Attorney.

**EXECUTIVE SESSION**

**RESOLUTION 25-365**

**AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS ACT**

**WHEREAS**, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and,

**THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Neptune, County of Monmouth, as follows:
