

The appropriation for office supplies is up \$2,000 which is a 28.6% increase to reflect the result of operations in 2025. Administration Fringe Benefits have decreased by 18.4%. Operations Fringe Benefits has increased 24.3% which reflects the increased cost of employee health insurance set by the State Health Benefits Program. A 12.1% increase on the cost of all lines insurance is more than offset by a 40% decreased in insurance deductibles. Appropriations offset with Revenues - Fringe is down 100% as a result of taking the \$2,500 appropriation in the 2025 budget and applying that same amount to Appropriations Offset with Revenues - Salary.

The District proposes an increase of \$19,328 in the amount to be raised by taxation which is a 2.6% increase versus 2025. The budget proposed the use of \$170,000 in unrestricted fund balance in the general budget. The total of \$170,000 in unrestricted fund balance utilized is \$10,000 more than utilized in 2025. The budget proposes zero use of restricted fund balance in 2026. The budget is compliant with the Property Tax Levy Cap
