## **RESOLUTION #2020-9-2**

# AUTHORIZE CHANGE ORDER #1 (FINAL) IN CONNECTION WITH RENOVATIONS TO BATHROOM AT EAGLE FIRE HOUSE

WHEREAS, a contract was awarded to Robert Gassner in the amount of \$18,900.00 in connection with the project to renovate the 2<sup>nd</sup> floor bathroom at Eagle Fire House; and,

WHEREAS, changes to the contract has been experienced as a result of adding floor drain, upgrading the hot water supply line, rerouting the sewer pipe system around a steel beam, and eliminating the need to replace the entrance door; and,

WHEREAS, funds for this purpose are available in the 2020 Fire District Budget and the Chief Financial Officer has so certified,

THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Neptune Township Fire District #2 that Change Order #1 (final) in the contract with Robert Gassner in connection with the project to renovate the 2<sup>nd</sup> floor bathroom at Eagle Fire House resulting in a net increase of \$3,400.00 revising the total contract amount to \$22,300.00.

## **RESOLUTION #9-1-2020**

# INCREASE BID AND QUOTATION THRESHOLDS PURSUANT TO STATE REGULATION

WHEREAS, pursuant to N.J.S.A. 40A:11-3(c) and 18A:18A-3(b), the State Treasurer has exercised his authority to adjust the bid thresholds for awarding contracts by various contracting units; and,

WHEREAS, Neptune Township Fire District #2 has appointed a Qualified Purchasing Agent pursuant to N.J.S.A. 40A:11-9(b) and therefore can increase the maximum bid threshold from \$40,000 to \$44,000 and the maximum quotation threshold to 15% of the bid threshold, or \$6,600,

THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Neptune Township Fire District #2 that the maximum bid threshold is hereby established at \$44,000 and the maximum quotation threshold is hereby established at \$6,600 in connection with purchases and contracts by Neptune Township Fire District #2 in accordance with action taken by the State Treasurer pursuant to N.J.S.A. 40A:11-3(c) and 18A:18A-3(b).
