AN ORDINANCE TO AMEND VOLUME I, CHAPTER XXIII OF THE
CODE OF THE TOWNSHIP OF NEPTUNE BY APPLYING THE
REGULATIONS FOR PARKS AND PLAYFIELDS TO ALL
TOWNSHIP OWNED OPEN SPACE

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter XXIII, Section 23-1 – Regulations for Parks and Playfields, is hereby amended as follows:

Section 23-1.1 – Locations Designated, is amended to add the following at the end of the list of parks and playgrounds:

In addition to the locations set forth herein, the provisions of this Chapter shall apply to any and all open space owned by the Township including all areas identified in the Township's Roster of Open Space Inventory.

SECTION 2

This ordinance shall take effect upon publication in accordance with law.

AN ORDINANCE TO AMEND VOLUME I, CHAPTER VII OF THE
CODE OF THE TOWNSHIP OF NEPTUNE BY ADDING A
HANDICAPPED PARKING ZONE ON HECK AVENUE AND
REMOVING HANDICAPPED PARKING ZONES ON ATLANTIC
AND SEAVIEW AVENUES

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-21.2 - Handicapped Parking Spaces on Public Roads - Locations Designated, is hereby amended by adding the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Heck Avenue	1	South side of Heck Avenue beginning 53 feet east of the southeast intersection of Heck Avenue and Central Avenue.

SECTION 2

Volume I, Chapter VII, Section 7-21.2 - Handicapped Parking Spaces on Public Roads - Locations Designated, is hereby amended by *deleting* the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Atlantic Avenue	1	South side of Atlantic Avenue beginning 158 feet east of the

southeast intersection of Atlantic Avenue and Central Avenue.

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Seaview Avenue	1	North side of Seaview Avenue beginning 165 feet west of the northwest intersection of Seaview Avenue and Ocean Avenue.

SECTION 3

This ordinance shall take effect upon publication in accordance with law.
