Mayor Brantley called the meeting to order at 6:00 p.m. and requested the Clerk to call the roll. The following members were present: Keith Cafferty, Robert Lane, Jr., Nicholas Williams, Tassie D. York, and Mayor Michael Brantley.

Also present were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; and Gene Anthony, Township Attorney.

Mayor Brantley announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in The Coaster and the Asbury Park Press on May 27, 2021, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk. In addition, the meeting agenda is posted on the Township web site (<a href="https://www.neptunetownship.org">www.neptunetownship.org</a>) and the meeting is being streamed live via townhallstreams.com.

The following items were discussed in open session:

Mayor Brantley announced that if anyone in the audience is here for Ordinance No. 21-49, also known as the nepotism ordinance, there will be a motion to table the ordinance during the regular meeting.

Mr. Lane announced a Veterans Day service at Post 66 at 11:00 a.m. on November 11th.

Mr. Gadaleta forwarded a press release from Coastal Habitat regarding work being done on the home of Arden Thorne, long time postal worker in Neptune. Coastal Habitat is installing a new roof and a flag pole on Veterans Day to honor Mr. Thorne's military service.

# <u>AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS</u> ACT

Mr. Lane offered the following resolution, moved and seconded by Mr. Cafferty, that it be adopted:

The Committee reviewed recommendations for the hiring of seasonal Drivers, a Custodian, two full-time Drivers and a Bookkeeper. Mr. Cafferty and Ms. York requested that be allowed to interview the candidates for the Bookkeeper position. The Committee took action by resolution during the regular meeting to hire in the positions indicated with the exception of Bookkeeper.

The Committee reviewed the removal of Deion Johnson as a member of the Planning Board and took action by resolution during the regular meeting. There were no recommendations for a replacement at this time.

The Committee indicated that the "nepotism" ordinance would be tabled to allow for the new Business Administrator to make her recommendations.

The Committee asked that a RFQ be issued for Interim Engineer for 2022. Mr. Cafferty and Ms. York indicated that they will meet with anyone who responds to the RFQ.

The Committee returned to the Meeting Room for the regular portion of the meeting.

Mayor Brantley called the regular meeting to order and requested the Clerk to call the roll. The following members were present: Keith Cafferty, Robert Lane, Jr., Nicholas Williams, Tassie D. York, and Mayor Michael Brantley.

# **COMMENTS FROM THE DAIS**

Mr. Lane attended numerous Trunk or Treat events, the PBA Local 74 steak bake and the Veterans Day ceremony at Veterans Memorial Park. He congratulated the Mayor, Mr. Williams, and Ms. York on their election victories. The Senior Center recently upgraded their computers which was paid for entirely by grant funds. The Center conducted a well attended seminar on Medicare. Early voting was conducted at the Senior Center and it worked out well. The upcoming Thanksgiving luncheon was sold out in 2 ½ hours. The Center hosted a senior cinema for Halloween and served over 120 people at the recent vaccination and booster clinic. Finally, he thanked the County for the donation of a 2<sup>nd</sup> bus for the Center.

Ms. York attended the Veterans Day memorial event on November 6<sup>th</sup>. It was special because four of her brothers served in the Army. She also attended the Cancer Walk and Trunk or Treat. She congratulated the Mayor and Mr. Williams on their victory. She also congratulated Jerome Hubbard, Sheila Jones, and Jessie Thompson on their apparent victory in the Board of Education election.

Mr. Cafferty offered congratulations to the Mayor, Mr. Williams and Ms. York on winning the election. The Halloween event at the Gables was very well done and included a magic show and a showing of the Great Pumpkin. He thanked the Public Works Department for their work on the disc golf course.

Mr. Williams stated that the leaves are now falling and Public Works is out with the trucks cleaning up. Boats from the marina are catching striped bass just outside the inlet and are hoping the warm weather continues. The library is now back to pre-pandemic hours and is open six days a week.

Mayor Brantley spoke at a wreath laying at Veterans Memorial Park. Our Veterans sacrificed a lot for our freedom and it is nice to honor them and their families. He called on everyone to support our Veterans.

### BUSINESS ADMINISTRATOR'S REPORT

Mr. Gadaleta provided an update on Township projects as follows:

The Planning Board voted to approve the application of M&M Properties for the redevelopment of the former Coca Cola site at Route 35 and Asbury Avenue. This project includes a new Aldi Supermarket and three additional pad uses, including a gas filling station with retail, a restaurant and additional retail use. While the project was approved the vote was not unanimous at 5 members voted yes, 2 members voted no and one member abstained.

Solar Landscape of Neptune and Asbury Park was awarded two Community Solar Grants for projects in Neptune. These projects, supported by the Township, will construct solar panel arrays on two storage facilities located on Routes 33 and 66. The State's Community Solar Program will enable low and moderate income households and the environmental justice community access to clean energy and savings on their electricity bills. For more information you can visit NJCleanEnergy.com/COMMUNITYSOLAR. Potentially, 400 low/mod homes may be benefitted by these two projects. Solar Landscape continues to work with Neptune building owners to build out more projects. I have placed some program brochures on the table outside the meeting room.

Mayor Brantley received correspondence from NJDOT advising that Neptune Township had been selected to receive funding from the NJDOT Fiscal Year 2022 Municipal Aid Program for Improvements to Neptune Boulevard Project in the amount of \$448,600.

After tonight, he will be the Administrator for three more meetings.

There includes a hardship placement in the street for Ocean Grove and maintains the prohibition on weekends in the summer months in Ocean Grove. The ordinance is enforced by Code or Construction and the dumpster application is the same.

David Chernin, Lawrence Avenue, urged swift approval of the ordinance.

WHEREAS, Monmouth County SPCA has proposed a rate of \$7,125.00 per month for 2022 which is the same rate as provided in the 2021 contract; and,

WHEREAS, funds for this purpose will be provided in the 2022 Municipal Budget, when adopted, in the appropriation entitled Dog Account, and the Chief Financial Officer has so certified in writing.

THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Neptune that the Mayor and Clerk be and are hereby authorized to execute an agreement with Monmouth County SCPA for animal control services for the year 2022 at a cost of \$7,125.00 per month; and,

# PRIVILEGE OF THE FLOOR/PUBLIC COMMENTS

Mayor Brantley asked for public comments. The public was permitted to speak one time with a limit of five minutes. Comments were as follows:

Joan Venezia, 107 Mt. Hermon Way, asked for a status of the North End application at the Historic Preservation Commission. Mr. Gadaleta stated there in no updated information. Ms. Venezia asked if the Planning Board approval has a timeframe to submit the required items or risk losing the approval. Mr. Cafferty suggested that she contact the Planning Board Administrative Officer.

Annabelle Bissett, Heck Avenue, stated there is nothing on the Township web site regarding

North End. She feels there should be a link to the OGNED application to provide status updates. Mr. Gadaleta will look into the matter. She asked if power lines could be moved underground when roads are repaved. She asked if there are any goals for parking solutions in 2022. Mr. Cafferty replied that he and Ms. York have attended two meetings. There should be recommendations moving forward and possibly a survey being done. Ms. Bissett stated that the parking problem does not affect her, but a parking permit plan will cause her to be impacted. She asked the Committee to consider that some people are selfish in regards to parking. The Mayor stated that he has been involved in this issue for many years. One proposal did push the problem from north to south and that factor does need to be considered.

Dianna Harris, Willow Drive, offered congratulations on the election. She asked where the solar electric project will be located, where Neptune Blvd will be improved, and what plan the Township has for taking down buildings on West Lake Avenue. She also asked if the various homeowners associations and MURC could have a small article in the joint Township/Board of Education newsletters. Mr. Gadaleta responded that the Community Solar project will be 400 homes Township-wide. A kick off meeting and bar-be-que is being planned. The Neptune Boulevard work will be between Bangs Avenue and Shop-Rite. He has no update on a Redeveloper for West Lake Avenue and the Public Works Department will be tearing down the buildings owned by the Township. He suggested that Ms. Harris speak to the new Business Administrator regarding the newsletters.

Katie Roessle, 66 Cookman Avenue, complimented the Road Department on installing a dry well in front of her home to alleviate ponding of water. She stated that there are tree trunks that need to be ground out at Boswell Park and a railing is needed on the stairs. She advised that the house across the street from her has no railings on the porches and renters living there. Mr. Gadaleta will follow up.

Bishop Paul Brown, asked for relief from the Fire Official's requirement for an inspection of the church parsonage. An inspection would cost thousands of dollars. There is a food pantry housed there which would be difficult to move to the church. Mr. Gadaleta stated that this is a matter for the Fire District which is an autonomous body. He will send contact information to Bishop Brown.

Mr. Williams offered a motion, seconded by Ms. York, to adjourn. All were in favor.
