ORDINANCE NO. 12-31

AN ORDINANCE TO AMEND VOLUME I, CHAPTER VII OF THE  
CODE OF THE TOWNSHIP OF NEPTUNE BY ADDING  
HANDICAPPED PARKING ZONES ON CLARK AVENUE, BEACH  
AVENUE AND ABBOTT AVENUE, DELETING A HANDICAPPED  
PARKING ZONE ON ANELVE AVENUE AND ADDING A NO  
PARKING ZONE ON OAK TERRACE

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-21.2 - Handicapped Parking Spaces on Public Roads - Locations Designated, is hereby amended by adding the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Clark Avenue	1	South side of Clark Avenue beginning 75 feet east of the southeast intersection of Whitefield Avenue and Clark Avenue
Beach Avenue	1	West side of Beach Avenue beginning 150 feet north of the northwest intersection of Seaview Avenue and Beach Avenue
Abbott Avenue	1	North side of Abbott Avenue beginning 10 feet east of the fire hydrant located in front of 77 Abbott

Avenue

SECTION 2

Volume I, Chapter VII, Section 7-21.2 - Handicapped Parking Spaces on Public Roads - Locations Designated, is hereby amended by *deleting* the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Anelve Avenue	1	West side of Anelve Avenue beginning 275 feet north of the southwest intersection of Anelve Avenue and Monroe Avenue (space shall be large enough to accommodate an ambulance).

SECTION 3

Volume I, Chapter VII, Section 7-7.7 – Parking Prohibited at All Times on Certain Streets, is hereby amended by adding the following:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Oak Terrace	Southern end	At the southern dead end stub of Oak Terrace beginning at the intersection of Block 1303, Lot 64 and Block 1303, Lot 41 and running 50 feet east.

SECTION 4

This ordinance shall take effect upon publication in accordance with law.

ORDINANCE NO. 12-32

AN ORDINANCE AMENDING ORDINANCE NO. 11-48 ENTITLED "AN ORDINANCE CREATING AND SETTING THE SALARY RANGE FOR NEW JOB TITLES AND AMENDING THE SALARY RANGES FOR ALL OTHER EXISTING JOB TITLES OF THE TOWNSHIP OF NEPTUNE AND REPEALING ALL PARTS OF PREVIOUS ORDINANCES INCONSISTENT HEREWITH" BY AMENDING THE SALARY RANGE OF CERTAIN JOB TITLES AND ELIMINATING CERTAIN JOB TITLES NO LONGER IN USE

BE IT ORDAINED, by the Township Committee of the Township of Neptune, County of Monmouth, State of New Jersey, as follows:

SECTION 1. Ordinance No. 11-48 be and is hereby amended to *delete* the positions of Project ANCHOR Coordinator, Project ANCHOR Counselor and Project ANCHOR Mentor.

SECTION 2. The salary ranges for following existing job titles in Ordinance No. 11-48 are hereby amended as follows:

SECTION 3. This ordinance shall become effective January 1, 2013.

SECTION 4. The salary for each position named above shall be established within the aforesaid ranges by adoption of a contract with employees of AFSCME Local 1844, the Neptune Township Management and Department Heads Association, P.B.A. Local #74, F.O.P. Local #19 or by individual contract for employees not represented by a bargaining unit.

SECTION 5. That all ordinances or parts of ordinances of the Township of Neptune in conflict or

inconsistent with this ordinance are hereby repealed.
