AN ORDINANCE AUTHORIZING ACCEPTANCE OF DEED OF DEDICATION WITH REGARD TO BLOCK 10017, LOT 9.02 TO THE TOWNSHIP OF NEPTUNE

WHEREAS, EI Properties, Inc., a New Jersey Corporation having an address of c/o EI Realty, 8 Ridgedale Avenue, Cedar Knolls, New Jersey 07927, the owner of property located at Block 10017, Lot 9.02 is desirous of transferring title to the aforesaid property for \$1.00, since the Township owns adjoining lots and blocks to the subject property located off of Jumping Brook Road,
