TOWNSHIP COMMITTEE MEETING - NOVEMBER 25, 2013

Mayor Houghtaling called the meeting to order at 6:00 p.m. and requested the Clerk to call the roll. The following members were present: Mary Beth Jahn, Kevin B. McMillan and Mayor Eric J. Houghtaling. (J. Randy Bishop and Dr. Michael Brantley arrived at the end of the open workshop session)

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Township Administrator; Michael J. Bascom, Chief Financial Officer; and Gene Anthony, Township Attorney.

Mayor Houghtaling announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press on January 4, 2013 and The Coaster on January 3, 2013, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk.

The following items were discussed in open session:

The Committee discussed the purchase and placement of electronic sign boards to advertise recreation events. Mr. Gadaleta stated that there are funds in the Recreation Trust Fund that would be used for this purpose and the Recreation Director has received bids from three companies. Dawn Thompson, Recreation Director, was present and stated that the signs would also be useful during emergencies. She recommended six locations throughout the Township: Municipal Building, Gables Park, Jumping Brook Ballfields, Shark River Hills Firehouse, Main Avenue entrance to Ocean Grove and Midtown Commons Park. The signs can be programmed remotely and cost \$19,000 for a single sided sign and \$30,000 for both sides. The Trust Fund balance is close to \$200,000.00 and funds should be expended at the end of each year. Mr. Bascom stated that money that comes into the Trust Fund in one year should be spent in the same year, but a large balance has accumulated in the fund. The fund is utilized for various recreation related items throughout the year. Ms. Jahn questioned how the signs would hold up. Ms. Thompson stated that the signs were made of a heavy gage aluminum and durable plastic.

Mr. Gadaleta stated that the Army Corps has awarded a bid for the sand replenishment project from Avon to Asbury Park. The DEP will conduct a meeting on December 5th at the Municipal Building for all agencies involved. The project will start in December.

Ms. Jahn stated her concern that there are no state regulations as to who is authorized to perform home elevations in the flood zone. Two homes have been dropped and destroyed in other towns. Mr. Anthony stated that the State should be involved in this with certifications and regulations. The issue is beyond the scope of a municipality. Mr. Gadaleta stated that there are regulations and credentials required to obtain a construction permit. The Mayor asked if insurance is required. Mr. Gadaleta stated that the property owner needs to verify that insurance is in place. Mr. Anthony stated that this is the same as any other contractor in that the homeowner needs to ask for proof of insurance. Mr. Bascom stated that he has a list of Frequently Asked Questions regarding home elevations that can be put on the Township web site.

The Mayor stated that he has noticed a lot of homes with blue tarps on the roof both since and before Sandy hit. He would like to look into doing something to compel the homeowner to make the necessary repairs so that the tarp can be removed. Mr. Bascom stated that Bill Doolittle has sent some notices to the offending property owners and is making progress on addressing this issue.

Mr. Gadaleta stated that the Township Engineer is finalizing specifications and electric connections for the Broadway lighting project. It is estimated that it will take 8 to 12 weeks for the light fixtures to arrive. Mr. Gadaleta added that the use of LED lighting is being reviewed which would be more durable.

Mr. Bishop and Dr. Brantley arrived.

<u>AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS</u> ACT

Ms. Jahn offered the following resolution, moved and seconded by Mr. McMillan, that it be adopted:

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and,

WHEREAS, this public body is of the opinion that such circumstances presently exist,

THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune, County of Monmouth, as follows:

- 1. The Public shall be excluded from discussion of and action upon the hereinafter specified subject matters.
 - 2. The general nature of the subject matter to be discussed is as follows:

Personnel – Recommendation for Customer Service Representative in Public Works Department

Real Estate negotiations – Blue Acres acquisitions.

- 3. It is anticipated at this time that the above stated subject matters will be made public when matters are resolved.
 - 4. This Resolution shall take effect immediately.

The resolution was adopted on the following vote: Bishop, aye; Brantley, aye; Jahn, aye; McMillan, aye; and Houghtaling, aye.

The Committee entered executive session for discussion on closed session matters.

Mr. Gadaleta reported that a meeting was held with the State and a list of properties provided for possible Blue Acres acquisition. All of the properties submitted are on the waterfront and make sense for acquisition. The Township will be notified in the Spring if the State will be acquiring.

The Committee returned to the Meeting Room for the regular portion of the meeting.

Mayor Houghtaling called the meeting to order and requested the Clerk to call the roll. The following members were present: J. Randy Bishop, Dr. Michael Brantley, Mary Beth Jahn, Kevin B. McMillan, and Mayor Eric J. Houghtaling.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Township Administrator; Michael J. Bascom, Chief Financial Officer; and Gene Anthony, Township Attorney.

After a moment of Silent Prayer and the Flag Salute, the Mayor asked the Clerk to indicate the fire exits.

The Clerk stated, "Fire exits are located in the rear of the room and to my right. In case of fire you will be notified by bell and or public address system, then proceed to the nearest smoke-free exit"

Mayor Houghtaling announced that the notice requirements of R.S. 10:4-18 for an "Annual Notice" have been satisfied by the publication of the required advertisement in the Asbury Park Press on January 4, 2013 and The Coaster on January 3, 2013, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk. APPROVAL OF MINUTES

Mr. Bishop offered a motion, seconded by Mr. McMillan, to approve the minutes of the meetings held on October 10th, October 28th and November 6th. All were in favor.

The Mayor proclaimed the month of December as Drunk and Drugged Driving Prevention Month in the Township of Neptune.

COMMENTS FROM THE DAIS

Randy Bishop stated he attended the Gables Homeowners Association with the Mayor and as always speed and recklessness was the topic of conversation. He also attended the Jersey Shore University Medical Center and Housing Authority ground breaking for the new housing that will replace the John Knox homes across the street. He stated it was great to be there in a sense that they first started on this project when he was a commissioner on the Housing Authority. He also stated that he went to the League of Municipalities and attended some very interesting classes. He focused on Land Use/Land Development and assessing. He also stated that he represented the Mayor this evening at the High School for a vigil for awareness an prevention on Drunk Driving. He stated there was a good message. He stated he attended the ground breaking on Veterans Day for Memorial Park as well.

Mary Beth Jahn stated she attended the Ocean Grove United Harvest Brunch at the Starving Artist in Ocean Grove. She states she's been focused on getting her mom moved up here from Philadelphia and they hoped to donate some rooms of furniture to some Sandy victims. She also reported that she was now working a second shift.

Kevin McMillan stated he also attended the ground breaking for the Housing Authority and Meridian. He attended the Memorial Park ground breaking and this Saturday he attended the funeral of Morris Biel and employee in the Public Work's Department. He worked for the Township for 25 years. He also stated he attended MURC's meeting and commended Dianna Harris on how great it was and thanked Mr. Ermon Jones for hosting it. He attended the League of Municipalities and went to classes on substanibility and recreation.

Dr. Michael Brantley stated he's missed a number of events due to personal issues and now that they were resolved hopefully he would not miss any more events.

Mayor Eric Houghtaling stated he attended the ground breaking for the Memorial Park. He stated it was nice to have all the veteran's groups present and a lot of people from the community were also present. He stated he would be happen when they could get started with the demolition of the farm house. He also stated he attended the ground breaking for the new senior housing and there will be 50 new units. By doing this it would allow the hospital to grow and it is a good fit for everyone involved. He went on to state that he taught a third grade class at Shark River Hills School and he learned a lot. He felt it was a great experience so he invited them to attend the next Township Meeting to lead the pledge of allegiance. He also stated he had a Governors mobile unit here to help regarding Sandy. He stated they were still trying to do all that they could to help everyone. He stated he spent the evening with Herb Herbst at the Jersey Shore Performing Arts Center and he's done a lot with restoring that building. The township gave him a proclamation for all that he's done. He stated he also went to the League of Municipalities and anything you could think of they had. Mr. McMillan stated he also taught a class at the Middle School as well and they had a poster contest.

PUBLIC COMMENTS ON RESOLUTIONS

Tassie York, 11th Avenue, congratulated the Mayor and Mr. Bishop on their election victory and commended Dr. Brantley and Mr. McMillan on their campaign for state legislature.

Michael D. Fornino, 120 Fulham Place, asked if any member of the Township Committee was part of the negotiating team in regards to the resolutions approving employee contracts. The Mayor stated that no members were part of the negotiating team. Mr. Bascom stated that no one member is on the team but all members are advised of progress. Mr. Gadaleta stated that the entire Committee sets the parameters of negotiations and all participate in final discussions. The Mayor stated that the Committee has professionals who do a good job negotiating contracts.

Joan Venezia, 107 Mt. Hermon Way, in reference to a lien being placed on property, asked if World Changer participants pay for supplies. The Mayor stated that it depends on the need of the homeowner and this was a special circumstance. Mr. Bishop stated that the Township pays for supplies through an old grant and World Changers supplies the labor.

Hank Coakley, Valley Road, asked which employees are confidential. Mr. Cuttrell stated certain secretaries, administrative assistants and statutory employees.

Tassie York asked for further explanation on the resolution to approve employee agreements. Mr. Gadaleta stated they are employment agreements with the Township's Department Heads and confidential employees.

Annette Ross, stated that she is available to do whatever she can to help with Wesley Lake.

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse established the Municipal Alliances for the Prevention of Alcoholism and Drug Abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, nonprofit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey; and,

WHEREAS, the Township Committee of the Township of Neptune, County of Monmouth, State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem in our society amongst persons of all ages; and therefore has an established Municipal Alliance Committee; and,

WHEREAS, Township was approved for a Municipal Alliance grant for the January 1, 2013 through December 31, 2013 grant term; and,

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse has extended the 2013 grant term until June 30, 2014, in order to transition the grant to a fiscal year rather than calendar year cycle; and,

WHEREAS, funding has been made available to the Neptune Township Municipal Alliance in the amount of 50% of its approved 2013 grant total for the six-month extension period of January 1, 2014 to June 30, 2014, contingent upon meeting the 25% Cash Match and 75% In-Kind Match grant requirement for the extension funding; and,

WHEREAS, on October 28, 2013, the Township Committee adopted Resolution #13-462 which authorized the submission of the grant extension but the amount of the grant was expressed in the resolution as the full prior year amount plus the six month extension amount; and,

WHEREAS, the Township Committee desires to adopt this subsequent resolution to authorize the submission of the grant extension with the amount of the grant expressed as the

amount of the six month extension period only,

THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Neptune hereby authorizes the submission of the grant extension for the Neptune Township Municipal Alliance grant in the amount of:

AUTHORIZE A REDUCTION IN THE PERFORMANCE GUARANTEE FILED BY EPWORTH VILLAGE, LLC FOR SITE IMPROVEMENTS AT EPWORTH VILLAGE (COOKMAN AND CLARK AVENUES)

WHEREAS, on December 21, 2005, the Township Committee adopted a resolution which accepted performance bond S20145 in the amount of \$165,483.00 filed by Epworth Village, LLC written by First Indemnity of America Insurance Company guaranteeing site improvements at Epworth Village on Cookman and Clark Avenues (Block 49); and,

WHEREAS, at the request of the Developer, the Township Engineer has inspected the site improvements and has recommended a 70% reduction in the performance guarantees which is the maximum amount of reduction permitted under the Municipal Land Use Law; and,

WHEREAS, the Developer will be instructed to post a Change Rider reducing the amount of the performance bond from \$165,483.00 to \$49,645.00; and,

Dianna Harris, Willow Drive, questioned whether there was any word on the skateboard.

Ms. Harris also questioned whether there was an update regarding the signs for Mid-Town Commons Park.

Mr. Gadaleta stated they were still in the process of coming up with a design and they will come up with a collective decision.

Ms. Harris stated traffic on West Lake Avenue around 4pm is backed up past Drummond Avenue. She asked if they could get a traffic study for a left hand turn signal.

Mayor Houghtaling stated they could ask the State.

Bill Scorbin, 504 Wakefield Road discussed speeding in the Gables and asked for more police presence in the area. He also stated he never noticed anything about Neptune in the Police Blotter in the Asbury Park Press because when someone hit his car it was never mentioned.

Mr. Bishop asked Officer Adams if he could talk to the Deputy Chief about that.

Mayor Houghtaling stated they would be shooting radar more and more and enforcement is what they want to do and hopefully it will go town wide.

Celeste Overby, 608 Bingham Street discussed speeding on Neptune Blvd near the Post Office. It bothers her because the kids really do not look for cars.

Kennedy Buckley, 65 Broadway, stated there was speeding on practically every corner in Ocean Grove. He also discussed the Recreation Department purchasing sign boards. He stated he was not against it, it was just that he felt that because the money was there did not mean they had to spend it all. He felt it would set a bad tone for the other departments.

Mayor Houghtaling stated it was money that has been ear marked for the Recreation Department.

Mr. Bishop stated he felt the sign boards were another way to get information out because it also allows them to communicate with a wider variety of people in town.

Michael Fornino, 120 Fulham Place questioned whether anyone has spoken to George Jackson the former Police Chief and current Business Administrator of Eatontown regarding the speed tables.

Mayor Houghtaling stated he had lunch with the current Mayor and discussed it.

Mr. Fornino asked whether Mr. Gadaleta could come up with a three year plan indicating the cost of purchasing speed tables verses the use of police officers and their equipment. He felt the Township was not affectively using their money. He also stated that if he was on the Committee he would want to be on the negotiation team. He stated he would want to represent the people and it offended him that no one from the Committee was on the negotiation team.

Hank Coakley, Valley Road, thanked everyone who helped him during sandy. He also discussed the dredging of the river and his tax assessment.

Jack Breden, reviewed the history of the North End property and the building known as 4 Boardwalk. He reiterated his belief that the property was improperly designated as a Redevelopment Zone and that 4 Boardwalk was improperly subdivided as a separate lot from the beach.

Jonathan Mateus, 10 Frederick Lane, extended congratulations to the Mayor and Mr. Bishop. He asked the Committee to consider back-up power for the recreation signs in the event of a power outage.

Joan Venezia, 107 Mt. Hermon Way, asked for an update on the Broadway lighting project. Mr. Gadaleta stated that the bid will go out in December and the installation will take place in the Spring. Ms. Venezia stated that some street signs on the Broadway medians need to be relocated because they are behind the light poles making it impossible to read them. She stated that there have been reports of work occurring at 4 Boardwalk without permits and she knows that one person took photographs. Mr. Gadaleta stated that violations were issued by the Construction Department and they continue to visit the site. He asked Ms. Venezia if she could provide the photographs to which she responded yes. Mr. Gadaleta will further investigate with Mr. Doolittle.

Heinz Weck, Ocean Grove, stated that he has expressed the need for a new stop sign at the corner of Main and Central Avenues. On the way to the meeting tonight he noticed a new stop sign at the intersection. He thanked the Committee for the new sign
