WHEREAS, with the likelihood of additional development along the Route 66 corridor in the Township of Neptune, the need to widen Route 66 has reached a new level of urgency; and,

WHEREAS, the North Jersey Transportation Planning Authority has included the widening of Route 66 as a pending project; however, funding has not been officially allocated,

WHEREAS, on August 7, 2012, the Township thought there was a need to use the Municipal Planner to participate in the review, update and approval of the Municipal Affordable Housing Trust Fund Spending Plan previously adopted by the Township for purposes of the Department of Community Affairs required certification as to committed funds, thereby allowing the municipality to retain all of its funds, rather than to release said funds to the State of New Jersey, and therefore then municipal employee, Monique Burger, the Neptune Township Community Programs Coordinator, performed the necessary review and preparation of a certification of Neptune Township Rehabilitation and Affordable Housing Assistance Program Administration, which allowed for the municipality to retain all of its funds; and

WHEREAS, by letter to the Mayor of the Township of Neptune, dated May 1, 2013 from the State of New Jersey Council on Affordable Housing (COAH), it was claimed that the Municipality had failed to spend or commit to spend development fees of monies in its Affordable Housing Trust Fund within four years of the date of collection, and therefore, it was the responsibility of the Township to recertify should the Township feel that any balances provided by the letter of May 1, 2013 as unspent or uncommitted fees were inaccurate or incorrect.

WHEREAS, funds for this purpose are available in the 2013 municipal budget in the appropriation entitled Planning OE, known as Account No. 180-020 and the Chief Financial Officer has so certified in writing,
