WHEREAS, Lucas was authorized to make the necessary repairs on May 10, 2013; and,

WHEREAS, funds for this purpose are available in Ordinance No.13-14 and the Chief Financial Officer has so certified in writing,

THEREFORE, BE IT RESOLVED, that the Township Committee of the Township of Neptune hereby authorizes an emergency contract with Lucas Construction Group to make emergency repairs at a sink hole on Louisville Avenue at an amount not to exceed \$20,000.00; and,
