TOWNSHIP COMMITTEE SPECIAL MEETING - SEPTEMBER 4, 2014

Mayor Brantley called the meeting to order at 6:00 p.m. and requested the Clerk to call the roll. The following members were present: J. Randy Bishop, Eric J. Houghtaling, Mary Beth Jahn, Kevin B. McMillan and Mayor Michael Brantley.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Township Administrator; Michael J. Bascom, Chief Financial Officer; and Gene Anthony, Township Attorney.

<u>AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS ACT - TABLED</u>

Mr. Bishop offered a motion, moved and seconded by Ms. Jahn, that a resolution to "Authorize an Executive Session as Authorized by the Open Public Meetings Act" be tabled. All were in favor.

PUBLIC COMMENTS ON RESOLUTIONS

The Mayor requested comments on resolutions presented on this agenda. There were no public comments.

WHEREAS, funds for this purpose will be provided in the 2014 budget in the appropriation entitled Police S&W and the Chief Financial Officer has so certified in writing,

THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune that James Hunt be and is hereby appointed to the position of Chief of Police in the Township of Neptune effective September 5, 2014; and,

BE IT FURTHER RESOLVED, that the Mayor and Clerk are hereby authorized to execute an Employment Agreement in connection with this appointment; and,

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the Business Administrator, Chief Financial Officer, Assistant C.F.O and Human Resources.

The resolution was adopted on the following vote:

Bishop, aye; stating the Freeholder Arnone expressed his regrets for not being able to attend this evening. He sends his best wishes to Chief Hunt, particularly since is a product of Neptune City. Mr. Bishop added that James Hunt is the right person at the right time as the Department finishes the accreditation process. It has been great to watch him grow as Deputy over the last 17 months. He is very proud of him and very proud of the Police Department.

Houghtaling, aye; stating that since the retirement of Chief Adams, the Committee has looked to James Hunt for the past 17 months to lead the Department as Deputy Chief.
