TOWNSHIP COMMITTEE MEETING - DECEMBER 8, 2014

Mayor Brantley called the meeting to order at 6:00 p.m. and requested the Clerk to call the roll. The following members were present: J. Randy Bishop, Eric J. Houghtaling, Mary Beth Jahn, Kevin B. McMillan and Mayor Michael Brantley.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Township Administrator; Michael J. Bascom, Chief Financial Officer; and Gene Anthony, Township Attorney.

Mayor Brantley announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press on January 2, 2014 and The Coaster on January 3, 2014, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk.

The following items were discussed in open session:

Mr. Bishop stated that some members of the Land Use Boards approached him regarding applicants coming to the Board and getting the Board to determine the least that can be done and still obtain Board approval, so revisions are being made to the plan at the meeting. The applicants attend the meeting with plans that they know will not get passed in the hopes that the Board will say what they are willing to accept. He asked if the Township Committee could recommend that the Boards hear application on their own merit. Mr. Anthony stated that the Township Committee cannot get involved with revising applications. As policy, the Committee should not get involved in the business of the Boards because there is a separation of powers and that any interference or recommendation on how to conduct business could be illegal. Mr. Bishop stated that the Board attorneys are looking for guidance. Mr. Anthony stated that he will speak to the two board attorneys about the issue because they have the jurisdiction to advise the Boards on how to conduct the meetings.

The Committee reviewed language in the Property Maintenance Code regarding prohibited occupancies in the Certificate of Inspection process. Ms. Jahn stated that recently a renter called for a Certification of Inspection to rent a three bedroom apartment, but the ordinance states a child cannot share a bedroom with an adult. In this situation, there are two brothers that are 16 and 18 years old. Mr. Anthony stated that the BOCA Code deals with square feet per occupancy. COAH regulations contain language regarding age and gender. Mr. Anthony recommended that it is better to stay with square foot requirements. The Committee can repeal the section of the ordinance containing reference to ages and gender and the Construction Official can then refer the square footage requirements in the BOCA Code.

Mr. McMillan asked if the speed humps are being removed Township wide. Mr. Bascom replied that they are being taken out for the winter months and discussion will take place on where they will be installed next Spring. Mr. Houghtaling asked if grant money is available for speed humps. Mr. Bascom stated that Transportation Trust Fund monies may be available for permanent traffic solutions, but not portable speed humps.

Mr. Bishop stated that he intends to offer a motion to table the Transit Village Land Use Amendment scheduled for public hearing at this meeting until the December 22nd meeting. There is a concern from Sanitary Linen on Memorial Drive. A meeting will be scheduled and they will be asked to submit expansion plans prior to December 22nd. There are three other potential projects waiting on this amendment. The Committee indicated that they are willing to hear Sanitary Linen's response and if plans are in the works. Ms. Jahn stated that Bradley Beach has retail and new housing already and the Township needs to move on the Transit Village Plan to capture the market.

Mr. Bishop asked that discussion regarding the requirement for an on-site manager at apartment complexes be placed on the December 22nd workshop agenda.

<u>AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS</u> ACT

Mr. Bishop offered the following resolution, moved and seconded by Mr. McMillan, that it be adopted:

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and,

WHEREAS, this public body is of the opinion that such circumstances presently exist,

THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune,

County of Monmouth, as follows:

- 1. The Public shall be excluded from discussion of and action upon the hereinafter specified subject matters.
 - 2. The general nature of the subject matter to be discussed is as follows:

Personnel – Vacant Foreman position Contract negotiations – Cityworks/West Lake Avenue Redevelopment Contract negotiations – Additional/alternate bid work at Jumping Brook Ballfields

- 3. It is anticipated at this time that the above stated subject matters will be made public when matters are resolved.
 - 4. This Resolution shall take effect immediately.

The resolution was adopted on the following vote: Bishop, aye; Houghtaling, aye; Jahn, aye; McMillan, aye; and Brantley, aye.

The Committee entered executive session for discussion on closed session matters.

Jaime Garay was recommended for the vacant Foreman position and action was taken by resolution during the regular business meeting.

Mr. Gadaleta reported that the Environmental/Shade Tree Commission Chairperson has reviewed the plantings adjacent to the Jumping Brook Ballfields and recommends that irrigation be installed. This will be coming from the original funding source. The resolution authorizing the work had been previously tabled pending additional information.

The Committee returned to the Meeting Room for the regular portion of the meeting.

Mayor Brantley called the meeting to order and requested the Clerk to call the roll. The following members were present: J. Randy Bishop, Eric J. Houghtaling, Mary Beth Jahn, Kevin B. McMillan, and Mayor Michael Brantley.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Township Administrator; Michael J. Bascom, Chief Financial Officer; and Gene Anthony, Township Attorney.

After a moment of Silent Prayer and the Flag Salute, the Mayor asked the Clerk to indicate the fire exits.

The Clerk stated, "Fire exits are located in the rear of the room and to my right. In case of fire you will be notified by bell and or public address system, then proceed to the nearest smoke-free exit"

Mayor Brantley announced that the notice requirements of R.S. 10:4-18 for an "Annual Notice" have been satisfied by the publication of the required advertisement in the Asbury Park Press on January 2, 2014 and The Coaster on January 3, 2014, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk. In addition, the meeting agenda, resolutions and ordinances are posted online at www.neptunetownship.org.

APPROVAL OF MINUTES

Mr. McMillan offered a motion, seconded by Mr. Bishop, to approve the minutes of the meeting held on November 24th. All were in favor

REPORT OF THE CLERK

The Clerk stated that the following reports and communications are on file in his office:

An e-mail from Randy Slawsky, Lakewood Road, commending the Public Works Department for their assistance and hard work on a number of issues.

COMMENTS FROM THE DAIS

Mr. Houghtaling stated that he attended the viewings of former Chief Paduano and Joe

Shafto. Mr. Shafto was a Fire Commissioner and Chairman of the Planning Board and will be greatly missed. He attended the Neptune/Asbury Park football game, a meeting with Broadway residents regarding the flooding, the tree lighting ceremonies at Volunteer Park, Ocean Grove and Midtown and the Ocean Grove Citizens Patrol dinner.

Mr. Bishop stated that he attended the viewings of former Police Chief Anthony Paduano and Joseph Shafto. He added that Mr. Shafto was Chairperson of the Planning Board and was a great Neptune Township historian. He reflected on Mr. Shafto's contributions to the Township and concluded that he will miss Mr. Shafto's input on the Planning Board. He attended the tree lightings ceremonies at Midtown Commons, Volunteer Park in Shark River Hills and Jersey Shore Arts Center. Mr. Bishop also attended meetings with state representatives to discuss Route 66 improvements and with the township administration and impacted residents to discuss Broadway flooding issues. Finally, he attended the Mayor's Youth Cabinet clothing drive.

Mr. McMillan stated that he attended the Midtown Oldies but Goodies Dance hosted by Wes Walker. He also attended the viewings of former Chief Paduano and Fire Commissioner Joseph Shafto, the Ocean Grove Citizens Patrol holiday party, and the Neptune High Scholl Hall of Fame Luncheon at Jumping Brook honoring Verita Hill, Louis Jordan, and others. Finally, he attended the Monmouth County Foodbank Thanksgiving event in which McDonalds donated turkeys to the Foodbank for the event.

Ms. Jahn stated that she attended the Shark River Hills Christmas tree lighting, which was also attended by the Neptune High School Jazz Ensemble and two horses. She expressed her sorrow at the passing of Dave Biel, a longtime Public Works employee who just retired a few months ago. Ms. Jahn announced that she has designated Madonna House as the beneficiary of her Mayors' Ball this coming April. She reminded everyone that Madonna House is in desperate need of new or gently used boys' clothing and asked to keep them in mind for coats, snow suits or pants and boots that are gently used but have been outgrown for both boys and girls. These gifts would benefit kids in Neptune who would be warm and grateful for your donation.

Mayor Brantley stated that he attended the Neptune High School Hall of Fame inductee luncheon and tree lighting ceremonies in Shark River Hills, Ocean Grove and Midtown. He also attended a meeting with Broadway residents regarding the flooding issues. He stated the meeting was productive and the Township continues to look at ways to improve the situation. The Mayor also participated in a high level meeting to discuss the Route 66 Bottleneck Project which was hosted by Neptune on December 4th. In attendance were NJDOT representatives; Senator Jennifer Beck and Legislative staff; Executive Director of NJTPA; Committeeman Bishop and Township Staff. The NJDOT is in the Concept Development Phase and it is anticipated this Phase of the project will be complete sometime in mid-2015. A future meeting will be scheduled mid-year 2015.

PUBLIC COMMENTS ON RESOLUTIONS

Kathy Arlt, stated that she appreciates the resolution placing a lien on 103 Franklin Avenue. She added that the retaining wall on the property is near collapse and the sidewalk has been heaved due to tree roots. She asked for a copy of the lien which was provided by Mr. Cuttrell.

Dorothy Argyros, 2100 Rutherford Avenue, asked what the grant money will be used for in the resolution to change title and text in the municipal budget. Mr. Bascom stated that the resolution transfers funds from matching grants to the Drug Alliance grant which will be used for educational programs. Ms. Argyros asked what the term "fleet" means in the resolution to renew the contract for fleet maintenance. Mr. Bascom stated that refers to all Township vehicles.

Joan Venezia, 107 Mt Hermon Way, asked for details on the resolution to authorize repairs at the municipal marina. Mr. Bascom stated that the resolution is to purchase lumber for pilings as part of a bulkhead repair. The total cost of the repair project is around \$60,000. Ms. Venezia asked if the marina is making a profit. Mr. Bascom stated that the marina is operating in the black and all revenue earned by the marina offsets all costs at the marina.

Non-residential not for profit organizations - \$2.00 per cubic yard per pick-up All other non-residential businesses - \$4.00 per cubic yard per pick-up

Contractual - Weekly Pick-up

Organizations/businesses outside of Neptune Township - \$6.00 per cubic yard per pick-up

Non-contractual – Pick-up as needed (not to exceed eight per year)
Non-residential organizations/businesses - \$6.00 per cubic yard per pick-up

WHEREAS, 22% of motor vehicle fatalities in New Jersey in 2013 were alcohol related; and,

WHEREAS, said grant has eligible funding for projects limited to Coastal Lake Surge Reduction and Increased Discharge Capacity, Flood Risk Reduction Infrastructure, Stormwater Management, and Beneficial Reuse of Dredge Material; and,

WHEREAS, the Borough of Avon-By-The-Sea is preparing an application for grant funding under said program for silt removal, storm system improvements and wall repairs to Sylvan Lake; and.

WHEREAS, a portion of the storm water that is discharged into Sylvan Lake originates in the Township of Neptune; and,

WHEREAS, said grant application must be signed by a person(s) authorized by written resolution or ordinance of the local government unit to file an application for a grant, to represent the local government unit in all matter relating to the application process, and to obligate the local government unit to the terms and conditions of a grant agreement,

EXTEND CONTRACT OF CENTERRA INTEGRATED SERVICES TO PROVIDE FLEET MANAGEMENT AND MAINTENANCE

WHEREAS, the Township contracted with G4S Integrated Fleet Services, Inc. to provide fleet management and maintenance services to the Township through December 31, 2013 with the option of up to two additional single year extensions; and,

WHEREAS, the Township Committee desires to extend this contract for a period of one year through December 31, 2015 pursuant to N.J.S.A. 40A:11-15 and amend the original agreement to reflect current size of fleet; and,

WHEREAS, as a result of changes in corporate structure G4S Integrated Fleet Services, Inc. is now Centerra Integrated Services; and,

WHEREAS, funds will be provided in the 2014 municipal budget in the appropriation entitled Vehicle Maintenance O.E., and the Chief Financial Officer has so certified in writing,

THEREFORE, BE IT RESOLVED, that the Township Committee of the Township of Neptune hereby authorizes a one year extension of the current contract, with amendments to reflect the current size of the fleet, with Centerra Integrated Services to provide fleet management and maintenance to the Township of Neptune through December 31, 2015 at an annual amount of \$870,853.00 which represents an increase of 1.5% in the annual amount per the current index rate calculation; and,

PRIVILEGE OF THE FLOOR/PUBLIC COMMENTS

Assistant C.F.O.

Russ Harmstead, 111 Hawthorne Street, stated that he is still trying to get the Township reimbursed for the cost of the sidewalk repair on Old Corlies Avenue near the entrance to the Water Company facility. He stated that Section 13-4 of the Township Code requires that sidewalks be repaired at the expense of the property owner where the sidewalk abuts. He asked if this ordinance was followed as to the repair of the sidewalk. Mr. Gadaleta stated that the Township is responsible for the repair of sidewalks on a County bridge and Township owned Green Acres land abuts the sidewalk. The Mayor stated that Mr. Harmstead can meet with Mr. Gadaleta to further discuss the matter.

Dorothy Argyros, 2100 Rutherford Avenue, read a statement regarding the recent grand jury decisions not to indict police officers in cases in Ferguson, MO and New York City. She stated that this is also happening in Neptune. The Chief of Police was a defendant in two police brutality cases. She is sick of paying settlements for police brutality and is appalled at the purchase of rubber bullets for simulated training for "cop killers". We do not need to train killers but need to train police to diffuse situations. Ms. Argyros recommended that the Township go back to community policing, make cops pay for their own liability insurance and attorneys, make access to complaints easier for citizens, punish abusers and provide de-escalation training.

Linda Johnson, 704 Chaphagan, stated that the Committee made James Hunt the Police Chief, but she read the complaint against him as a Deputy Chief that cost the taxpayers over \$500,000. The complaint shows that he disrespected women and people in general. There is no legitimate reason why the Committee made Hunt the Chief of Police. The Mayor stated that the police department is working well.

Kennedy Buckley, 65 Broadway, thanked the Committee for attending the Ocean Grove Citizens Patrol dinner and for the informative meeting for the residents on the Broadway flooding.

Joan Venezia, 107 Mt. Hermon Way, asked how and when it will be determined how much will be spent in 2015 to address the Broadway flooding issue. Mr. Gadaleta stated that the Township will work on a plan for Broadway and the list of overall capital projects will be reviewed during the budget process. There may be some funds leftover in 2014 to allow some work to be done. Mr. Bascom stated that the budget is usually adopted in April. The timing of any expenditure depends on when the plan is developed. Ms. Venezia asked when the abandoned property list under the new ordinance would be available. Mr. Anthony stated six months from the adoption date of the ordinance.

Gail Oliver, Neptune City, stated that in regards to the no indictment verdicts for police misconduct in Ferguson, MO and New York, the police need sensitivity training. She added that

uprisings for justice will continue.

Ellis Jones, 30 Ridge Avenue, stated that the playground at Division Street has been spray painted with gang signs. Public Works took care of this but the house across the street at the corner of Embury and Atkins still has gang signs painted on the outside. He asked if the landlord can be pursued to clean it up. Mr. Gadaleta will follow-up with the Code Department.

Hank Coakley, Valley Road, asked if the life of a tideflex value is known because one of the values in the Shark River did not work. Mr. Gadaleta stated that he does not know the expected life but will research the condition of the one valve that did not work.

Mr. Bishop offered a motion, seconded by Mr. McMillan, to adjourn. All were in favor.
