TOWNSHIP COMMITTEE MEETING - JULY 13, 2015

Deputy Mayor McMillan called the meeting to order at 6:00 p.m. and requested the Clerk to call the roll. The following members were present: J. Randy Bishop, Dr. Michael Brantley, Eric J. Houghtaling, and Kevin B. McMillan. Absent: Mayor Mary Beth Jahn.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; Michael J. Bascom, Chief Financial Officer; and Gene Anthony, Township Attorney.

Deputy Mayor McMillan announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 8, 2015, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk.

The following items were discussed in open session:

Bernard Haney, Land Use Administrator, was present to discuss the amendment to the Land Use Ordinance which is on the regular meeting for public hearing. He stated that all changes, with the exception of the section relating to signs, was driven by the annual report of the Board of Adjustment. The changes will allow property owners to do more things without Board approval. The ordinance includes changes to corner lot setbacks to treat them as one front lot and one side yard setback. Mr. Bishop stated that the ordinance addresses issues that routinely get approved by the Board of Adjustment. In regards to the portion of the ordinance regarding signs, the Township is involved in a lawsuit regarding a revolving billboard sign. The amendment will allow LED signs which the Township currently has on the front lawn of the Municipal Complex; therefore the Plaintiff in the case would simply go to court and state that the Township is allowing LED signs already. The ordinance provides for LED signs in certain zones. The NJDOT regulates the frequency that the sign can change as well as the brightness. Dr. Brantley inquired about temporary political signs. Mr. Anthony stated that there is no change to the existing language. Dr. Brantley asked if political signs can be limited. Mr. Anthony stated no restrictions on private property are allowed. There was further discussion regarding political signs in the right-of-way. The language in the ordinance will be left as it currently exists which is no regulation on private property and not permitted in the right-ofway or on public property.

Dr. Brantley reviewed proposed changes to the Wesley Lake Commission Charter. He stated that the Commission has had problems in the past with attendance of the members. After discussion, Mr. Anthony stated that he will review his file because he had prepared the ordinance and the changes but was awaiting approval of the Commission before moving forward. Dr. Brantley will get a copy of the minutes of the Commission when approval was indicated.

Mr. McMillan stated that he met with Dawn Thompson, Recreation Director, and the date of Neptune Day will be September 26th. The Committee agreed and also set the time from 12:00 p.m. to 4:00 p.m.

A petition from residents on Rutherford Avenue requesting resident only parking will be referred to the Police Department for consideration of making the street two hour parking only during business hours which is similar to what was done on 6th Avenue.

Mr. Anthony stated that at the last meeting, a resident raised the issue about the Township tax maps and whether or not they were official maps. Mr. Haney stated that the tax map is designated for assessment purposes. Municipalities pay to have tax map prepared, but the approval of tax maps comes from the Division of Treasury. He stated that the tax maps are now digitized. The first digits of the block numbers also now correspond to the page number of the tax map. The tax map is official and can be amended only by a survey. Mr. Haney added that the land use map changes when a zoning change occurs.

<u>AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS</u> ACT

Mr. Bishop offered the following resolution, moved and seconded by Dr. Brantley, that it be adopted:

WHEREAS, this public body is of the opinion that such circumstances presently exist,

THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune, County of Monmouth, as follows:

- 1. The Public shall be excluded from discussion of and action upon the hereinafter specified subject matters.
 - 2. The general nature of the subject matter to be discussed is as follows:

Potential litigation – Tax Court decision regarding property tax status of hospitals Personnel – Township Committee member appointment to Community Action Agency Litigation – Hovsons litigation

Potential Litigation – Maintenance of private roadways

Personnel – Recommendation for hire to the position of Driver

- 3. It is anticipated at this time that the above stated subject matters will be made public when matters are resolved.
 - 4. This Resolution shall take effect immediately.

The resolution was adopted on the following vote: Bishop, aye; Brantley, aye; Houghtaling, aye; and McMillan, aye.

The Committee entered executive session for discussion on closed session matters.

Mr. Gadaleta stated that the Affordable Housing Alliance is moving to Neptune and are the Community Action Agency in the area. They have asked for a Township Committee member to sit on their Board and have requested that Mr. Bishop be appointed. Dr. Brantley asked if there could also be an alternate appointed. Mr. Gadaleta will inquire with Affordable Housing Alliance.

The Committee returned to the Meeting Room for the regular portion of the meeting.

Deputy Mayor McMillan called the meeting to order and requested the Clerk to call the roll. The following members were present: J. Randy Bishop, Dr. Michael Brantley, Eric J. Houghtaling, and Kevin B. McMillan. Absent: Mayor Mary Beth Jahn.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; Michael J. Bascom, Chief Financial Officer; and Gene Anthony, Township Attorney.

After a moment of Silent Prayer and the Flag Salute, the Deputy Mayor asked the Clerk to indicate the fire exits.

The Clerk stated, "Fire exits are located in the rear of the room and to my right. In case of fire you will be notified by bell and or public address system, then proceed to the nearest smoke-free exit"

Deputy Mayor McMillan announced that the notice requirements of R.S. 10:4-18 for an "Annual Notice" have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 8, 2015, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk. In addition, the meeting agenda, resolutions and ordinances are posted online at www.neptunetownship.org.

COMMENTS FROM THE DAIS

Dr. Brantley stated that the Ocean Grove Independence Day Parade was a great parade and very well attended.

Mr. Houghtaling stated that he met with the Seaview Island Homeowners Association Executive Board to discuss how the Township will be moving forward with the dredging project. He also met with the Shark River Hills Homeowners on the same topic. He stated that the Township will be keeping the process open and honest and keep the interests of the residents first. It was a great day in Ocean Grove for the 4th of July. Mr. Houghtaling extended sympathy on the loss of Charles Moore and Sharon Rowe's father.

Mr. Bishop stated that he also attended the Seaview Island homeowners meeting. He extended congratulations to the Class of 2015. He attended the memorial service for David Mooij, Superintendent of Schools. The World Changers have again arrived in Neptune and are working to fix up a number of homes. He attended the Shark River Hills Homeowners meeting, the 4th of July parade, and the Shark River Hills First Aid Squad fundraiser. He extended condolences to Beverly Holland on the passing of Charles Moore, to Bill Gray on the passing of his mother and to Sharon Rowe on the passing of her father.

Deputy Mayor McMillan attended to the 4th of July parade in Ocean Grove and the recent MURC meeting where abandoned properties were discussed. He extended condolences on the loss of Bill Gray's mother, Charles Moore and Sharon Rowe's father. He also announced that Neptune Day will be held on Saturday, September 26th from Noon to 4:00 p.m.

PUBLIC COMMENTS ON RESOLUTIONS

Kathy Arlt, 106 Abbott Avenue, asked about two liens placed on 98 Main Avenue and 723 Doris Terrace. As part of the abandoned properties ordinance, the Construction Official is supposed to consult with the Tax Collector about pending tax liens and 723 Doris Terrace is on the list. Mr. Bascom confirmed that he is consulted and Mr. Doolittle makes notification to the lien holders. Ms. Arlt asked if the lien on 98 Main Avenue was for vegetation. Mr. Bishop responded that the lien was for vegetation is response to a neighbor's complaint. Ms. Arlt stated that 98 Main has been vacant for over a year so that is a candidate for the abandoned properties list and she is working with MURC to identify additional abandoned properties in the Township.

Michael Fornino, 120 Fulham Place, asked how the energy aggregation services purchase works. Mr. Bascom stated that it is a state program where an approved vendor conducts an auction. The Township then views the results and decides whether or not to accept the price offered. This time the numbers were favorable so the Township is locking in the price. Mr. Fornino asked what a Public Safety Officer does. Mr. Bascom stated that the title refers to the paid daytime ambulance crew. Finally, Mr. Fornino asked for the location on Route 35 where the liquor license is being transferred. Mr. Gadaleta stated that it is the site of the former Jack's Rib & Ale.

Dorothy Argyros, 2100 Rutherford Avenue, stated that she hopes the purchase of energy aggregation services is not a scam. Mr. Bascom stated that the Township has been doing this for years and the price this time will still be cheaper than JCP&L, but slightly higher than the last contract. Ms. Argyros asked if the liens all involved tall grass. Mr. Cuttrell stated that the large majority of the liens were lawn cutting and brush clearing.

Hank Coakley, Valley Road, asked for the address for Heritage at Neptune. Mr. Gadaleta stated that is single family homes being constructed on Green Grove Road.

Ann Horan, 69 Clark Avenue, asked where the Community Pride Block Party is being held. Mr. Bishop stated that it is a NAACP annual event to bring the Neptune and Asbury Park communities together.

Dorothy Argyros, 2100 Rutherford Avenue, commended Mr. Bishop for his concern for the elderly. She asked how much time are people given to shovel their sidewalks, how will this will affect her because she does not have sidewalks, and also how will the residents within 1000 feet of a school be notified. She then reviewed the Township's response to the 2010 blizzard and stated that favoritism was given to commercial businesses. She added that the Township should pay fines because of the way they handled the 2010 storm and the Township cannot police this ordinance without selectivity and discrimination. Mr. Gadaleta stated that the timeframes to shovel are spelled out in the ordinance. If you have no sidewalks, then the ordinance does not apply.

Jack Bredin, Mt. Hermon Way, stated that the Committee should table this ordinance to investigate further. The boardwalk, Lake Avenue and Ocean Pathway are all sidewalks. He shovels his sidewalk and his neighbors. The Ocean Grove Camp Meeting Association owns all of the sidewalks in Ocean Grove. He suggested that the Ocean Grove Homeowners Association get involved in helping homeowners shovel their sidewalks.

Hank Coakley, Valley Road, asked how long people have to shovel the sidewalks. Mr. Gadaleta responded within 12 hours of daylight.

There being no further comments, the Deputy Mayor closed the public hearing.

The resolution was adopted on the following vote: Bishop, aye, with regrets to the resignation of Jerry Robinson; Brantley, aye; Houghtaling, aye; and McMillan, aye, except abstain on the resolution to authorize a Developer's Agreement with Heritage at Neptune, LLC.

PRIVILEGE OF THE FLOOR/PUBLIC COMMENTS

Deputy Mayor McMillan stated that he recently attended a MURC meeting and questions came up about abandoned properties. He asked Mr. Gadaleta to give a status on abandoned properties.

Mr. Gadaleta stated he received a request for information on 607 Sayre Street. This property had fire damage. The owner has a building permit ready to be picked up to make repairs on the property as well as an addition so this property will be renovated. Also, there was an inquiry on 1710 West Lake Avenue. The Township has been in contact with the owner for possible acquisition as part of the West Lake Avenue Redevelopment. As far as the abandoned property list, letters went to 67 property owners and lien holders of record. He also displayed the 18 x 24 sign that is required to be placed on all properties on the list. The Township will post the sign on the property if the property owner does not. The owner of 1313 Washington Avenue has already picked up a sign and posted it on the property.

Michael Fornino, 120 Fulham Place, distributed recent Asbury Park Press articles regarding drunk driving accidents. He stated that he wants to see drunk driving laws strengthened. He stated that you can't just take away the driver's license, but you must impound the license plates so people with suspended licenses for drunk driving cannot drive the car. In addition, legislation for people who drive without their license can be remedied.

Kathy Arlt, 106 Abbott Avenue, stated that her letter to the editor appeared in last week's Coaster regarding a registration fee for abandoned properties. If you have 200 vacant properties and charge \$500 each, the Township has the potential to raise \$100,000. There are three properties in Ocean Grove that are being lost this year. The Parkview has already had a demolition hearing. In 2010, the HPC asked for a demolition by neglect designation with was not granted. The Warrington at 22 Lake Avenue is occupied by squatters. Mr. Bishop stated that the windows and entrances are boarded up. Ms. Arlt stated squatters are also located 31 Broadway. One of the main points of the ordinance is securing the building from unauthorized entry. You can easily gain entry to 80 Main Avenue. Also, Mr. Doolittle did not file the notices with the lienholders of the properties. Mr. Anthony sated this was not true perhaps Ms. Arlt did not check the correct registration book at the County. Ms. Arlt stated that the lienholders are not showing up on-line.

Jack Bredin, Mt. Hermon Way, stated that Planning Board members cannot have personal preferences or prejudices against a certain type of building. The Planning Board recommended that the North End be declared an area in need of redevelopment on February 28, 2007 which generally the governing body agrees with, which the Township Committee did on June 11, 2007. But in January, 2007, there is a Memorandum of Understanding between WAVE and the OGCMA which established a Plan for the North End for which the two entities would serve as co-redevelopers. On June 9, 2008, the Township Committee designated WAVE and the OGCMA as co-redevelopers, just as the two entities predicted in 2007. Mr. Bredin asked if a Redevelopers Agreement is in place.

Mr. Anthony stated that this is still being negotiated, but WAVE will be the sole redeveloper. Mr. Bredin asked if they can still install underground parking. Mr. Anthony stated that can do whatever the Redevelopment Plan calls for.

Barbara Burns, Ocean Avenue, stated that the sidewalks in Ocean Grove are owned by the Ocean Grove Camp Meeting Association but are leased to the homeowners who are responsible for maintenance.

Joan Venezia, Mt. Hermon Way, asked if financials have been received on W.A.V.E. Mr. Anthony stated not as of yet; however, the Redevelopment Agreement will not be signed until this information is received. Mr. Anthony confirmed that negotiations are on-going. Ms. Venezia asked why the number of World Changers participants was smaller this year. Mr. Bishop stated that many of the youth went to a program in Florida for a week in early July, so there were less participants available to come to Neptune. It appears that next year, the Regional Managers that served several years ago will be back and they have more of a vested interest in the Shore so the number of World Changer participants will likely rise next year.

Janice Thompson, 271 Fisher Avenue, asked if some of the properties on the abandoned property list are subject to squatters. Mr. Gadaleta responded yes. Ms. Thompson suggested that the Township could get grants to acquire the properties and flip them to non-profits who could then convert them to affordable housing. Mr. Gadaleta stated that Affordable Housing Alliance is moving to Neptune Township and they have a program to acquire properties from banks, rehabilitate, and put the properties on the market.

Hank Coakley, Valley Road, asked if there is a problem with the marina building construction. Mr. Gadaleta stated that when the concrete slab was removed, piles were found from an old structure so the engineer needs to address areas that are in conflict where new piles will be installed. The installation of new piles will start in areas with no conflicts. Mr. Coakley asked if there will still be underground parking at the North End project. Mr. Bishop stated that it must be built to RSIS standards so the number of parking spots is tied to the number of units.

Dorothy Argyros, 2100 Rutherford Avenue, asked for the status of the Police Department accreditation process. Mr. Bascom stated that a consultant is here reviewing the document and the department's processes. The Department will make a formal request for a final review within weeks.

Mr. Bishop offered a motion, seconded by Dr. Brantley, to adjourn. All were in favor.
