TOWNSHIP COMMITTEE MEETING - NOVEMBER 9, 2015

Deputy Mayor McMillan called the meeting to order at 6:00 p.m. and requested the Clerk to call the roll. The following members were present: J. Randy Bishop, Dr. Michael Brantley, Eric J. Houghtaling, and Kevin B. McMillan. Absent: Mayor Mary Beth Jahn.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; Edward J. Hudson, Assistant Chief Financial Officer; and Gene Anthony, Township Attorney.

Deputy Mayor McMillan announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 8, 2015, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk.

The following items were discussed in open session:

Mr. Gadaleta discussed the State-Local Cooperative Housing Inspection Program. If the Township participated, \$19,000 would be received from the state which would allow for the hiring of a part-time person in Code Enforcement. The employee is not permitted to perform the Township inspection at the same time as the state inspection, but the two inspections can be done by two different inspectors at the same time. The Committee indicated that they want to move forward with the Program. Mr. Anthony will prepare the necessary ordinance for the next regular meeting.

Mr. Bishop stated that he was contacted by New Jersey Natural Gas seeking support for the project to build a redundant east-west natural gas line into the western part of New Jersey. Only one line currently services this entire area with no back-up. The Committee asked that a resolution of support be placed on the next regular meeting.

Mr. Anthony discussed the ordinance regulating sales of precious metals and other secondhand merchandise that was tabled in September. The issue is that the ordinance regulates secondhand goods including furniture and jewelry. He contacted other municipalities and the language could be cumbersome for Ocean Grove businesses that sell this type of merchandise. Mr. Anthony recommended removing this section of the proposed ordinance. Mr. Bascom stated that the ordinance was recommended by the Prosecutor's Office and it is working in other counties and towns in New Jersey. Mr. Anthony believes that the ordinance would present no problems in municipalities that do not have a large number of businesses that sell secondhand merchandise. The Committee indicated to proceed with the removal of the language that would be cumbersome for this type of business.

Mr. Gadaleta stated that the Seaview at Shark Island Homeowners Association wants to install a new streetlight in the complex. The fixture they want is not one of the approved fixtures but it is in keeping with the gooseneck design for lighting on structures in the waterfront streetscape. Mr. Anthony stated that an agreement is necessary because these lights would remain the property of the Association. Mr. Gadaleta added that a portion of the lights will be on the Township's right-of-way. Mr. Houghtaling indicated that this is not a feasible expense for the Township's right-of-way, but if they want to pay for the lights in our right-of-way, we can support the idea. Mr. Bishop stated that he does not like the idea of buying a different fixture than the remainder of the Township. The Committee concluded that a more coastal design should be considered by the Homeowners, then the Township will consider assisting with the cost of the lights in the Township right-of-way.

<u>AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS ACT</u>

Mr. Bishop offered the following resolution, moved and seconded by Dr. Brantley, that it be adopted:

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and,

WHEREAS, this public body is of the opinion that such circumstances presently exist,

THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune, County of Monmouth, as follows:

1. The Public shall be excluded from discussion of and action upon the hereinafter specified subject matters.

2. The general nature of the subject matter to be discussed is as follows:

Personnel - Succession Planning

- 3. It is anticipated at this time that the above stated subject matters will be made public when matters are resolved.
 - 4. This Resolution shall take effect immediately.

The resolution was adopted on the following vote: Bishop, aye; Brantley, aye; Houghtaling, aye; and McMillan, aye.

The Committee entered executive session for discussion on closed session matters.

The Committee discussed the formation of a Police Athletic League. Mr. Bascom is coordinating with various Township departments and agencies.

The Committee indicated that the interviews for EMS Manager can be scheduled.

Mr. Anthony will submit the Township's Responsible Contractor Ordinance to the Department of Community Affairs for approval.

The Committee asked that further discussion on the ordinance to implement a Revocable License Agreement procedure be scheduled for the next workshop meeting.

The Committee returned to the Meeting Room for the regular portion of the meeting.

Deputy Mayor McMillan called the meeting to order and requested the Clerk to call the roll. The following members were present: J. Randy Bishop, Dr. Michael Brantley, Eric J. Houghtaling, and Kevin B. McMillan. Absent: Mayor Mary Beth Jahn.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; Edward J. Hudson, Assistant Chief Financial Officer; and Gene Anthony, Township Attorney.

After a moment of Silent Prayer and the Flag Salute, the Deputy Mayor asked the Clerk to indicate the fire exits.

The Clerk stated, "Fire exits are located in the rear of the room and to my right. In case of fire you will be notified by bell and or public address system, then proceed to the nearest smoke-free exit"

Deputy Mayor McMillan announced that the notice requirements of R.S. 10:4-18 for an "Annual Notice" have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 8, 2015, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk. In addition, the meeting agenda, resolutions and ordinances are posted online at www.neptunetownship.org.

APPROVAL OF MINUTES

Mr. Bishop offered a motion, seconded by Mr. McMillan, to approve the minutes of the meetings held on October 8th and October 26th. All were in favor.

REPORT OF THE CLERK

The Clerk stated that the following reports and communications are on file in his office:

COMMENTS FROM THE DAIS

Dr. Brantley congratulated Mr. Hougtaling on winning the election and becoming the new Assemblyman for the 11th District. He stated he worked very hard for this victory and they got their message out and apparently people liked what they heard. He was happy that Neptune came out very strong for Mr. Houghtaling. He stated Neptune supported Carol Rizzo as well and he was proud of what she's done. He stated on November 2nd the Police Accreditation Team came to Neptune and policies that they reviewed were policies that were put into place for quite some time and they were working on it for a long time. They were positive with what they saw and every three years they will look at what's going on. This is a voluntary thing that they are doing because they recognized that it needs to be done and he was proud of the team that put it together.

Mr. Houghtaling congratulated Dr. Brantley for being reelected to the Township Committee and installing our newest Committee member Nick Williams. He stated he went to the Lions Club, Night For Sight on Halloween and it was a great night. It was the best function they had to date and they had almost 150 people there. All the money that was donated and received by that function will go to the Lions Club and what it stands for. The future of the Lions Club is very bright in Neptune and they are always looking for new members to sign up and help out. Last year he went to the Night for Sight and he ended up joining because he really believed in what they do. He stated if no one has been to our new Public Works for drop offs they have reinforced all of their drop offs with timber and it looks brand new over there and they've done a wonderful job and they are open seven days a week. He went on to state that he will have to step down from the Township Committee and it tears him up a little bit because being on the Committee was something that he honored. He stated he grew up in this Township and was once the Mayor but will be stepping down on January 11, 2016 and someone will be taking his spot and he hoped they would have the same values that he has. He stated it was great serving with this Committee.

Mr. Bishop stated there was a dredge in the Shark River and it was dropped a week ago last Friday and the hope was to get 16,000 cubic yards removed before the end of this year. He also stated it appears to be a misconception among some people about the accreditation process and it is that we come up with the ideas and then we get graded on them but that is not true. He stated there's a process in place and they were living by them and that is part of what the accreditation process is. It's not only the fact that they have these policies but that we are utilizing these policies today and they look at how we utilize them and what the policies are. He congratulated Dr. Brantley and the Police Department for working to get this done and to make it happen and to earn us this type of respect. We won't hear for sure until next year but we can be very proud of everything that our police, administration and governing body has done to make certain that we have a process that is and will be followed and they are doing what they should do to protect our residents. He went on to congratulate Dr. Brantley and Mr. Williams on winning the election. He also congratulated Diana Harris and Kevin Sheehan for running. He also challenged her to never stop trying and to continue working for her beliefs and dreams. He also congratulated Carrol Rizzo for running an uphill battle. He congratulated Mr. Houghtaling for winning the Assembly race.

Mr. McMillan congratulated those who won their elections. He felt we would be represented well in Trenton. He also extended his congratulations to Carol Rizzo and Diana Harris. He also stated he went to the Lions Club party and presented a proclamation to St. Augustine's Church for their 125th anniversary for of serving the community. He also stated he performed a couple of weddings.

Mr. Houghtaling stated November was Pancreatic Cancer Awareness Month and the Lustgarten newsletter progress and promises there's a picture of Neptune Township in this very room presenting a check to the Lustgarten Foundation for \$35,000 and this year they raised \$33,000.

Dr. Brantley stated the Biergarten was having a happy hour tomorrow. They will take a portion of the sales and donate to the Friends of Wesley Lake. He urged the residents to pick up a flier and attend.

PUBLIC COMMENTS ON RESOLUTIONS

Diana Harris 17 Willow Drive, addressed the Committee and spoke regarding Resolution #15-441 which reclassified an employee to the position of Human Resources Director. She stated she knew she was currently classified as a specialist and questioned how it would change. She questioned whether she received an increase or an increase in responsibilities.

- Mr. Gadaleta stated she was originally brought into the position and essentially the governing body wanted to see a time period as to how the position worked out and because the position requires the employee in that position to manage employees within certain bargaining units and so forth there was a position taken that at some point it would be reclassified as a Department Head position within the Township and that is essentially what is taking place by this resolution.
- Ms. Harris questioned whether this position was open to other employees in other departments or was she hired for that position when she was originally hired.
- Mr. Gadaleta stated there wasn't that position at that time. Her title was administrative assistant, then her current title was established specialist and then subsequently the director position and the management position was established by the governing body.
- Mr. Bishop stated he thought the question Ms. Harris was asking was when the specialist position was established was that position posted.
 - Mr. Gadaleta confirmed that it was.
- Mr. Bishop stated this position was a reclassification of an existing so you wouldn't repost.
 - Ms. Harris questioned whether additional classes had to be taken for that.
 - Mr. Gadaleta stated she continues to take classes.
- Ms. Harris questioned whether there were guidelines if someone wanted to advance within the Township.
- Mr. Gadaleta stated there were job descriptions for respective positions and there are regular Township positions, there are statutory positions such as the Clerk and Finance Officer who have educational requirements and licenses that go along with that.
 - Ms. Harris questioned who paid for the classes.
- Mr. Gadaleta stated the Township does send employees to classes to allow them to move forward in positions within the Township.
- Ms. Harris questioned whether the Township selected them go to those classes or could they come to the Township own their own and request it.
- Mr. Gadaleta stated they could actually come to the department head and request and the department head may look to an employee and say we would like to consider you in the future for promotion and in order for you to be considered for that these are the classes you will have to take and we offer them that ability.
 - Mr. Bishop stated for additional responsibility they can take a class.
- Mr. McMillan stated this goes along with the succession planning process and the affordable care act.
 - Ms. Harris questioned whether she would have a staff.
 - Mr. Gadaleta stated she would not have a staff.
 - Mr. Houghtaling stated they were not creating a department just a position.

Michael Golub stated she would be a department head but she would not have a department.

- Mr. McMillan stated that was correct.
- Mr. Golub questioned whose decision was it to bring this before the Committee and why do they need a human resources director and why they couldn't just follow the model of that gentleman and just give somebody else additional responsibilities with a little stipend and use that advantage because her job went from thirty some odd thousand dollars a year to seventy thousand.
 - Mr. McMillan stated no not with this and that he could see the incremental differences.
- Mr. Gadaleta stated she originally came in as an administrative assistant then was moved up to human resources specialist because there is a need for someone to be directly involved with human resources and it's more than just the employee involvement. This position involves the Affordable Care Act and all of our insurance with the Township and not just working directly with employees. It is anything that has to do with insurance, liabilities, pensions, all of that falls under this title.
 - Mr. Golub questioned who takes care of that now.
 - Mr. Gadaleta stated she does now.
 - Mr. Golub questioned who did it before she did it.
- Mr. Gadaleta stated it was actually amongst a number of employees and this has now been consolidated. Essentially there were three positions that were doing a portion of this work and now more responsibility has come on board and it has now been consolidated into two positions.
 - Mr. Golub questioned whether they were doing their job poorly.
- Mr. Gadaleta stated it was actually a retirement and there was a need to look at how they were going to restructure this department and the responsibilities.
- Mr. Golub asked whether she was not willing to go on as a human resource specialist unless she became a department head and jacked up her salary. He stated he was curious about this and questioned how did it happen.
- Mr. Gadaleta stated the position was established and putting certain job responsibilities under this umbrella of specialists. He pointed out earlier to Ms. Harris that this individual has a responsibility to oversee employees below management level.
- Mr. Bishop stated one of the reasons they did this was because it was being done but was inconsistent depending on who was doing what and we were not meeting all the marks that we had to in terms of accreditation for things that they had to do. There were things that they did that could have put them at risk. It was the decision of the governing body to consolidate this in one place. We decided to do the specialist to determine whether we would make it an HR Director or not.
- Mr. Golub stated the specialist position was posted but when this position was considered was the position posted to the general population of employees or was she the only person that was anointed to the position.
- Mr. Bishop stated it was a reclassification they wouldn't do it because you would be creating a new position.
 - Mr. Golub stated it was a new position.
- Mr. Bishop stated it was a reclassification of job title and individual and if they had reposted they would now have a specialist and they would have to hire a director if it was someone different. Therefore it would be creating a second position.
 - Mr. Golub asked whether the Township had a human resource director prior.
 - Mr. Bishop confirmed that they did not.
 - Mr. Golub asked if they were reclassifying at the same time they were creating a position.
 - Mr. Bishop stated they were renaming a position.

Mr. Golub did not agree that they were renaming a position. He still felt they were creating a position. He felt it could have been posted and there could have been another qualified person that could have applied.

Gail Oliver of Neptune City commented on Resolution #15-443 which pertained to the renewal of Alpha's Liquor License. She stated it mentioned that a Tax Clearance Certificate was not provided and guestioned what it was.

- Mr. Cuttrell stated that was a certification that each liquor license owner has to provide every year to renew their license that they paid their sales tax.
 - Ms. Oliver stated so one was not provided to the Township.
- Mr. Cuttrell stated that was correct they did not have one from the Division of Taxation so they could not renew the license then they get temporary stays to keep the business going. Now we can renew it because they got the certificate from the Division of Taxation.
- Ms. Oliver questioned whether there has been any complaints against the establishments.
 - Mr. Cuttrell stated not to this level.
- Ms. Oliver stated a couple of years ago she made complaints regarding the hours in which they were still open and selling alcohol.

Mike Golub, Cliffwood Drive asked what is changing in the Charter. Dr. Brantley responded that the changes include adding Commission members, adding that the watershed is included in the Commission's jurisdiction, and making the term three years for Commission members.

There being no further comments, the Deputy Mayor closed the public hearing.

Mr. Bishop offered the following ordinance, moved and seconded by Dr. Brantley, that it be adopted:

BOND ORDINANCE PROVIDING FOR SHARK RIVER DREDGING, BY AND IN THE MARINA UTILITY OF THE TOWNSHIP OF NEPTUNE, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING \$160,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$152,000 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF

The Deputy Mayor requested public comments on the above ordinance and they were as follows:

Dorothy Argyros, 2100 Rutherford Avenue, stated that this is another example of spending taxpayer dollars to benefit relatively few yacht owners. Mr. McMillan explained that the funds were coming from the marina utility and not the current fund so local taxes are not funding this ordinance. She asked if the dredge material would be stored on Seaview Island. Mr. Bascom stated that two locations were approved as drying sites; the Belmar marina area and property at Seaview Island. The plan now is to use the Belmar marina area as the primary site with Seaview Island only being used as back-up. Mr. Bascom also explained that the material will be trucked to the County landfill and not stockpiled at either drying site.

Frank Vitale, 111 Olive Street, stated that he was in support of this project.

Hank Coakley, Valley Road, stated that the river is an asset that can be used 24 hours a day, 365 days a year and he commends the Committee for taking this action.

There being no further comments, the Deputy Mayor closed the public hearing.

The ordinance was adopted on the following vote: Bishop, aye; Brantley, aye; Houghtaling, aye; and McMillan, aye.

THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune that Stephanie Oppegaard be and is hereby reclassified to the position of Human Resources Director at an annual salary of \$70,000.00 effective November 15, 2015; and,

PRIVILEGE OF THE FLOOR/PUBLIC COMMENTS

Joan Venezia, Mt. Hermon Way stated she received her OPRA information in the mail today and she had questions about the North End. She also stated she hasn't been able to get information about 68 Clark despite her numerous phone calls. She also stated she would like to see an email blast go out regarding the 20% flood insurance discount.

- Mr. Gadaleta stated it's on our website and on Facebook.
- Ms. Venezia stated it was never sent out as an email blast.
- Mr. Gadaleta stated they would check that out.

Ms. Venezia also stated that people should be aware of surcharges. She also stated she sent a request to both Mr. Gadaleta and Mr. Cuttrell regarding 102 Mt. Herman Way.

Mr. Gadaleta stated they received it and he sent the Code Officials out today and they brought back a piece of asbestos siding and he has it sitting on his desk. He stated he will be meeting with Public Works tomorrow. They may have to follow up back with the property owner because he may have to dispose of that material because we cannot take it. It has to go to a licensed facility and they will follow up on it tomorrow.

Mr. Anthony stated that as far as the North End he hasn't gotten any financials but he did get a letter after her OPRA request after he submitted everything from WAVE indicating that they are amending their developer's agreement with the Camp Meeting Association. They finalized that and they were also taking on a new partner.

Kennedy Buckley, 65 Broadway, discussed street sweeping in Ocean Grove and questioned why tickets were not given out when people do not move their vehicles. He questioned whether there was an ordinance pertaining to it and if not could they create one so the flooding on Broadway could be contained.

Mr. stated he would look into it and get back to him.

Mike Fornino, 120 Fulham Place, congratulated the electoral winners. He also stated he went to an Asbury Park Council meeting and they had an LED time clock and there was very good control of the meeting and it ran smoothly. He suggested the Committee look into getting one as well and offered to pay for it. He went on to state that it annoyed him that Department hands are not required to be at Board of Adjustment meetings or Planning Board Meetings because when questions came up and there is no one there to defend or affirm the decisions. He stated he did not want to see in their contracts that they will be paid overtime because he did not feel that they should be paid overtime to do what is part of their job. He felt it was a disservice to the applicant and to the Township by not having them attend the meetings. He stated since Mr. Hougtaling would be the Assemblyman for this area, he figured he could fix the nightmare at the circle. He questioned why the Township was running eight snow plows on Hwy 33 when for over thirty years they did it with three plows. He felt heavy money was going into this. He also discussed the taxes in New Jersey.

Mr. McMillan stated on Route 33 they were State plows.

Dr. Brantley stated that both he and Mr. Gadaleta met with Congressman Smith at the WaWa and they talked about Hwy 66 and he injected a lengthy conversation about the Asbury Circle and another job for our Assemblyman is that Congressman Smith said that he will look into that and he would hope do the same thing in that area. He asked Mr. Houghtaling to follow up on that and see if they can get the circle restructured.

Mr. McMillan stated when they have workshops, new developments or talk about the budget they have the Department Heads present. He stated they also come to the homeowners meetings, but he understood their concerns.

Diana Harris, 17 Willow Drive, stated she called Mr. Cuttrell regarding the RFP for the Wesley Lake Ave Redevelopment Project and she asked for a copy of it for MURC and he told her it was \$300. She stated she was a little concerned with the price. She stated she did research with the Local Public Contract Laws and they said that fees maybe charged but should not exceed \$50 or the cost to reproduce the documents. She questioned why was the price set so high.

Mr. Gadaleta stated that was the price set by the governing body so that they would have groups and redevelopers who had a serious interest in coming to Neptune Township and working on that project.

Ms. Harris then asked whether or not they had to abide by the law she mentioned.

Mr. Gadaleta stated it was an RFP not a bid spec for a project and so forth it is separate and it is a separate request.

Ms. Harris asked if MURC could get a copy of that.

Mr. Bishop requested a copy of the RFP.

Ms. Harris provided pictures of 505 Fisher Place and questioned whether it was on the abandoned property list because the conditions were horrible.

Mr. Gadaleta stated he would speak with Code Enforcement again.

Ms. Harris also commented on 1943 West Lake, the house with the hole in the roof and a trailer in the back. She stated she was aware the property owner wanted to maintain ownership of the property but they still needed to clean it up.

Mr. Gadaleta stated she was now living in Maryland with her son and he was working through the courts down there to get power of attorney for the property and he knows that he is looking to market the property.

Both Mr. Bishop and Ms. Harris stated they were still in violation.

Ms. Harris stated they moved the cars which is great but there is still a trailer back there and garbage is everywhere.

Mr. Gadaleta stated he would follow up on that.

Ms. Harris then asked as far as the accreditation process was concerned would they have to go to the Police Department to see the binder.

Mr. Bascom stated it is available in the Police Department and if she wanted to see what was in the binder it was on the NJ Association of Chiefs of Police Website. He stated it was basically their policies but the assessor report will not be done until sometime during the end of the year.

Mr. Golub, Cliffwood Drive, stated he did not think that Sean Kean would not want to be a legislator designing highways. He thanked Mr. Bishop for asking for a copy of the RFP. It was said they wanted to weed out the people that were not serious. He stated he thought it was amazing that MURC could be put into that company of people that would be suspect of not being serious. There isn't another stakeholder or organization that has a larger stake in redevelopment than MURC and its members and the notation that they would have to come up with \$300 is disgusting and grotesque. It is not a profit center. He felt \$50 was more reasonable. He also stated the dredging was important and he did not think it would last 15 years and if they did enough due diligence the dredging is a maintenance process and we will get better funding and success if we curb everything going on in the western part of Neptune. He also mentioned the change in zoning near the border of Neptune.

Mr. Bishop stated he did not believe it was the intention of this governing body that people who wanted information in terms of understanding what the RFP was to charge them \$300. What there intentions were, if there was a developer who comes to pick it up and registers when they pick one up they have to pay \$300 because we have been burnt far too often by developers who came in to pick something up without absolutely no wherewithal and it's a waste of taxpayer money and our time just to hand these out like candy.

Helen Stocum, 22 Lynn Drive spoke regarding the proposed zoning change in Tinton Falls.

Dorothy Argyros, 2100 Rutherford Drive, stated all of these years they have been supporting Code Enforcement and suddenly they have two ordinances 14-36 and 15-43 which purports to do the work of Code Enforcement on vacant and abandoned homes but with outlandish penalties and requirements. She stated she lives in her home and is not on the list but she was worried about this and she objected to the huge fines. She said Committeeman McMillan caught her after a meeting and said don't worry about it. It is aimed at banks. She stated they were supposed to go against banks and not the poor owner who lost the property and can't afford the fines.

Mr. McMillan stated the overall intent is to get the land owner to fix their properties.

Mr. Anthony stated there are cases when a property is abandoned and has no bank at all and those are some of the cases they had today. There are cases in which they have a foreclosure and they include the lienholder as a defendant.

Mr. Bishop questioned whether our ordinance follows what the enabling legislation says that it can do.

Mr. Anthony confirmed that it did.

Frank Vitale, 111 Olive Street, stated this was an issue where both he and Dorothy agree on 90% of what she just presented to the Committee. He felt she made some really intelligent and important points for the first three quarters of what she said. He stated the only part that he did not agree with that he did not feel that it was their intention to hurt anyone. He felt it was their intention to improve the property and he's on the same side of improving the property; however, there are code enforcement violations that can be addressed. He stated none of his property was on a list but he does have a friend that is going through this. He stated he sincerely believed that this ordinance was illegal. He stated he asked Mr. Doolittle to provide him a list with property owners who have supplied provided proof that the Township is listed on their insurance and the answer was zero. He stated Mr. Anthony could not go to court and say they were in compliance because they are not because they cannot supply insurance because

they have no insurable interest. He stated the Township drafted the ordinance and he's prosecuting the cases. He felt it was a conflict of interest which he has no right to be there and if they wanted a prosecutor that's fine they are trying this case and they are going to take it as far as it needs to be taken. He went on to state that today Mr. Anthony had to dismiss himself from our trial because there was a conflict of interest but yet he can hammer people in the hallway and convince them that this \$2,000 fine will suspend \$1,500 of it and give you a break and you just pay \$500 now that's a prosecutor negotiating a plea bargain. He stated they needed to get him out of this.

Mr. McMillan questioned whether these violations had a certain amount of time.

Mr. Anthony confirmed that they did and there was a whole procedure and under the ordinance first of all they are put on the abandoned property list or given notification by certified mail that it's published in the newspaper, it's registered with the Clerk of Monmouth County they have the right to appeal after that. Most of these people do not respond until they have a summons situation. Then notice goes out for the summons issued and then there's a summons. Mr. Anthony stated Mr. Vitale was interesting because he wouldn't even know that there was a conflict of interest if he didn't bring it up in the first place. He stated he was the one who said it was a conflict whenever someone comes before the Committee and makes an issue about an ordinance he prepared and Mr. Vitales friend did not feel it was a conflict and wanted him to go ahead. He stated he recused himself from two cases because both defendants came before the Township Committee and engaged in him regarding an ordinance which was partly created by himself and partly by Bill Doolittle. He stated he did the right thing in recusing himself. In terms of other things he had to say, Ted Wardell who is our insurance agent has already invested this and has indicated we do have an insurable interest in this case. If they wanted to remove one portion of the ordinance for individuals to make it easier it was up to them. This ordinance relies on a number of enabling statues. It's also based on another town.

Sandra Sollee, Birdsall Road Farmingdale, questioned at what point did the Committee decide to add interior to this ordinance. She asked if they were not trying to rent it and get a C/O why did they have to let someone into their house. She also commented on Ordinance 14-36 which mentioned putting people in jail for 90 days. She asked was that meant for a bank or a little old land who owns a house and she can't come up with the money. She also stated someone was fined \$500 today because they did not have insurance. She stated she had insurance on her home and if it's never going to be thrown down why would she need a rider. She stated she was never told she had to do anything with her home and now she's being told her home has to be rehabbed. She felt she should have been given more notice.

Mr. Anthony stated jail in the amount of 90 days was your standard penalty clause which sets the maximum amount of \$2000 and it does provide for remedies of community service but it's not likely that something like this will lead to that but these are the standard provisions because there's a statute that allows most of the ordinances to have that whether it is utilized or not and that depends on the judge and not them. He stated as far as \$500 for demolition the judge actually made that decision and no one else made that decision. He went on to state that he had many cases where people are in the process of demolishing their house and it may take five more years before they do it. So just because someone tells me they are going to demolish their house doesn't mean that it is going to happen. Then you're saying the notice is not enough but the notice is exactly what provided by the enabling statute any more notice would be more than what the statute even provides for.

Ms. Sollee stated they were not given enough time to abate the problem.

Mr. Anthony stated she was given notice that she was on the abandoned property list in March and she was given notice later that she had to follow certain criteria of the ordinance and then the summons was issued in August. She had quite a few months to do something and hasn't done anything under the ordinance.

Ms. Sollee stated she was waiting on her hearing and appeal.

Hank Coakley, Valley Road, stated he was at the Recycling Center on Saturday and all he saw were the non-migratory geese. He asked if the Township could spend the money to get rid of them from there and other areas of the town. He stated the breeding season was in the Spring and suggested they oil the eggs.

Ann Horan, 69 Clark Avenue, stated she sent a letter to Mr. Gadaleta regarding 68 Clark. She also stated the duck situation has gotten out of hand at Fletcher Lake. They are beautiful but there are too many of them.

- Dr. Brantley stated Mr. Coakley mentioned something that Asbury has done in the past and they oiled the eggs. He questioned whether the Township has been doing that.
- Mr. Bishop stated Fletcher Lake oils the eggs in the Spring and there are certain times you can do it and there are certain times that you can't. He stated they have used the dogs before and it is semi affective and then they come back.
 - Dr. Brantley stated that Asbury said the oiling really worked but they stopped doing it.
- Mr. Bishop stated you could only doing it a certain time of a year and you have to get permission to do it. He stated it was highly regulated.
- Mr. Gadaleta stated you had to be certified to oil the eggs. There's an agency that comes down and runs the program and shows you how to do it. Mr. Gadaleta stated he only knew you could do it with geese and not ducks.

Joel Popkin, 88 Inskip Avenue, stated it is a big problem over there. The ducks are sitting on your car in the morning. He felt the Township should have an Ordinance and place a posting over there. The Police should stop residents from other towns from feeding them.
