THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune, County of Monmouth, State of New Jersey hereby opposes the building of the Port Ambrose liquefied natural gas facility in the waters off the New Jersey coast for the reasons described herein; and,
