BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-21.7 – Resident Handicapped On-Street Parking, is hereby amended by adding the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Central Avenue	1	West side of Central Avenue beginning 30 feet south of the southwest intersection of Central Avenue and Cookman Avenue

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-9 – One-Way Streets, is hereby amended by adding the following:

<u>Name of Street</u>	<u>Direction</u>	<u>Location</u>
Inskip Avenue	Westerly	Entire Length
