#### TOWNSHIP COMMITTEE MEETING - MARCH 28, 2016

Mayor McMillan called the meeting to order at 6:00 p.m. and requested the Clerk to call the roll. The following members were present: J. Randy Bishop, Dr. Michael Brantley, Carol Rizzo, Nicholas Williams and Mayor Kevin B. McMillan.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; Michael J. Bascom, Chief Financial Officer; and Gene Anthony, Township Attorney.

Mayor McMillan announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 7, 2016, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk.

The following items were discussed in open session:

- Mr. Gadaleta stated that Blanche Dunbar, 40 Lynn Drive, appeared at the last Committee meeting regarding the removal of trees in the right-of-way in front of her home by the Township. On March 24<sup>th</sup>, the Shade Tree Commission dropped off replacement trees and a Contractor planted the trees on March 25<sup>th</sup>. A few more trees can be planted if necessary. Ms. Rizzo asked if the stumps were removed. Mr. Gadaleta stated that the stumps are in the right-of-way. He will ask Public Works to cut the stumps down to the ground. At this point, Ms. Dunbar walked into the meeting room and advised that the new trees are further back from the curb and more trees are needed on the side of the property.
- Mr. Gadaleta stated that the Shade Tree Commission wants to plant trees in Gables Park for Arbor Day. This will replace trees that were felled in Hurricane Sandy. The Gables Homeowners Association was contacted and are in favor of the project.
- Mr. Bishop asked Mr. Gadaleta to prepare a list of properties that are on the vacant and abandoned list and have questionable title. He suggested that the Township can get some information on ownership for these properties to get code enforcement issues resolved.
- Ms. Rizzo stated that she wants to finalize the designation of Committee Sub-Committees. Mr. Bishop suggested that the matter be placed on the next workshop meeting for discussion.

Mayor McMillan distributed photographs to Mr. Gadaleta depicting code issues at 26 Maplecrest Drive.

Mr. Bascom stated that the Traffic Calming discussion and workshop is ready to take place. The Committee asked that the item be scheduled for the April 25<sup>th</sup> workshop meeting.

Bernard Haney, Tax Assessor, stated that postcards were mailed to property owners in Shark River Hills, Seaview Island, and parts of Green Grove, west Neptune and the Concourse, that inspections will be done on properties in these areas. This is the first 20% of the Township being inspected under the Assessment Demonstration Program. Since no properties were done in 2015, another 20% will be done this year and that area will be in midtown and Ocean Grove. These inspections are required by law and the entire five year program that will eventual inspection 100% of the Township has been contracted and paid for.

The Committee entered executive session for discussion on closed session matters.

Jeff Klein was recommended for appointment to the Rent Leveling Board and the Committee acted by resolution at the regular meeting.

Terrell Brown was recommended for hire as a Special Law Enforcement Officer – Class I. The Committee requested the appropriate resolution be placed on the next regular meeting for consideration.

The Committee returned to the Meeting Room for the regular portion of the meeting.

Mayor McMillan called the meeting to order and requested the Clerk to call the roll. The following members were present: J. Randy Bishop, Dr. Michael Brantley, Carol Rizzo, Nicholas Williams and Mayor Kevin B. McMillan.

### **COMMENTS FROM THE DAIS**

Ms Rizzo stated that she attended the JSUMC community meeting. The parking garage is scheduled for completion by the end of the year. She attended the Ocean Grove Homeowners Association meeting and the MURC breakfast to support the Community Garden. MURC will also be sponsoring a summer job fair. Finally, she visited Ms. Dunbar's property on Lynn Drive to examine the removal of trees.

Mr. Williams stated that he attended a meeting on a new Clean Communities initiative which involves churches, the community and the schools in a program to keep the streets clean. He also attended the Recreation Department Easter egg hunt, the Board of Education 2016 budget presentation, the Shark River Hills Property Owners Association and the MURC breakfast for which he extended congratulations to Dianna Harris.

Mr. Bishop stated that he attended the corn beef & cabbage dinner at the Senior Center. He attended the MURC Trustees meeting to talk about the West Lake Avenue Redevelopment. MURC is contemplating a broad survey to get a better idea from Township residents and businesses on what they want to see as part of the redevelopment. He attended the MURC breakfast, the Memorial Day Parade Committee meeting and the Shark River Hills Sunrise Service on Easter. He noted that Jane Flynn, owner of five Dunkin Donuts and participant in many community events, passed away.

Dr. Brantley stated that he was sorry to miss the MURC breakfast. He attended the Wesley Lake Commission meeting where they are looking at alternatives to chemicals for weed removal in the lake. He also attended Fathers/Daughters Day at the Neptune Middle School.

The Mayor stated that he attended a candidate's forum to provide information on being an elected official to a college fraternity, the Biddy Basketball All-Star game, the MURC breakfast, a tour of colleges, and the Mt. Olive Good Friday service. He noted that Mt. Olive Church also has a soup kitchen on Thursdays.

#### PUBLIC COMMENTS ON RESOLUTIONS

Michael Fornino, 120 Fulham Place, commented on Resolution 16-178 and stated he was curious as to why they would tax the hospital because it did not make sense to him.

Mayor McMillan stated the hospitals were moving more from a fee base type of system to an outcome space and as a result of the Morris Town Memorial hospital case which proved that in some cases hospitals have profit entities in them. He stated they just wanted to protect the interests of the taxpayers.

Mr. Anthony stated the Morris Town case which is an Appellate Court decision found that most hospitals now though they are set up as non - profit have some profit oriented operations in their facility. We are not saying the entire hospital is non exempt. He stated they wanted to find out what parts were exempt and which parts weren't and tax them accordingly.

Mr. Bishop stated they wanted to pass this to protect themselves ourselves so that we have the ability to get the information so that we can respond as these decisions unfolds. He stated this was very rapidly an interesting unfolding of situations.

Mr. Fornino stated this is not what the resolution is saying.

Mr. Anthony stated you have to file a complaint challenging the total exemption in order to get the partial exemption unless the hospital is willing to meet with you a head of time.

Dorothy Argyros, 2100 Rutherford Avenue, stated she was in total support of this because she felt the rich was getter rich and the poor people were going broke. She questioned why hospitals were tax exempt so she looked it up. She stated this was not a free enterprise at all and we all were going broke for supporting the hospital. She thanked the Committee for this resolution and urged this to pass it.

#### ORDINANCE NO. 16-09 - ADOPTED

Michael Fornino, 120 Fulham Place, asked why the Township was seeking a 3.5% cap and not the mandated 2% cap. Mr. Bascom responded that this refers to the appropriation cap. The 2% tax levy cap still applies.

There being no further comments, the Mayor closed the public hearing.

Mayor McMillan requested public comments on the above ordinance and they were as follows:

Dorothy Argyros, 2100 Rutherford Ave., repeated that since they were subsidizing Jersey Shore Medical Center she felt we should have gotten more than a dollar for this easement, especially since people who are being charged high fees and penalties for encroaching on the Township's easements.

Michael Golub, 305 Cliffwood Drive, stated from what he believes there has been ten hospitals that have been challenged on their non-profit status. We are now questioning some of Jersey Shore's locations and they are not necessarily tax exempt, they are for profit. He questioned what was the hospital saying. He also stated a lot of conversations have taken place with the hospital including the Housing Authority as well. He questioned whether that discussion has ever been broached as a negotiation tool.

Mr. Anthony stated they were dealing with that right now with the Hope tower which is their new construction project and they've taken the stance that it is all subject to non exemption and we are realizing that it is all not necessarily. We are saying that part of the tower may or may not be tax exempt. There position so far is that the entire project is an exempt project.

Hank Coakley, Valley Road, questioned the location of the underground conduit would be proposed and erected.

Mr. Bascom stated the underground conduit would run from the police department to the hospitals new towers.

Ms. Rizzo asked if \$1 was the usual amount for an easement. Mr. Anthony stated that the Township is getting the benefit of conduit and construction to network the hospital to the Police Department

There being no further comments, the Mayor closed the public hearing.

The ordinance was adopted on the following vote: Bishop, aye; Brantley, aye; Rizzo, aye; Williams, aye, and McMillan, aye.

# EMPLOY ON-CALL PART-TIME YARD ATTENDANT IN THE DEPARTMENT OF PUBLIC WORKS

WHEREAS, Walter Thomas Taylor was employed in this capacity in the past, but has not worked for several years; and,

#### PRIVILEGE OF THE FLOOR/PUBLIC COMMENTS

Janel Jones, Stamford Drive, asked how the recent settlement in litigation involving the Neptune Fire District was paid. The Mayor stated that the Fire District is an autonomous body. Mr. Anthony added that the Township would not have that information and questions should be directed to the Board of Fire Commissioners.

Jack Bredin, 94 ½ Heck Avenue, tipped his hat to the Neptune Township Police Department and then he talked about Wesley Lake and it becoming an estuary.

Dr. Brantley stated the best thing they can do is make the lake better as it stands.

Joan Venezia, 107 Mt. Hermon Way, thanked everyone who has been answering her emails. She's stated she's been provided with good information. She questioned whether there were any updates on the North End as far as environmental issues. She stated she no longer had a contact with the Camp Meeting. She questioned when would the RSIS application be complete and be available to the public.

- Mr. Gadaleta stated it would be available at some point in the future but he did not have a date at this point.
- Mr. Bishop stated both he and Ms. Rizzo attended separate meetings and they were taking what they hear back to make sure that the Planner and Engineer were hearing that.

Michael Golub, 305 Cliffwood Drive, stated someone needed to address the issue of the rock on the corner of Route 33 and West Bangs Avenue because it was disgusting and is stupid because it is not working.

- Mr. Gadaleta stated both he and Committeeman Williams have had numerous discussions on this and they were continuing to look at it. The issue there were site triangular issues.
- Mr. Golub suggested they paint the lines yellow near the little league field. He also stated the police department recently received accreditation and questioned whether a contract was signed.
  - Mr. Bascom stated there was a fee for the review.
- Mr. Golub questioned whether he could OPRA the contract. He also stated additional work was needed on the fields on Jumping Brook because there is a problem with the drainage. He stated someone on the engineering side did not get it.

Mr. Williams stated he's been up there and reported the improvements and what is being done to address his concerns.

Mr. Golub stated as far as the car wash was involved, Natasha who works in Code Enforcement was a home run and she knew how to handle people on the phone. He commended Sgt. Zarro for the work he's done as far as the traffic.

#### (Dr. Brantley left the meeting)

Dorothy Argyros, 2100 Rutherford Avenue, stated the assessment demonstration program was a disaster and many towns have opted out of it. She stated Mayor Robert Mayhun of Avon stated it has resulted in increased financial burdens for Monmouth County taxpayers already struggling with an excessive tax burden. She felt there was no need for Neptune to stay in this program and to throw the residents under the bus.

Roger Wenzig, 507 South Riverside Drive, stated his neighbors in Shark River Hills have received cards that they will be inspecting their homes but no one is understanding what is going on. He questioned whether this was just for data collection or are they going to hit each person again with a reassessment and their taxes will go up.

Mr. Bishop asked if the homeowners association would be willing to share with the Committee the emails that they've received and have Bernie put together a fact sheet that we post and put out to answer your questions.

Mr. Gadaleta stated Mr. Haney has been in contact with the President of the property owners association. He also stated he had conversation with Mr. Haney today and the individuals that were coming out into the fields are in fact data collectors. They will not be in the field reassessing your property. What they are doing is collecting the data, compiling that information and bringing it back to our tax assessment office. It is to make sure that the information we have on file is accurate information. He stated he would suggest to Mr. Haney that they would take a page off of his department page to talk about the demonstration assessment program.

Kathy Arlt, 106 Abbott Avenue, announced that they have two representatives of SHIPPO coming to an Ocean Grove Homeowners meeting on April 23<sup>rd</sup> to talk about the certified local government program and how they can apply and what they will need to do to apply. This project is very close to her heart because her family has history in Ocean Grove. She questioned if anyone knew anything about 69 Webb Avenue. She stated it was in really bad shape. She stated she did not know where it came from that they needed to separate zoning ordinances for zoning.

Michael Fornino, 120 Fulham Place, stated in his opinion the tax pilot program was valid and the concept was to reinstate rolling assessments so that you don't get bombed every ten years. He also stated Wesley Lake and Deal Lake were once both estuary's to the Ocean. He also discussed drainage throughout the town both past and present.

Kennedy Buckley, Broadway, discussed the bird problem that was at Fletcher Lake, the snow problem and the parking in Ocean Grove.

Christina Schuetz, 24 Oakcrest Drive, stated she was here to remind them about the density and wildlife in her area and they needed protection.

Carol Ayoub, Summit Road, stated that she is supporting the St. Jude's walk in Asbury Park. Her parents were long time supporters of St. Jude and she asked the Committee and Township for support. She will be walking with Committeeman Williams.

Ricardo Biancho, stated that he is a cancer survivor and is supporting the St. Jude's walk. He added that it is great to see Asbury Park and Neptune joining forces for a good cause.

Mr. Bishop offered a motion, seconded by Mr. Williams, to adjourn. All were in favor.
