#### TOWNSHIP COMMITTEE MEETING - MARCH 12, 2018

Mayor Williams called the meeting to order at 6:00 p.m. and requested the Clerk to call the roll. The following members were present: Dr. Michael Brantley, Robert Lane, Jr., Kevin B. McMillan, Carol Rizzo, and Mayor Nicholas Williams.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; and Gene Anthony, Township Attorney.

Mayor Williams announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 4, 2018, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk.

The following items were discussed in open session:

The Committee reviewed a request from Fire District #1 for an increase in annual salary for the five Fire Commissioners from \$3,500 to \$5,000. State statute requires municipal governing body approval of salary increases for Fire Commissioners. The Mayor stated that the increase is in the voter approved budget and there has not been a change in salary since 2006. Ms. Rizzo stated that she was in favor since the increase is in the Fire District budget and the voters approved it. The Committee asked that a resolution be placed on the next meeting to approve the salary increase.

Ms. Rizzo stated that she would like to add high school students to the Green Team. Mr. McMillan stated that we had a High School Green Team and are looking to reactive the group. The Mayor stated that additional members can be added to the Township's Green Team.

Ms. Rizzo asked for more information on the Loaner Agreement resolution with the County. Mr. Gadaleta stated that this is a Township employee who was moved to the County when they took over 9-1-1 dispatching. The Agreement extends this arrangement whereby the County is paying the Township the cost of the employee's salary.

Ms. Rizzo asked for discussion on the proposed plan for shuttle bus service in Ocean Grove to provide access to off-site parking. The Mayor stated that at the last Township meeting, someone asked about the shuttle. Since the Committee is looking for ways to improve the parking situation, the Mayor asked Mr. Gadaleta to put some information together on the shuttle. Ms. Rizzo stated the parking professional from the Parking Task Force indicated that the shuttle was not a good idea. The Mayor stated that this shuttle proposal is just an idea. It would use the Senior Center bus to shuttle visitors to the midtown school parking lot. Mr. Gadaleta stated there is nothing in the budget specifically dedicated to the shuttle program. He added that he discussed the idea of valet parking with the Chamber of Commerce as a project then could look into. The Inskip Avenue lot would be used for parking. Ms. Rizzo replied that the Camp Meeting Association is against the use of the Inskip Avenue lot for parking.

# AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS ACT

Ms. Rizzo offered the following resolution, moved and seconded by Mr. Lane, that it be adopted:

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and,

WHEREAS, this public body is of the opinion that such circumstances presently exist,

THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune, County of Monmouth, as follows:

1. The Public shall be excluded from discussion of and action upon the hereinafter specified subject matters.

2. The general nature of the subject matter to be discussed is as follows:

Personnel/Litigation – Labor Attorney to provide update on litigation and Police Committee matters

Personnel – Vacancy on Wesley Lake Commission

Personnel – Recommendation for Code Inspector position

Contract negotiations – RFP for vacant and abandoned property services.

3. It is anticipated at this time that the above stated subject matters will be made public when matters are resolved.

4. This Resolution shall take effect immediately.

The resolution was adopted on the following vote: Brantley, aye; Lane, aye; McMillan, aye; Rizzo, aye; and Williams, aye.

The Committee entered executive session for discussion on closed session matters.

The Committee reviewed a recommendation to reclassify a Customer Service Representative to the position of Code Inspector. Ms. Rizzo expressed concern at the lack of female applicants and asked that future job postings encourage women and minorities to apply. The Committee asked that the resolution to approve the reclassification be placed on the next regular meeting.

The Committee will not take action on the proposal for vacant and abandoned property services. The process is functioning well currently and they are not in favor of increasing the registration fees.

The Committee returned to the Meeting Room for the regular portion of the meeting.

Mayor Williams called the meeting to order and requested the Clerk to call the roll. The following members were present: Dr. Michael Brantley, Robert Lane, Jr., Kevin B. McMillan, Carol Rizzo, and Mayor Nicholas Williams.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; and Gene Anthony, Township Attorney.

After a moment of Silent Prayer and the Flag Salute, the Mayor asked the Clerk to indicate the fire exits.

The Clerk stated, "Fire exits are located in the rear of the room and to my right. In case of fire you will be notified by bell and or public address system, then proceed to the nearest smoke-free exit"

Mayor Williams announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 4, 2018, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk. In addition, the meeting agenda, resolutions and ordinances are posted online at <u>www.neptunetownship.org</u>.

### APPROVAL OF MINUTES

Mr. Lane offered a motion, seconded by Ms. Rizzo, to approve the minutes of the meeting held on February 12th. All were in favor except Mr. McMillan and Dr. Brantley who abstained due to their absence at that meeting.

Mr. Lane offered a motion, seconded by Dr. Brantley, to approve the minutes of the meeting held on February 26th. All were in favor except Mr. McMillan and Ms. Rizzo who abstained due to their absence at that meeting.

#### COMMENTS FROM THE DAIS

Dr. Brantley stated that the Redevelopment Committee met with the Redevelopment Attorney and got an overview of redeveloper's interest in West Lake and North Channel. He attended an Irish/American Dinner where Mayor Williams was honored. The St. Patrick's Day parade in Belmar was great, but cold. He and the Mayor were nominated by the Neptune Democratic organization to run for re-election to the Township Committee.

Mr. McMillan offered prayers for Pam Howard, Deputy Municipal Clerk, whose brother passed away last week. He attended an Economic Development meeting in Ocean Grove where valet parking was discussed. On the League Legislative Committee, he approved equal pay for women legislation. He attended a Black History Month program at Green Grove School and marched in the Belmar parade. Finally, he met with people at the homeless encampment behind Shop-Rite to distribute shoes. One of the individuals is looking into a multi-family housing situation for the group.

Mr. Lane attended the St. Patricks Day parade and the dinner at which the Mayor was honored. There wer 4,349 diapers collected in the Diaper Drive in February. There are tickets available to the Veterans Park Committee dinner/dance at the American Legion. Mr. Lane presented an award to Ryan Ugrovics, Senior Center employee who helped assist a homebound client after a medical episode.

Ms. Rizzo provided an update on the recent issue with a church being placed back on the tax roles. Rev. Wright had until October to get the roof on the church to regain the tax exempt status. We are not able to make the bill for 2017 taxes go away, but there will not be any taxes accruing in 2018 because the church has regained tax exempt status. She notified all that the state now has a state income tax exemption on up to \$3,000 in income for veterans and the \$250 property tax credit remains. Anyone seeking help with tax forms should contact the Senior Center or library.

Mayor Williams marched in the Belmar parade. He congratulated the Neptune High School band who did a great job at the parade. The Redevelopment Committee is pushing redevelopment and has met with multiple developers with interest in four Township redevelopment zones. They are coming back with drawings and show genuine interest.

#### PUBLIC COMMENTS ON RESOLUTIONS

Dorothy Argyros, 2100 Rutherford Avenue, stated that punitive damages are appropriate in the case listed in the two resolutions this evening because Chief Hunt and Mr. Bascom where in charge when a police officer murdered his wife and are non-responsive to complaints from female officers. If the case is settled, the taxpayer gets stuck with the bill. Mr. Anthony stated that we never get to a punitive damage trial. The insurance carrier represents the Township in the compensatory trial and makes the recommendation on how to proceed.

Dianna Harris, 17 Willow Drive, asked for information on the Green Team. Mr. McMillan stated this is in reference to Sustainable NJ which looks at ways to protect the environment and get credits for actions that the Township has already taken as well as grant opportunities. Ms. Harris for more information on the recording equipment being purchased. Mr. Gadaleta stated that this is upgraded equipment to record phone and radio communications in the Police Department.

WHEREAS, the Township Committee of the Township of Neptune wants to begin the process of focusing on "Green" issues by starting with audits of municipality facilities and operations first.

WHEREAS, the Township Committee of the Township of Neptune will appropriate funds to begin the process of making its operations greener, and more environmentally friendly beginning with energy audits of the Township's facilities to pinpoint the most effective ways to reduce energy consumption; and

WHEREAS, solar power, changes to fleet purchasing and maintenance, water quality improvements, and operational changes will all be considered as the Township moves to do their share to lessen the environmental impact of its operations,

THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Neptune that we do hereby establish a Green Team Advisory Committee consisting of eleven members who shall be residents or employees of Neptune Township, appointed annually, but whose initial term of appointment shall be through December 31, 2018; and,

BE IT FURTHER RESOLVED, by the Township Committee of the Township of Neptune that the Mission, Goals and Objectives for the GTAC through December 31, 2018 are established as follows:

#### MISSION

The Neptune Township Green Team Advisory Committee will advise the Township Committee on ways to improve municipal operations with "Green" initiatives which are economically and environmentally sound through research and evaluation.

#### GOALS

Submit a report and recommendations to the Township Committee to include:

- 1. An audit of municipal facilities
- 2. An evaluation of municipal fleet vehicles
- 3. A report of suggested best practices for "greener" municipal operations

# **OBJECTIVES**

- 1. Collaborate with township employees, service providers and other governmental agencies to share resource information and ideas consistent with the Mission of the GTAC.
- 2. Encourage participation of all employees to solicit ideas on green initiatives.
- 3. Research and analyze green initiatives which make practical environmental and financial sense.
- 4. Develop strategies for sustainable green initiatives in municipal operations.

#### AUTHORIZE EXECUTION OF A LOANER AGREEMENT WITH THE COUNTY OF MONMOUTH AND THE MONMOUTH COUNTY SHERIFF'S OFFICE

WHEREAS, the County and Township previously entered into a shared service agreement for the County to provide emergency response communication services to the Municipality; and,

WHEREAS, to assist with the transition of the provision of said services from the Township to the County so as to address unique issues, the Township requested that the County utilize the services of a Township trained Public Safety Telecommunicator ("PST"); and,

WHEREAS, the Monmouth County Sheriff's Office, Communications Division has determined that there is a present need for a PST to assist with call-taking and emergency dispatch services; and,

WHEREAS, the Township of Neptune will provide the County with a Township trained PST to assist with the unique transitional issues as requested by the Township; and

WHEREAS, the Township trained PST will gain invaluable experience working with a larger organizational unit and dispatch center while simultaneously increasing the manpower of the County dispatch center,

THEREFORE, BE IT RESOLVED, that the Township Committee of the Township of Neptune hereby authorizes the execution of a Loaner Agreement with the County of Monmouth and the Monmouth County Sheriff's Officer to allow for the assignment of a Township trained PST to the Monmouth County Sheriff's Office through December 31, 2021; and,

### PRIVILEGE OF THE FLOOR/PUBLIC COMMENTS

Noel & Ronald Clark, 107 Monmouth Avenue, stated that there is a lot of speeding on their road and it is only getting worse. The Mayor asked Sgt. Washington, who was present at the meeting, to follow up on this matter.

Tim Bauman, 15 Jumping Brook Road, asked if the Township has an ordinance regarding high intensity LED lighting intruding on a neighbor. Mr. Gadaleta responded yes and advised Mr. Bauman to contact the Engineering Department. Mr. Bauman stated that Jumping Brook Apartments has installed new lighting at the top of their buildings that casts light on his property.

Joyce Klein, 105 Mt. Hermon Way, stated that she missed the workshop discussion regarding the Ocean Grove shuttle. She applauds the Committee for trying to do something, but the Township should hire a traffic expert first before anything is done because an expert would be better able to determine what would work. The Mayor stated that someone approached him with the idea and he asked Mr. Gadaleta to preliminarily look into the matter. We would use Township buses and the Board of Education parking lot. Ms. Klein suggested that the Township ask the Camp Meeting Association for guidance since they attempted this before.

Nancy Clarke, 47 Embury Avenue, asked for any updates on the North End redevelopment. Mr. Gadaleta stated that the new Redevelopment Attorney has the files. He is in the process of setting up a meeting with WAVE and will share any new information. Ms. Clarke stated it would be helpful to have a professional to have input on the Ocean Grove parking because they can help make some initiatives more successful.

Dorothy Argyros, 2100 Rutherford Avenue, stated that the Committee tabled a resolution to oppose offshore drilling at the last meeting. She asked if the matter will come up again. The Mayor stated that there was not an opportunity to discuss it with the entire Township Committee and the Committee will look at it in the future. Ms. Argyros asked the Committee to be wary of bail-ins which will allow banks to into your personal accounts and take your money in the event of the next financial downturn. The government will save the rich and the bankers, not the people.

Jack Bredin, 94 ½ Heck Avenue, stated that the Committee should have the Redevelopment Attorney present at these meetings. Anyone can find the zoning on any property in any town in the State so you do not need to meet with developers. They can find out what is needed by looking at the Master Plan and the zoning ordinance. Wesley Lake and Fletcher Lake are not included in the list of municipal facilities. The Township has to clear that the lakes are either on the Roster of Open Space Inventory or a municipal facility, they can't be both.

Dianna Harris, 17 Willow Drive, asked for information on the polling place changes that have occurred in Neptune. Mr. Cuttrell explained that four polling districts will have changes. Postcards will be mailed to each registered voter in the affected districts and signs will be placed on the old polling places to notify voters of the change. Ms. Harris asked if the senior tax freeze was also available in Neptune Township. Ms. Rizzo responded that is available in Neptune along with the new veterans deductions.

Reverend Edmund Lee, stated that there is still one property not owned by the Township in within the one block of properties in the West Lake Avenue Redevelopment Zone. He added that towns along the coast should oppose offshore drilling. The Mayor stated that he wants to present that to the full governing body and believes the matter will resurface in the future.

Richard Williams, 1 Abbott Avenue, asked if the Township has a vision for the redevelopment areas or are developers saying what should be done. The Mayor responded that the Redevelopment Plan dictates what can be done. Redevelopment is based on what the Township wants, not what the Redeveloper wants. Mr. Gadaleta stated that all of the redevelopment plans are on the Township web site. Mr. Anthony stated that the Redevelopment Attorney negotiates the Redevelopment Agreement which includes safeguards to protect the Township. Mr. Gadaleta added that the Township is looking at redevelopment corridors by block within the zones so that both sides of the street are done at the same time.

Elizabeth Markulin, 112 Cardinal Road, asked Mr. McMillan to repeat what he said earlier about his visit to the homeless encampment. Mr. McMillan repeated that he delivered shoes and one of the people who lives there is looking at a multi-family dwelling where they all can live.

Mr. Lane offered a motion, seconded by Ms. Rizzo to adjourn. All were in favor.
