TOWNSHIP COMMITTEE MEETING - APRIL 8, 2019

Mayor Rizzo called the meeting to order at 5:00 p.m. and requested the Clerk to call the roll. The following members were present: Dr. Michael Brantley, Robert Lane, Jr., Nicholas Williams, and Mayor Carol Rizzo. (Kevin McMillan arrived during executive session)

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; and Gene Anthony, Township Attorney.

Mayor Rizzo announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 3, 2019, a notice of revised meeting start time published on April 4, 2019, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk.

<u>AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS</u> ACT

Mr. Williams offered the following resolution, moved and seconded by Dr. Brantley, that it be adopted:

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and,

WHEREAS, this public body is of the opinion that such circumstances presently exist,

THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune, County of Monmouth, as follows:

- 1. The Public shall be excluded from discussion of and action upon the hereinafter specified subject matters.
 - 2. The general nature of the subject matter to be discussed is as follows:

Personnel – Personnel matter

Personnel – Assistant Mercantile License Officer

Personnel – Recommendations for Bookkeeper, Customer Service Representative in Code/Construction and seasonal Marina Attendants.

- 3. It is anticipated at this time that the above stated subject matters will be made public when matters are resolved.
 - 4. This Resolution shall take effect immediately.

The resolution was adopted on the following vote: Brantley, aye; Lane, aye; Williams, aye; and Rizzo, aye.

The Committee entered executive session for discussion on closed session matters.

The Committee reviewed recommendations for the reclassification of existing employees and the hiring of part-time seasonal Marina Attendants and Property Maintenance Worker and tool action by resolution during the regular business portion of the meeting.

Mr. Anthony discussed an OPRA case that was held before the Government Records Council (GRC). The case involved assessing records that were denied in 2014 because the records are held by the County of Monmouth. The GRC ruled that the Township unintentionally withheld the documents but must provide the documents. The Township is responsible for fees incurred by the Plaintiff's attorney which amount to \$1,320.00. Mr. Anthony will prepare a resolution for the Committee's consideration at the next regular meeting.

Mr. Williams offered a motion, seconded by Mr. McMillan, to return to open session. Dr. Brantley left the meeting due to illness.

The following items were discussed in open session:

Mr. Gadaleta discussed the National League of Cities Service Line Warranty Program. This is a program to warranty utility lines for the portion that is the responsibility of the property owner.

The warranty would be offered to Township residents and would not be of any cost to the Township. Mr. Gadaleta will obtain additional information and report back to the Committee.

Mr. Gadaleta stated that Governor Murphy held a press conference at the Municipal Marina building earlier in the day regarding additional funding for residents who are still not in their homes as a result of Hurricane Sandy. Mr. Gadaleta also reported that he is meeting with the Chamber of Commerce on a monthly basis and is obtaining estimates on the maintenance of the trees on Main Avenue. Also, he is working with the Chamber on shuttle service for the June 1 st flea market and the July 6th parade and fireworks. They will pay for the cost of the shuttles to and from the parking lot at Midtown Community School. He is seeking interest by the Chamber in taking on a project to install banners on the Broadway island light poles. The cost of the signs would be sponsored by businesses. The Redevelopment Committee met recently and there will likely be resolutions on the April 22nd meeting to extend the Conditional Redevelopment Agreements for both the North End and the West Lake Avenue Redevelopers. He is also negotiating the Township's purchase of the People's Barber Shop property.

Mayor Rizzo called the regular meeting to order and requested the Clerk to call the roll. The following members were present: Robert Lane, Jr., Kevin B. McMillan, Nicholas Williams, and Mayor Carol Rizzo. Absent: Dr. Michael Brantley

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; and Gene Anthony, Township Attorney.

After a moment of Silent Prayer and the Flag Salute, the Mayor asked the Clerk to indicate the fire exits.

The Clerk stated, "Fire exits are located in the rear of the room and to my right. In case of fire you will be notified by bell and or public address system, then proceed to the nearest smoke-free exit"

Mayor Rizzo announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 3, 2019, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk. In addition, the meeting agenda, resolutions and ordinances are posted online at www.neptunetownship.org.

APPROVAL OF MINUTES

Mr. McMillan offered a motion, seconded by Mr. Lane, to approve the minutes of the meeting held on March 25th. All were in favor, except Mr. Williams who abstained due to his absence.

PROCLAMATION

The Mayor proclaimed April 26th as Arbor Day in the Township of Neptune.

COMMENTS FROM THE DAIS

Mr. Williams stated that the Friends of Belmar Harbor are finalizing plans for this year's programs. A portion of the programming is moving to the Shark River Municipal Marina. The sailing program cannot move this year due to DEP regulations. In return for the use of the marina facilities, a limited number of Neptune students will be allowed to attend the programs for free.

Mr. McMillan attended a Recreation Committee meeting. The Committee is analyzing the various summer programs to either improve or expand.

Mr. Lane stated that the Recreation Committee is looking at different recreation programs and the expansion of Neptune Day to include some different things. He attended the Cops vs. Kids basketball game, the Black & Blue Ball which helps survivors of fallen police officers, and a ribbon cutting ceremony for a new family owned breakfast and lunch establishment. The project to film some of our senior citizens is progressing.

Mayor Rizzo stated that she did an interview with News 12 prior to the Governor's arrival at the Marina. Governor Murphy announced the availability of \$50 million to help people get into their homes damaged by Hurricane Sandy as well as an extra 19 months in rental assistance. She met with Tami Crader, Superintendent of Schools, and they are working on our state legislature representatives regarding the school district's loss of state aid. Ms. Crader believes the Department

of Education may have faulty data. The Mayor thanked Mr. Williams and Mr. Gadaleta for their efforts in getting the Friends of Belmar Harbor to conduct their programming at the Municipal Marina.

WHEREAS, the Township desires to issue the Note to the Sewer Operating Fund of the Township; and

WHEREAS, such Note shall bear interest at a rate of zero and zero hundredths percentum (0.00%) per annum and shall mature on January 15, 2020; and

WHEREAS, the Township seeks to authorize the issuance of the Note to the Sewer Operating Fund of the Township.

BE IT RESOLVED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF NEPTUNE, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY as follows:

Section 1. Pursuant to and in accordance with Bond Ordinance Number 18-07 duly adopted by the Township on March 12, 2018 (the "Bond Ordinance"), a Sewer Utility Bond Anticipation Note of the Township in an aggregate principal amount not to exceed \$1,330,000 (the "Note") shall be issued for the purpose of temporarily financing the costs of various sewer capital improvements to Heck Avenue and the Tremont Pump Station in the Township.

Section 2. The Note is authorized to be issued to the Sewer Operating Fund of the Township.

Section 3. The Note shall be dated April 9, 2019 and shall mature on January 15, 2020 and shall bear interest from its date, which interest shall be at a rate of zero and zero hundredths percentum (0.00%) per annum, and shall be in the form attached hereto as <u>Exhibit A</u>.

Section 4. The Note shall be subject to prepayment by the Township at any time prior to its stated date of maturity.

Section 5. The Note shall be executed by the Mayor and the Chief Financial Officer of the Township and the official seal shall be thereunto affixed and attested to by the Clerk of the Township. To the extent not otherwise determined by this resolution, it is hereby delegated to the Chief Financial Officer of the Township the authority to determine all matters in connection with the Note issued, and the signature of the Chief Financial Officer upon the Note shall be conclusive evidence as to all such determinations. The Chief Financial Officer is also hereby authorized to sell part or all of the Note from time to time at a public or private sale and to deliver it to the purchaser thereof upon receipt of payment of the purchase price and accrued interest thereon from its date to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the Township Committee at the meeting next succeeding the date when any sale or delivery of the Note pursuant to this resolution is made. Such report must include the principal amount, the description, the interest rate, the maturity schedule of the Note so sold, the price obtained and the name of the purchaser. The Chief Financial Officer is hereby authorized and directed to deliver any certificates necessary in connection with the issuance of the Note.

Section 6. This resolution shall take effect immediately.

This Note may be registered as to principal and interest after which it will be transferable only upon presentation to the Chief Financial Officer of the Township at his office with a written assignment duly acknowledged or proved, and the name of the assignee shall be endorsed hereon and entered in the books kept in the office of said Chief Financial Officer of the Township.

This Note is subject to prepayment by the Township at any time prior to its stated maturity.

This Note is being issued to temporarily finance the costs of various sewer capital improvements to Heck Avenue and the Tremont Pump Station in the Township. This Note is authorized to be issued pursuant to the provisions of the Local Bond Law, N.J.S.A. 40A:2-1 et seq., as amended and supplemented, Bond Ordinance Number 18-07 duly adopted by the Township Committee on March 12, 2018, approved by the Mayor and published as required by law, and a resolution duly adopted by the Township Committee on April 8, 2019.

It is hereby certified and recited that all acts, conditions and things essential to the validity of this Note exist, have happened and have been done, and that every requirement of law affecting the issuance hereof has been duly complied with, and this Note is within every debt and other limit prescribed by the Constitution and laws of the State of New Jersey.

PRIVILEGE OF THE FLOOR/PUBLIC COMMENTS

Dianna Harris, 17 Willow Drive, read a letter addressed to Dr. Brantley and Mr. Williams from MURC. The letter expresses thanks to the two for attending a recent MURC meeting regarding redevelopment. The letter expresses concerns regarding the West Lake Avenue redevelopment including density, parking, affording housing, pricing and types of businesses. The letter expresses the need to include local contractors in the construction and asks that MURC be kept updated as to progress. Ms. Harris asked that the Redeveloper attend the next MURC meeting on April 23rd. Ms. Harris asked if the Police Department will be doing their annual report and asked if they could present the report at a MURC meeting. Mr. Williams will discuss with Chief Hunt.

Kennedy Buckley, 65 Broadway, asked who will enforce the Settlement Agreement with the owners of 9 Broadway. Mr. Gadaleta responded Michael Celli and that he and Mr. Anthony will be contacting Mr. Celli regarding the matter.

Hank Coakley, Valley Road, asked for an update on street numbers on all buildings, the bump out on Neptune Blvd., sunken manhole covers on Route 33, and yellow lines on Brighton Avenue. He stated he against a ban on plastic bags and referred the Committee to a display at Manalapan Town Hall in regards to the drawbacks of plastic water bottles. Mr. Gadaleta responded that Code Enforcement is looking into the street numbers on buildings issue at the time an application for a certificate of inspection is made. The Route 33 paving is a NJDOT issue and they have not acted. Brighton Avenue will be paved and stripped the week after Easter. The bump out on Neptune Blvd will remain and it is up to the State to act on a plastic bag ban.

Jack Bredin, 94 ½ Heck Avenue, asked for the cost of preparing the North End Redevelopment Plan. The Mayor responded \$25,000. Mr. Gadaleta stated that the Township will be passing that cost on to the Redeveloper. Mr. Bredin stated that the Redeveloper has to deposit money for the review of the plans and for the preparation of the Redevelopment Plan. Mr. Gadaleta stated that the Redeveloper has already deposit \$50,000 for the cost of the review of plans by the Township's professionals and will be paying the \$25,000 for the cost of the Redevelopment Plan once the Redevelopment Agreement is executed. Mr. Bredin stated the reason why WAVE did not develop the North End property is because the DEP says that two levels of underground parking cannot be done. Mr. Bredin asked if either WAVE or OGNED are the same entity and if either ever developed anything. Mr. Gadaleta stated that some of the principals of OGNED also were a part of WAVE and that principals of OGNED have completed larger projects than the North End project.

Connie Holmes 62 Winding Ridge Drive, asked if the West Lake Avenue Redeveloper has acquired any contracts to purchase property on West Lake Avenue. Mr. Gadaleta stated that the Township is negotiating with him on Township owned property and he has one other lot under contract. He added that the transfer of property will not take place until the Redevelopment Agreement is signed.

Sandra Stevens, 1513 6th Avenue, stated that portions of the sidewalk on 6th Avenue are in need of repair, there is a sight problem at the intersection of 6th and Union because of trees, and speeding is occurring on 6th Avenue. She asked for the Township to partner with the County to install a solar powered speed sign on 6th Avenue between Route 35 and Neptune Blvd. In addition, she asked for a 4 way stop at 6th Avenue and Neptune Blvd and advised that cars should not be allowed to park on the sidewalk of 6th Avenue adjacent to the Housing Authority apartments. Mr.

Gadaleta stated that trees and sidewalls are the responsibility of the homeowner and he will have Code Enforcement look into the matter. He added that since 6th Avenue is a County road, the Township cannot adopt traffic regulations without County approval.

Robert Ivory, 1412 7th Avenue, stated that his neighbors at 1416 7th Avenue are running a taxi stand and making repairs on vehicles at a residential home. Mr. Gadaleta will bring the matter to the attention of the Zoning Officer.

Mr. McMillan offered a motion, seconded by Mr. Lane to adjourn. All were in favor.
