BE IT ORDAINED, by the Township Committee of the Township of Neptune that Volume I, Chapter VII, Section 7-13 of the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-13 – Turn Prohibitions - is hereby amended to add the following:

Route NJ 33 (Corlies Avenue)	Left Turns	Northbound Stanley Avenue
and Stanley Avenue		Route NJ 33 westbound
Route NJ 33 (Corlies Avenue) and Davis Avenue	Left Turns	Southbound Davis Avenue Route NJ 33 eastbound

SECTION 2

All ordinances or parts of ordinances in conflict with or inconsistent with the provisions of this ordinance are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the taking effect of this ordinance.
