TOWNSHIP COMMITTEE MEETING - MARCH 9, 2020

Mayor Lane called the meeting to order at 6:00 p.m. and requested the Clerk to call the roll. The following members were present: Dr. Michael Brantley, Kevin B. McMillan, Carol Rizzo, Nicholas Williams, and Mayor Robert Lane, Jr.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; and Gene Anthony, Township Attorney.

Mayor Lane announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 3, 2020, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk.

The following items were discussed in open session:

Mr. Gadaleta reported that two meetings will be held on March 10th at the Municipal Building to discuss methods to ensure participation in the 2020 census.

Mayor Lane stated that the annual Hometown Hero Dinner/Dance will be held on April 18th. The Mayor will be sending a letter to Freeholder Tom Arnone requesting the County to install two signs on Old Corlies Avenue directing people to Veterans Memorial Park. The Mayor announced that the Township will be adding veterans and active military only parking spaces at the Municipal Building, Senior Center, and Veterans Memorial Park.

AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS ACT

Ms. Rizzo offered the following resolution, moved and seconded by Mr. McMillan, that it be adopted:

The Committee entered executive session for discussion on closed session matters.

The Committee reviewed recommendations for appointments to the Housing Authority and the Environmental/Shade Tree Commission and asked that the appropriate resolutions be placed on the next regular meeting agenda.

Mr. Gadaleta reminded that the Committee that employment contracts for all employees, including both union and management, expire at the end of 2020.

Mr. Gadaleta stated that the Township prevailed in a matter before the Public Employees Relations Commission and also in the appeal of the Board of Adjustment decision to uphold the determination of the Zoning Officer regarding the proposed charter school at the former Holy Innocents School location.

The Committee returned to the Meeting Room for the regular portion of the meeting.

Mayor Lane called the meeting to order and requested the Clerk to call the roll. The following members were present: Dr. Michael Brantley, Kevin B. McMillan, Carol Rizzo, Nicholas Williams, and Mayor Robert Lane, Jr.

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; and Gene Anthony, Township Attorney.

After a moment of Silent Prayer and the Flag Salute, the Mayor asked the Clerk to indicate the fire exits.

The Clerk stated, "Fire exits are located in the rear of the room and to my right. In case of fire you will be notified by bell and or public address system, then proceed to the nearest smoke-free exit"

Mayor Lane announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 3, 2020, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk. In addition, the meeting agenda, resolutions and ordinances are posted online at <u>www.neptunetownship.org</u>.

APPROVAL OF MINUTES

Mr. McMillan offered a motion, seconded by Ms. Rizzo, to approve the minutes of the meeting held on February 24, 2020. All were in favor, except Mayor Lane who abstained due to his absence.

COMMENTS FROM THE DAIS

Ms. Rizzo attended a public meeting of the Better Parking Alliance. She stated that people in attendance were able to voice their opinions about parking in Ocean Grove. She has been appointed to the Hackensack/Meridian Community Advisory Board to receive feedback on patient care. She is working with the Monmouth County Democrats on a set of procedures to advise and educate political candidates and campaign volunteers on harassment.

Mr. Williams stated that the marina is beginning to wake up for the summer season. There has been no overtime in the Public Works Department due to the lack of snow this winter.

Dr. Brantley stated the Planning Board is doing a great job. The Board has approved a number of projects.

Mr. McMillan attended the Better Parking Alliance meeting and healthy dialogue on the parking issue took place. He marched with the Mayor in the St. Patrick's Day parade. He attended the pancake fundraiser for the Broadway fire victims, the Read Across America event at the library, the Midtown School Black History month event, the annual Parks and Recreation awards dinner, the Mt. Olivet Black History month event, and the Light of the World Apostolic Faith Church Building Fund dinner. Mr. McMillan also performed a couple of weddings since the last meeting.

Mayor Lane attended a dinner for the homeless sponsored by set up by Reverend Edmund Lee, Mouth Carmel Baptist Church. He will be meeting with Reverend Lee and Assemblyman Houghtaling to address the remaining homeless in the community. He announced that 116 pints of blood were given at the recent blood drive. He honored Township residents in the journalism profession at the Black History Month celebration. He attended the American Legion Post 266 Black History month event, pancake dinner for the fire victims, and St. Patrick's Day parades in Belmar and Asbury Park. On July 5th, over 220 kids will be arriving in Neptune for the annual World Changers event. He read to over 60 kids at the Dr. Seuss event in the library. The Youth Advisory Council will be holding a fund raiser at Delvetto's. Finally, he announced that the annual Hometown Hero dinner/dance will be held on April 18th. Honorees are James Manning, Sr. and Neil DenBraven.

PRIVILEGE OF THE FLOOR/PUBLIC COMMENTS

Dr. James Chenitz, South Riverside Drive, stated that Mr. McMillan should have the County line in the June primary. At the last meeting, he spoke on Mr. McMillan's behalf. He mentioned his education on the issues and that all of his efforts and decisions are based on what is best for the Township. He stated that other member of the Township Committee acted like lemmings and voted against Mr. McMillan. The Neptune Democratic organization has suffered a significant loss of faith and transparency. Powerful members of the Township Committee only want things done their way. The public will do everything in their power to shine a light on this manipulation and will get Mr. McMillan elected at the primary. The future of Neptune Township depends on it.

Mr. Anthony replied that the Open Public Meeting Act refers to discussion on items that the Township Committee can act on. This matter is a political caucus issue. The public has the right to say anything during the public comment portion of the meeting. He suggested that anyone who has concerns about this issue should run for County Committee or address the district leaders.

Mr. McMillan stated that he is glad to see some of the district leaders here this evening. He thanked everyone for attending.

Richard Williams, 2 Abbott Avenue, stated that he was shocked to learn of the development regarding Mr. McMillan. He will do everything he can to ensure Mr. McMillan wins the election.

Hank Coakley, Valley Road, asked when the West Bangs Avenue detour at Route 33 will be eliminated and who came up with the detour plan. He asked when the bump-out on Neptune Boulevard will be removed. He asked if all Neptune residents will be able to park in Ocean Grove if resident only parking is implemented. Everyone in Ocean Grove is allowed to park in any other section of Neptune Township. Mr. Gadaleta replied that the Neptune Boulevard bump-out will not be removed. The West Bangs Avenue project will be completely shortly and the detour was a decision of the County Engineer. The Ocean Grove parking is still being discussed.

Nancy Clarke, 47 Embury Avenue, stated that she appreciates Mr. Anthony's comments. This is the only opportunity to speak in public about district leaders choosing a different person for the county line. Other Township Committee members were influential in choosing the other person. She is shocked that some are of the belief that if someone disagrees, it's better to get rid of them. This is not a neighborhood issue, but a Neptune-wide issue.

Ava Johnson, 1002 Fordham Road, stated that the when turning from Neptune Boulevard on to westbound Route 33, your car hits the curb. This causes drivers to turn into the left lane of traffic. Mr. Gadaleta will talk to the Township Engineering Department and ask them to contact the State.

Connie Holmes, 33 Winding Ridge Drive, thanked the Committee for the proclamation at the Black History Month celebration. She stated that she understands that the district leaders chose someone else to run for Township Committee but questioned why they did not choose a woman with experience. Mr. Anthony replied that question needs to be raised with the district leaders. Ms. Holmes stated that the people in the community do not know things are happening after the decisions are already made. She asked that the community be notified.

Joyce Klein, 105 Mt. Hermon Way, stated that she was not going to speak this evening but is upset that the Committee gave lip service to Ms. Holmes when she asked about more women in government especially after just celebrating the centennial of suffrage.

Tassie York, 1203 11th Avenue, stated that each district leader votes their conscious. She sees what happens in her district and votes accordingly. No district leader was bullied or redirected a certain way and she has no regrets in the way she voted.

Mr. McMillan offered a motion, seconded by Mr. Williams to adjourn. All were in favor.
