TOWNSHIP COMMITTEE MEETING - MAY 10, 2021

Mayor Brantley called the meeting to order at 6:00 p.m. In addition to live attendance, the Mayor announced that video and audio access to the meeting is available via townhallstreams.com/towns/neptune_nj.

The Mayor requested the Clerk to call the roll. The following members were present: Keith Cafferty, Robert Lane, Jr., Nicholas Williams, Tassie D. York, and Mayor Michael Brantley.

Also present were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; and Gene Anthony, Township Attorney.

Mayor Brantley announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in The Coaster and the Asbury Park Press on April 29, 2021, which indicated the ability to attend the meeting in person and included instructions on accessing and participating in the meeting virtually trough townhallstreams.com. The Notice was filed with the Municipal Clerk and posted on the Township web site (www.neptunetownship.org), along with the meeting agenda, ordinances and resolutions.

The following items were discussed in open session:

- Mr. Cafferty stated that he has been working with Mr. Anthony on an ordinance to recreate the Green Team. The ordinance calls for more community membership with the goal to recertify the Township's Sustainable Jersey bronze level and hope to achieve silver level. Mr. Anthony added that this is an advisory board that can make recommendations to the Township Committee. There will be five voting members and two alternate members.
- Mr. Lane reviewed the Memorial Day events including a parade in Shark River Hills, service at American Legion Post #346, service event at the monuments at the Broadway entrance to Ocean Grove, and a ceremony at Veterans Memorial Park where the reading of deceased service members will be read.
 - Mr. Cafferty announced the Hooked on Fishing Event on June 5th.
- Ms. York announced the Giant Flea Market in Ocean Grove also on June 5th. She also discussed possible community events with the Ministerial Alliance.
- Mr. Lane announced a community outreach event by the Jersey Shore Dream Center on June 6th.
- Mr. Gadaleta reminded the Committee that the Pride Flag will be raised at the Municipal Complex on June 1st and asked if they desired a ceremony. He also stated that Green Acres and NJDOT funding applications are due on September 20th and July 1st respectively. He will submit recommendations on both grant opportunities to the Committee.
- Mr. Gadaleta stated that the Shark River Hills bikeway/vista application was deficient in the notice to the public. The DEP has rescinded the permit. He will correspond with the Committee to see how to proceed.
- Ms. York asked that a flag be raised at the Municipal Complex on June 19th in recognition of Juneteenth. Mr. Gadaleta will follow-up.
- Mr. Gadaleta stated that banners will be installed this week on the 20 light poles on Broadway medians. The banners will contain an American flag with the King Neptune logo and "Township of Neptune" at the bottom.

<u>AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS ACT</u>

The Committee entered executive session for discussion on closed session matters.

The Committee reviewed a recommendation for appointment to the Rent Leveling Board and asked that a resolution be placed on the next regular meeting.

Mr. Anthony reviewed a sewer capacity reservation agreement with Tinton Falls Veterans Hospital that was signed in 1997. They stopped paying to reserve the capacity last year. The Agreement allows the Township to terminate, but not to force them to remain in the Agreement. Michael Bascom, C.F.O. has recommended that the Agreement be terminated and not commence legal action for the fee not paid last year. The Township can sell the reserve capacity to someone else. The Committee agreed on this course of action.

Mr. Gadaleta announced that Leanne Hoffmann, Township Engineer, has resigned effective June 4th. He will advertise the position, but the Committee may have to select an Engineer from a private firm to serve in the interim if an Engineer cannot be selected and hired quickly.

The Committee returned to the Meeting Room for the regular portion of the meeting.

Mayor Brantley called the regular meeting to order at 7:00 p.m. by announcing that in person attendance is permitted. In addition, video and audio access to the meeting is via townhallstreams.com/towns/neptune_nj. Questions and comments may also be submitted via townhallstreams.com/towns/neptune_nj.

COMMENTS FROM THE DAIS

Mr. Lane announced Memorial Day events, the Jersey Shore Dream Center community outreach on June 6th at the former Hamilton First Aid building, and a Celebration of Life for "Hometown Hero" Terry Scalione will be held on May 22nd at St. Paul's Church. May is Older Americans Month. The Senior Center Staff held a food drive and offered a Mexican themed lunch on May 5th. Outdoor fitness has also begun at the Center. Mr. Lane also announced that American flag banners will be going up on the light poles on the Broadway islands.

Ms. York stated that she met with the Ocean Grove Chamber of Commerce, community members, and the Ministerial Alliance, to get their commitment on events to involve the community. The next Ocean Grove event is the Giant Flea Market on June 5th.

Mr. Cafferty met with residents on Shorebrook Circle. He is working on amendments to the tree ordinance. Recently, free trees were given out to residents for Arbor Day and a tree inventory is in the works. The Green Team ordinance will be introduced by the Committee at the May 24th meeting. The first few holes of the disk golf course have been marked out. He stated that the last frost has occurred so plants and vegetables can be planted outside.

Mr. Williams stated that boats are going in the water for the season at the marina. There is a lot of speeding occurring in Shark River Hills and he plans to discuss the matter with the Police Committee.

Mayor Brantley asked Mr. Lane to communicate Mr. Williams' concern with Chief Hunt. The Mayor will report later on topics discussed at meetings that he attended over the last two weeks

WHEREAS, it is in the best interest of the Township of Neptune to enter into such an Agreement;

and ending October 15, 2021, at an hourly rate of \$16.72; and,

RESOLUTION OF NEED DETERMINATION BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF NEPTUNE PERTAINING TO THE DEVELOPMENT OF 1130 HECK AVENUE SITE BY THE NEPTUNE TOWNSHIP HOUSING AUTHORITY

WHEREAS, the Housing Authority of the Township of Neptune through an affiliated entity (hereinafter referred to as the "Sponsor") proposes to demolish an existing affordable housing facility and construct or cause the construction of a new 70 unit (+/-) affordable housing project (hereinafter referred to as the "Project") pursuant to the provisions of the New Jersey Housing and Mortgage Finance Agency Law of 1983, as amended (N.J.S.A. 55:14K-1 et seq.), the rules promulgated thereunder at N.J.A.C. 5:80-1.1 et seq., and all applicable guidelines promulgated thereunder (the foregoing hereinafter collectively referred to as the "HMFA Requirements") within the Township of Neptune (hereinafter referred to as the "Municipality") on a site described as a portion of Lot 1, Block 304 as shown on the Official Assessment Map of the Township of Neptune, Monmouth County and commonly known as 1130 Heck Avenue, Neptune, New Jersey; and

WHEREAS, the Project will be subject to the HMFA Requirements and the mortgage and other loan documents executed between the Sponsor and the New Jersey Housing and Mortgage Finance Agency (hereinafter referred to as the "Agency"); and

WHEREAS, pursuant to the HMFA Requirements, the governing body of the Municipality is required to make a determination that there is a need for this Project in the Municipality.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Neptune (the "Township Committee") (not less than a majority of the full membership thereof affirmatively concurring) that:

- (1) The Township Committee finds and determines that the above referenced Project proposed by the Sponsor meets or will meet an existing housing need within the Municipality; and
- (2) Through the adoption of this Resolution, the Township Committee hereby makes the determinations and findings herein contained by virtue of, pursuant to, and in conformity with the provisions of the HMFA Law to enable the Agency to process the Sponsor's application for NJHMFA funding to finance the Project; and
- (3) The Mayor, Business Administrator, Township Clerk or any other designated Township official is hereby authorized and directed to execute and deliver any certificate or document and take such other and further actions necessary to effectuate the purposes of this Resolution; and
- (4) This Resolution shall take effect immediately upon adoption.

WHEREAS, this matter was subject to a Motion for Summary Judgment by the Defendant; filed by the Municipal Attorney, Gene J. PRIVILEGE OF THE FLOOR/PUBLIC COMMENTS

Mayor Brantley asked for public comments. The public was permitted to speak one time with a limit of five minutes. Comments were as follows:

Kathy Bray, 1804 MacBride Avenue, stated there are two burned out homes on her street. One fire occurred in February, 2019 and the other was about a year prior. She contacted Code Enforcement and nothing has been done to take the buildings down. The owner claims that the Township is holding up the demolition. She attempted to visit Bill Doolittle, Construction Official, earlier in the day. He finally came out after 45 minutes but at that point she did not want to speak with him. She asked that something be done. Mr. Gadaleta will follow-up,

Thomasina Shanks, 12 Shorebrook Circle, discussed a problem with erosion on her property. Rain is washing away the corner of her property which backs up to a stream that feeds Shark River. The area is overgrown and homeowners cannot address it because it's thick with vegetation. She understands that part of the responsibility is on the homeowner and asked for someone to show her how to address the problem. Mr. Cafferty stated that he went out and looked at the area. The homeowner needs assistance on how to clean up the area. Mr. Gadaleta replied the Township owns a drainage pipe that crosses near 4 Shorebrook Circle. The Township is hiring a contractor to replace the bulkheading and will also try to desnag the upstream area to assist with the flow of water by the time it passes behind her house. Mr. Cafferty offered to speak with Ms. Shanks after the meeting.

Dianna Harris, 17 Willow Drive, President of MURC, thanked the Township Committee members and four police officers for attending Fun Day on May 1st. She asked why the Committee was repealing the redevelopment zone at the former Dente fence site on Route 35. Mr. Gadaleta replied that there has been no action at the site. There is new zoning along Route 35 so the property owner can now apply for a project under the current zoning and not be restricted by the Redevelopment Zone. This gives control of the project to the Planning Board or Board of Adjustment. Ms. Harris asked if the owner requested the repeal of the Redevelopment Zone. Mr. Gadaleta stated the owner did not request it, but asked for a rezoning of the property so the Township Planner thought it was a good idea to allow the existing zoning to prevail. Ms. Harris then distributed MURC's list of priorities for the West Lake Avenue Redevelopment Zone to the Township Committee.

Matthew Parker, Public Works employee, stated that he is experiencing racial harassment and has filed a complaint with Human Resources. Mr. Pasquale, Labor Attorney, was present and stated that the matter has been reviewed and he will ask Human Resources to get back to him.

Kevin Pearce, Public Works employee, stated that he filed a complaint with Human Resources on April 12th and has not heard back regarding the disposition of his complaint. Mr. Anthony replied that an investigation is being done on the matter with a report going back to the Township Committee.

Jeff Lucien, represents the blue collar workers at Public Works, stated that complaints were made and told an investigation was done but now action has taken place. Mr. Anthony replied that an investigation is taking place and there should not be a discussion on the matter. Mr. Lucien stated that he wants an independent, non-biased investigation. Mayor Brantley replied that is being done.

Richard Williams, 1 Abbott Avenue, asked Mr. Gadaleta to resume his Business Administrator's report at public meetings. Mr. Williams asked what the process is to file an appeal of the tax court decision as authorized by resolution adopted at this meeting. Mr. Anthony replied that the appeal is filed in the Appellate Division. The Assessor asked to appeal the decision and received authorization from the Township Committee. Mr. Williams asked if a decision was made on parking in Ocean Grove. The Mayor replied nothing yet.

Joyce Klein, Mt. Hermon Way, asked when will there be a response to the Kimley Horn parking study. Mr. Gadaleta responded that he is waiting to hear back from each Township Committee member. Ms. Klein stated that the Homeowners Association stands ready to help.

Ann MacMorris, 15 New York Avenue, Better Parking Alliance, stated that there is a math error in the Kimley Horn parking study. She submitted corrections to the Township Committee and contends that the errors are in the payroll calculations. The residential parking permit loss is about \$16,000 per year and the parking meter would realize a profit in the first year versus a deficit as

claimed in the report. Therefore, she concluded that the plan for residential parking permits and metered parking is financially feasible. Mr. Gadaleta stated that the Township's management team went through the numbers and concur that the Township's numbers are more in line with numbers provided by the Better Parking Alliance.

Andy Levine, 98 Mt. Tabor Way, Better Parking Alliance (BPA), believes the revised numbers submitted by Ms. MacMorris were accurate. Kimley Horn was paid \$50,000 to come up with a report in which there is a \$600,000 error. The BPA alerted the Camp Meeting Association and Kimley Horn of the error, but Kimley Horn knowingly presented the flawed report on May 3rd. He asked the Township Committee to ask Kimley Horn to correct the report. It is time for all groups to work together over the next six weeks and come up with a plan. He asked the Township to appoint a facilitator and believes a recommendation could be done by July.

Connie Holmes, 33 Winding Ridge Drive, asked if the community center will be staffed with paid employees or volunteers. Mr. Gadaleta replied that the Township is not at the point to have a discussion about staffing.

Denis McCarthy, Broadway, asked if the Public Works employees have a union. Mr. Gadaleta replied yes.

Mr. Williams offered a motion, seconded by Ms. York, to adjourn. All were in favor.
