#### **PRESENTATION**

Proclamation- April 27, 2022 as Denim Day

WHEREAS, April 27, 2022 marks the 24th celebration of Denim Day in the United States. Denim Day is the annual sexual assault awareness event that works to start conversations about the destructive attitudes surrounding sexual assault, and;

WHEREAS, The Denim Day campaign began in 1999 as an international protest of an Italian Supreme Court decision to overturn a rape conviction because the victim was wearing jeans. The head judge argued that "because the victim wore very, very tight jeans, she had to help him remove them... and by removing the jeans... it was no longer rape but consensual sex", and;

WHEREAS, The judgement sparked a worldwide outcry from those who understood coercion, threats and violence that accompany the act of sexual assaults, and;

WHEREAS, Each year, we wear denim to honor this survivor and all survivors who have experienced victim blaming, and;

WHEREAS, Participating in Denim Day provides a wonderful opportunity for the community to show solidarity with survivors of abuse and to encourage open discussion about how we can work in our

personal and professional lives to reduce violence in our communities.

NOW, THEREFORE, I, Nicholas Williams, Mayor of the Township of Neptune, along with the entire Township Committee, do hereby declare April 27, 2022 as Denim Day and I encourage all to sport their denim as a symbol of protest against

misconceptions that surround sexual assault and as a show of support to all survivors of sexual assault.

#### **COMMENTS FROM THE DAIS**

Committeeman Lane attended a Fletcher Lake committee meeting where they are trying to work on their agreement with Bradley Beach. Mr. Lane was with the Shade Tree/ Environmental commission when they were handing out seedlings for free. Hooked on Fishing is occurring on Sunday June 5. May is Older American month and will be celebrating "Age my Way". There is a Covid clinic scheduled May 18 for testing and boosters.

Deputy Mayor Cafferty stated the basketball hoops were replaced at Sunshine Village.

Mayor Williams stated the Committee is proud to present a budget that reflects Neptune's commitment to financial stability and resiliency in the face of disasters and pandemics and still remain a full service community. Mayor Williams thanked Mr. Bascom and the department heads for their hard work on the budget this year.

#### REPORT OF THE BUSINESS ADMINISTRATOR

- Pump Track: Final design has been submitted and construction should begin within days.
- **Electric Vehicle Grant:** We have been notified by the NJDEP that we are to be awarded a grant in the amount of \$476,966.16 to purchase an electric garbage truck along with a charging station.
- Flood Damage Prevention Ordinance: NJDEP has completed their review of our ordinance. Staff is reviewing their recommended amendments. I would expect that the ordinance will be presented to the governing body for introduction at the next meeting.
- **Living Shoreline Project:** We are still awaiting the public notice to be posted by the Army Corps of Engineers.
- Microgrid: The BPU has awarded Neptune approval to move forward with the development of an estimated \$38 million microgrid project that will support our civic area including the municipal building, the schools, DPW, the Senior center, the Sheriff's building and more. We expect to complete the project design and be ready to award the project in September. There may be advantages of considering the area as an Area in Need of Rehabilitation to provide us with latitude in developing and awarding such a critical project. More will be shared in the coming days/weeks.








### How Your Property Tax Dollar is Divided











# Underpayment of State Aid to Neptune by Year (Totals more the \$68,416,432.00 since 2001/\$5,762,456.00 for 2022 Alone)




#### State Aid as a Percentage of Total Budget Revenues








### **Net Debt for Capital Improvements**






