Mr. Lane stated there is a backpack giveaway this Saturday at the McDonalds parking lot. Deputy Mayor Cafferty reminded all that Neptune Day will be September 10

2. Tree Removal Ordinance Requirements

Mr. Anthony stated that a letter was received that addresses potential issues with the current tree ordinance. Mr. Anthony stated there is a conservation officer who determines the fee required to be placed in trust for the tree replacement. The cemetery cost would exceed \$100,000 cost to the cemetery to move forward with the removal of trees. Mr. Anthony stated there is not an option in the ordinance to allow the Township Committee to waive fees. Mr. Anthony asked the Committee whether they would like to consider an amendment to the ordinance.

Mr. Lane asked how many plots are trying to be added to the cemetery. Mr. Anthony stated there will be an additional 399 plots included. The replacement equivalent would be 113 trees in the case of the application. The conservation officer calculated over 498 trees. Mr. Anthony stated there are other ordinances adopted in other towns that allow for these types of waivers.

Dr. Brantley stated the Planning Board recommended something, is the question changing something that was recommended. Mr. Anthony stated the Planning Board noted that compliance with the Tree Removal Ordinance is required, which is what the Township Committee is reviewing and determining whether or not the ordinance should be considered for amendment to allow for waivers for nonprofits, cemeteries, etc.

Dr. Brantley believed there should be consideration for the impact of the waiver of these fees on other parcels in town and the anticipated financial impact on the Township as a whole.

Mr. Cafferty asked what is the current cost per tree for replacement. Mr. Anthony stated he believes that it is \$15.00 per tree. Mr. Anthony confirmed action is not necessary at this time, but the cemetery is requesting action by the committee.

Mr. Cafferty asked if we could determine the fees the cemetery is charging before consideration.

Connor worked with our DPW Director, David Milmoe, QPA Melissa Zucconi and Sustainable Jersey representative Dainene Roberts throughout this summer and expressed his gratitude for the wonderful working experience with our professionals.
- Sunshine Village Pump Track: As of our last meeting, Deputy Mayor Cafferty and myself, along with other representatives of the Township, were scheduled to do a walk-through of the Sunshine Village Pump Track addition. All who attended were very pleased with the finished product, and we

are tentatively scheduled to have an official ribbon-cutting in the first week of September.

Carlton Alexander, 703 Stanford Dr. Mayor Williams stated there is security inside and outside the building. Mayor Williams will reach out to the Manager of Zen leaf if there is a way to speak to them about traffic control.

Mr. Alexander is here to speak to the Committee about the denial of the block party for Stanford Dr. Mr. Alexander stated that this is a family event and the community is excited for it. Mr. Alexander stated there are rides and vendors who come out and do a lot for the neighborhood. Mr. Alexander stated there has not been any problems. Mr. Alexander is seeking the Committee to overturn the denial from the Township Clerk's office of the permit.

Ms. Siboni summarized the reason for denial.

Frank Cooper, 718 Wakefield Rd.

Mr. Cooper stated this would be the 5^{th} year for this block party. In 2021, an attendee was rude to a responding officer. Mr. Cooper stated he spoke to Chief Fisher and a Lt. who advised they do not have an issue with the event.

Hank Coakley, Valley Rd.

Mr. Coakley asked:

- When will the center line be painted by Shoprite
- Was a letter sent by engineering to Wall Township regarding a sign to be posted on Gulley Rd. by the Legion
- Can the Township do an ordinance to ban black roofs in the next 2 years to make quality of life better?
- Can a noise complaint be made against the railroad because they blare the horn at every arrival at the train station.
- Had a business meeting in Asbury, the parking meter only takes coins. Can the Township ask Asbury to take paper money/ credit cards, etc.

Diana Harris, 17 Willow Dr.

Ms. Harris asked about the DHMAS resolution

The lights at Midtown Commons Park are out and asked for consideration to rectify.

Liberty Park is a part of the Sustainable Jersey certification. Ms. Harris is requesting consideration for security cameras at the community garden. West Lake Redevelopment update requests. Dr. Brantley stated there is a proposed agreement with developers for West Lake, but has not yet been accepted or approved.

Ms. Harris stated that with the Community Center, there is a Township owned property that is near the community garden that may be a good location for the community center. Dr. Brantley stated there is an issue with access to the lot with that parcel.

Richard Williams, 1 Abbott Ave.

Mr. Williams stated Camp meeting has received \$500,000 for a bike/fitness path. This is a controversial topic in town. Does the Township envision involvement in this project. Mr. Anthony stated the Township does not get involved in private grants because we do not have oversight of that nature of Private property. Most of Ocean Grove is private property and the Township does not have jurisdiction.

Mr. Williams spoke to Camp Meeting and stated there is litigation that "Camp Meeting should be more Christian"

Mr. Anthony stated there are current tax appeals because religious organizations are tax exempt. The assessor believes certain parcels should not be tax exempt. The use of the parcel is not falling under the religious exemption

James McNamara, 86 Asbury Ave.

Mr. McNamara asked if the proposed pathway will require zoning approval. Mr. Anthony stated there would need to be review and approvals through zoning and possibly HPC as well as construction approval.

Joan Venezia 107 Mt. Hermon Way Ms. Venezia stated she thinks the short term rental ordinance is going to hurt residents. The ordinance should have been considered with local realtors and rental properties.

Ms. Venezia is asking if there is any legal grounds to make HPC move faster on the resolution memorialization for OGNED.

Ms. Venezia asked where the parking limit ordinance on Main Ave. is. Mayor Williams stated it was pulled from the last meeting due to conflicting information.

Ms. Venezia stated the water has been turned off by the recreation areas by the township tennis court. The Township installed cameras at the location. Can an answer be provided as to the resolution after this. Ms. LaPlaca stated there is stormwater drainage issue where the pipe is on camp meeting property. A meeting

Granella Cobb, 540 Myrtle Ave.

Ms. Cobb stated she is tired of the neighbors next to her regarding her neighbor. There is trash, debris, terrible maintenance. Multiple complaints have been made. There are drugs in and out of the property. There are cameras all around her home, Ms. Cobb asked the neighbors to stop being on her yard. The neighbors came over with Ski masks to hurt her. The police were called. Ms. Cobb is not safe in her home. Ms. Cobb wants the tenants removed. 538 Myrtle Ave.

Veronica Cobb, daughter of Granella Cobb There have been rodents in the house to address the issues caused by the neighbors. The neighbors have been hostile and violent towards her mother. Ms. Cobb has sent notified the township of violations and called the police department.
