Dr. Brantley attended the Juneteenth Flag raising on June 17th.

Mr. Lane stated that Charlotte Joy Skalice passed away at 6 years old. When Mr. Lane was Mayor, a blood drive was held for the then 2-year old. Mr. Lane asked for everyone to keep her family and her in their thoughts and prayers.

Mr. Lane attended the Neptune High School Graduation and the most recent Ocean Grove Homeowner's Association.

Mr. Lane stated the Hometown Hero Banner Program is continuing and interested parties can contact April at the Administration office.

Mr. Lane stated that the Fletcher Lake Bulkhead project should begin after July 4th. The fencing is being installed. The Shade Tree Commission has met with Committeeman Lane and has recommended the placement of a 4-inch caliper River Birch.

Mr. Lane stated that over the weekend, under the leadership of Michael Bascom, the Neptune Special Operations Team Training Exercise held training.

Mr. Lane stated that sadly the Township has lost a dedicated employee, John Lalanas. Our thoughts and prayers are with his family.

Deputy Mayor York stated that she attended the Neptune Township High

School Graduation and was happy to see the graduating class.

Mayor Cafferty stated the Summer Camp at the Recreation program began today. Mayor Cafferty also attended the EMS training that occurred this weekend. We have a tendency to take EMS for granted, until they are needed. It is important that we recognize the paid and volunteers who take care of this town.

REPORT OF THE BUSINESS ADMINISTRATOR

The Business Administrator will report on capital projects and matters of general interest.

- Update on Homeless Encampment: On June 16th the Township hosted a case conference in conjunction with the DCA's Office of Homeless Prevention, Monmouth County Continuum of Care, Mental Health Association of Monmouth County, Garden State Home, Community Affairs and Resource Center of New Jersey, Interfaith Neighbors and the Affordable Housing Alliance. We worked diligently to identify 28 resident clients at the encampment and assess the appropriate next steps for each one to be placed into long-term housing while also identifying where housing opportunities may. Each resident was then assigned to one of the participating agencies for follow-up and to ensure that we continue to make progress in assessing all of their needs including mental health care and substance abuse treatment.
- Short-Term Rental Ordinance Update: As part of the updated Short-Term Rental Ordinance adopted by the Committee, the Mercantile and Code Departments have been utilizing a software program to help find properties that are advertising as short-term rentals but not properly registering with the Township. As of last week, we have filed 6 complaints in Municipal Courts with fines expected to be received in all cases, identified and brought to compliance 5 properties and currently following up on 17 additional properties to ensure compliance with the ordinance. The Mercantile and Code teams are working very hard to locate violators and I would like to take this opportunity to commend them for their efforts.
- Neptune Special Operations Team Training Exercise: This past Saturday June 24th I had the opportunity to observe members of the Neptune Special Operations Team complete the final phase of their 80-hour Structural Collapse Rescue Technician training. My thanks to Mike Bascom and his team for the invite and for the tour of our training facility.

Prior to the presentation Deputy Mayor York questioned whether the public hearing could take place because the Township Clerk did not advertise the Public hearing. Ms. Siboni indicated the advertisement for the Public Hearing was advertised in the Coaster on June 15 and has been published to the Township website in compliance with the application requirements.

Township Engineer Keith Daly will present concept plan for "Welsh Farm Property- Park Improvements" which the Township is seeking to apply for funding through Monmouth County Park Improvement Grant Program

- Mr. Lane asked if there would be any consideration for a bathroom access at the park to encourage longer enjoyment of the park.
- Mr. Williams asked if there was any consideration for parking with the disk golf recreational activity.

Mr. Martin stated he has not heard of residents interested in playing Bocce and does not understand the Township's desire to pursue this when there are other matters to be considered. Mr. Martin asked what input from the Township received from the Community on this proposed application. Mr. Martin stated he would like to note the application requires posting to the website at least 10 days prior to the public hearing.
Subsola Young, Neptune Twp.	Ms. Young stated the Township has many parks already. Why has there never been a conversation for a community center in town. There is a need to transport the children to other locations to participate in activities. Mayor Cafferty stated the Community Center was near and dear to Dr. Brantley and asked for an update. Dr. Brantley stated he began discussions on the community center 6 years ago. There has been work on where to place the community center in the Township. Dr. Brantley stated there was discussion about placing the community center in LoFreddo Field, but it is not large enough for a community center. The Township then looked at the park across from the aquatic field, but Monmouth County was not interested in selling the Township that property. Dr. Brantley stated there are currently conversations about another possible location, but they are still under review. Dr. Brantley stated there are concept drawings and engineering plans for the community center as well as a cost analysis. The cost to build a community center has increased since the discussions first began, roughly five times increase. Mr. Williams stated if a community center was placed on this property, would it serve the community? The proposed community center would need to service the residents of all sections of the Township, the schools, etc. This location would not be ideal for the community center to serve the residents of

Mr. Daly stated the grant is specific for park developments. Mr. Williams confirmed that the money could not be expended to another project. Mr. Daly stated that the Township received this property through an
Barbara Burns	acquisition grant in 2009. This park improvement has been a plan since the acquisition and in positive moves, the County has increased possible funding Ms. Burns asked the Committee to consider a different plan. The plan should leave the park in more of a natural state and encourage park goers to bike or walk to go to the park. Ms. Burns stated she wishes the Township would

make it more "Open Space" Mr. Daly stated the plan decreases the impervious coverage on the site. The proposed park improvements would beautify the park. Elza Greenblatt, Franklin Ave. Ms. Greenblatt stated the Summer camp cost has been increased threefold and asked why the Township would put \$100,000 towards this project. Ms. Greenblatt questioned the priorities. Laura Joseph Ms. Joseph suggested inclusion of children's playground equipment with the proposed bocce court. Mayor Cafferty asked Ms. Joseph which types of equipment would be desired. Ms. Joseph indicated swings and slides. Paul Martin, Franklin Ave. Mr. Martin stated he believes the meetings should be recorded. Mr. Martin asked who would maintain this park. Mr. Martin stated there are parks in Ocean Grove that the Township is required to maintain, that are not well maintained. Mayor Cafferty expressed confidence in DPW to maintain Danny Maly Mr. Maly asked what the way is to receive feedback from the community to see what the Township desires. Mr. Maly asked if there was a way to poll the community for input. Mayor Cafferty stated that outdoor recreation is also for adults. There are proposed improvements that are for adults and children. Mr. Daly stated there was a plan in 2009 for a walking path, a flower garden area, passive and active recreation areas. Mr. Daly sat with administration and DPW and discussed possible ideas while the remediation efforts were being made. One consideration for this particular park, is the consideration of the Veteran's Memorial and a focus on activities that would be quieter. The gazebo area will be a small area for passersby's to stop and rest at the picnic tables. Mr. Daly stated there was feedback from the Recreation Director for the need of outdoor exercise equipment. Mr. Daly stated the equipment would be useful but would encourage a quiet atmosphere. Deputy Mayor stated she was not on the Committee in 2009 and was not aware of the proposed plan. Deputy Mayor York stated she wishes the engineering department inviting the Township Committee to be a part of the discussions regarding the proposed plan. Joan Venezia, Mt. Hermon Way Ms. Venezia asked in the collection of data, where Bocce courts were specifically requested. Mayor Cafferty stated there were many requests made for bocce courts by residents. Patricia Monroe Ms. Monroe congratulated Ms. Joseph on her achievements of reaching the 95th Scripps National Spelling Bee. Ms. Monroe stated she was in support of the proposed plan as a part of the Veteran's Park Committee. Ms. Monroe was upset that the plans were not forwarded to the Veteran's Park Committee. Ms. Monroe also expressed frustration that the residents within 200 feet were not notified of the public hearing. Ms. Monroe stated the Township Committee needs to get the

community involved. Ms. Monroe stated there may have been additional suggestions for the improvements of this park. Ms. Monroe expressed that she was unhappy with the Disk Golf course being installed.
