REPORT OF THE BUSINESS ADMINISTRATOR

The Business Administrator will report on capital projects and matters of general interest.

- Update on Homeless Encampment: On August 9th the Monmouth County Continuum of Care held its monthly case conference regarding the status of the residents of the encampment and a progress report was provided on each resident. The most significant update is that the current official population of the camp is down to 20 residents, from a high of as many as 35 residents when I first started providing these reports to the Committee back in March. Of those 20 remaining residents, most have applied for housing assistance with various agencies in the area and are either on active waiting lists or awaiting final approvals to determine what type of assistance they may qualify for.
- Library Repairs: The railing leading up to the children's department is scheduled for construction on Saturday, August 19th & 26th; the library will be open, and the construction will not impair library services. You may recall also that the library experienced a failure in its air-conditioning system last month. A new compressor in the air-conditioning unit will need to be installed, along with roof repairs to address leaks coming from the A/C unit into the children's department. That process is expected to be scheduled for the beginning of November it will likely take two weeks and at that time the Library would need to be closed. More on that as we get further along in that process.
- Neptune Day September 9th: Saturday September 9th is our annual Neptune Day event from 12-5pm in the Neptune Middle School parking lot. (Rain Date September 10th) The Township is still looking for vendors for this event; anyone who is interested in participating should please contact Neptune Recreation for more details.

23-297 Welsh Farms Park Improvement Grant


Ms. Greenblatt stated that at previous meetings the park improvement grant, there was many public comments regarding concern about the cost of grant application and the proposed improvements including the bocce ball courts. Ms. Greenblatt asked or clarification on the project details and costs.

Mr. Jim Oris Township Engineer stated the resolution on the agenda tonight trues up the action taken by the Committee at the July 10 meeting. The Township took into consideration the public feedback, feedback from the Township committee and submitted the application. Paul Martin, Franklin Ave

Comment

Mr. Martin stated there is an issue with Ocean Grove Beach on Sunday mornings. Camp Meeting originally placed a rope to prevent/discourage people from entering. Mr. Martin stated the public trust doctrine and green acres requires access. The Camp Meeting has now placed a chain to stop access. Mr. Martin asked the Township Committee to instruct the police to enforce removal of the chain because Camp Meeting cannot prohibit access to the beach. Mr. Martins stated that green acre's recertification occurs in September and asks the Committee to fight the recertification. If Green Acres certification is removed, the Township would benefit as a taxable land. Mr. Anthony stated Township Committee has authorized MR. Anthony to share his legal opinion on this matter. Mr. Anthony stated Camp Meeting has historically enforced the regulations of a private organizations. Mr. Anthony provided an opinion to the Township that the Township cannot enforce regulations on behalf of the Camp Meeting Association. Camp Meeting has taken on self-management or self-enforcement. Similar to how we cannot enforce their regulations, it is difficult to stop them from enforcing their regulations. Mr. Anthony stated in the past, a civil rights lawsuit would be brought against the organization. Due to their Green Acres certification, the NJDEP may be notified to enforce the public trust doctrine through suit. There are now agencies established to enforce those regulations.

JP Thompson, Embury Ave.

Mr. Martins asked if the Township will pursue these options.

Ms. Thompson stated she believes that the Township can and is asking the Township Committee to take action against Camp meeting because Camp Meeting is calling 9-1-1 to report beachgoers prior to noon on Sundays. Ms. Thompson stated this is unacceptable and she believes it is illegal. Mr. Anthony stated this issue will be discussed with the Deputy Chief and Administration.

Natalie Lebron, 18 Lynn Dr.

Ms. Lebron stated the roads are being destroyed by the yard waste collection. Ms. Lebron stated the roads are getting worse. There are weeds growing in the drainpipes.

Mr. Milmoe, Director of Public Works, stated brush and yard waste are picked up with a tink claw that closes in on the brush and waste that are loaded in the container. Previously the Township only collected brush and now include yard waste. The use of green cans leads to very heavy containers for the employees to lift. The brush and yard waste are not separated. This process is more efficient and saved money for the Township. Public Works is working on having the street sweeper go out after the yard waste collection to keep the roads cleaner. The Tink claw mostly does superficial damage.

Mr. Milmoe stated the use of green cans requires an employee to throw the cans in the back of a truck. Public works is researching one arm cans for yard waste for collection.

Mr. Milmoe stated the damage being shown in the phot is not from the bucket, it is actually from water damage from the way the road was paved. The tink bucket could exacerbate the issue, but it did not cause it.

Ms. LaPlaca stated there is research on yard waste collection procedures and the possibility of a one arm collection, but the one arm collection is cost prohibitive.

Mr. Milmoe stated there was a comparison to other towns to compare towns with similar populations, taxes, etc. Many of the towns had between one-eight pickups per year and Neptune picks up once a month throughout the year. Mr. Milmoe stated he has received complaints, and the sweeper is sent to clean any left debris. Mr. Milmoe stated there is not additional debris compared to previous policies.

Mr. Milmoe stated brush is supposed to go out the Sunday of the week for pickup. There are issues with brush and waste being placed after pickups are complete and the department cannot double back.

Mr. Williams suggested that scheduling for landscaping be coordinated with the waste schedule.

Mr. Milmoe also stated that as fall season begins, they will not be using leaf bags.

Rachel Stolte, Hillcrest

Ms. Stolte stated she is concerned of the state of Neptune. Ms. Stolte stated that Mayor Cafferty has shown that he does not care about the constituency. Ms. Stolte stated Mr. Cafferty responded he did not want to respond to a question. Ms. Stolte believes Neptune deserves Better. Ms. Stolte noted the increasing taxes and projects that are not publicly supported. Ms. Stolte believed the concerns of the LGBT community do not feel heard or safe in the community. Ms. Stolte stated she is running for Township Committee in

building. Ms. Koch has requested the Township to take control of the property. There are issues with abandoned vehicles, drug usage, and homeless. There is also illegal dumping occurring at the property. Ms. Koch stated the Township is not addressing graffiti buildings. Ms. Koch stated the State has recently purchased the property. Ms. Koch asked why the State has not been contacted to address the property Ms. Koch did not agree with the dispatching of the police to regulate the police when there is an increase in crimes throughout. Ms. Koch asked if the property should be gated. Mr. Sanfelice stated that the tax bill is extremely high, and Mr. Sanfelice stated he is on a fixed income and will need to get a second job. Mr. Sanfelice was frustrated that leaves would not be picked up. Mr. Sanfelice asked what services he will be getting to account for the increase in taxes. Mr. Sanfelice stated there is an issue with snow removal on both sides of the street during snowstorms. Mr. Sanfelice stated the issue with the purchase of a leaf machine should not be an issue and would be a capital expense Ms. Fasano stated she has spoken before and has additional photos for damage to the street because of the new yard waste policy. There are issues with the debris blowing back on yards, drifting down the streets and possibly

damage to the street because of the new yard waste policy. There are issues with the debris blowing back on yards, drifting down the streets and possibly into the river. Ms. Fasano stated there is now more than 2 drivers rather than one vehicle. Ms. Fasano does not believe this would be a saved cost from the use of the older vehicles. Ms. Fasano stated residents have stated they prefer the old yard waste collection policy. Ms. Fasano did state the landscapers should be required to remove the debris they create.

Mr. Borges stated he does not support the new yard waste policy. Mr. Borges stated d the Public Works was fixing a county Road. Mr. Milmoe stated Brighton is not a County Road, it is a county Bridge. Mr. Borges stated the new yard waste policy has created a mess in the area. Mr. Borges stated he wants the Township to return to the green buckets for waste.

Mr. Mundorf stated there is a motor lodge near headliner. The roof was ripped off during a storm years ago and the property is in disrepair. Mr. Mundorf has met with local officials, department heads and Senator Gopal. Mr. Mundorf stated through the meetings, he learned the property is in the redevelopment zone. Mr. Mundorf stated there are numerous responses to the address for many issues including drugs, theft, suicide and others. Mr. Mundorf is working to have the building condemned. Mr. Mundorf has requested to meet with the redevelopment committee. Mr. Mundorf stated only through complaints have there been any remedies at the property. Mr. Roberts stated emphasized what Mr. Mundorf had stated. Mr. Roberts asked if the permits had been issued for the property. Ms. LaPlaca stated the permits were. Mr. Roberts asked if the Township has any concerns about the motel reopening with the number of calls that the police department has responded to.

Mr. Roberts stated he was present at the July meeting. The press has reported on the issue as well and stated it is an embarrassment for Neptune. Mr. Roberts stated the complaining residents do not have representation on the Committee. Mr. Roberts stated there was a portion of the fence is down and there is debris and weeds.

Mr. Brown stated he lives in a neighborhood with one catch basin. Public Works has done a wonderful job in the area.

Mr. Brown thanked the Committee and Ms. LaPlaca for the efforts at the homeless encampment. Mr. Brown is concerned about the increase of people

at the homeless encampment that are just leaving prison, using drugs or participating in illegal activities. Mr. Brown stated some of the inhabitants are targeting people at ShopRite. Mr. Brown is concerned about this activity coming to his house.

Mr. Williams stated he hopes Mayor Cafferty has a true crisis to not being at the meeting.

Mr. Williams asked to clarify if the beach access would be addressed in a workshop. Deputy Mayor York stated the Township Committee will discuss the matter with the Township Committee in advance of the September meeting.

James Allen, South Riverside Dr.

Mr. Allen stated the green containers would get too heavy with people putting too much earth into. Mr. Allen stated he has experience with the Shark River Community Garden. There would be barrel that would be picked up every 2 weeks. The barrels now must be pulled out to the street and emptied once a month. This is a physical strain.

Daniel Maly, Mt. Hermon Way Mr. Maly stated this is the first meeting he felt that he was being heard or having a responsive engagement. Mr. Maly stated he is excited for this for the future of the Committee with Ms. York as Mayor. Mr. Maly stated he was excited for what Ms. Stolte is bringing. Mr. Maly stated there was parking permit program in 60 out of 62 towns. Mr. Maly requested clarification on the percentage of properties that have landscapers.

Mr. Williams stated the point he was making was that those with landscapers have their landscapers remove the debris.

Blanche Dunbar 40Lynn Dr.

Ms. Dunbar stated she is on a dead-end. Ms. Dunbar is not sure if it is related to the size of the vehicles or the quality of asphalt. There are cracks and breaks in the asphalt that have grass growing through. MS. Dunbar stated she must pick up the limbs and brush on her property when she is physically able which leads to them being out earlier than they are supposed to be out for collection.

Joan Venezia Mt. Hermon Way Ms. Venezia stated that DPW does pick up the yard waste and thanked the public works for their efforts.

66 Cookman has not made any progress. Ms. Venezia thanked Mr. Lane for his response to the power outage caused by the Bulkhead.

Cynthia Klimart, Broadway

There are lights out on Mt. Hermon Way and Fireman's Park. Ms. Klimart stated she is disappointed and angry about the Township Committee's apathy. Ms. Klimart believes the Township Committee has let The Camp Meeting do as it pleases.

Ms. Klimart stated she had her family visit and go to the beach. Ms. Klimart stated that an employee advised Ms. Klimart that Camp Meeting owns the water. Ms. Klimart stated another family was also kicked off the beach. Ms. Klimart stated her mother has difficulty walking and asked the employee to remove the padlock to let her mother pass safely. Ms. Klimart contacted the police, Officer Palara responded and stated he is unable to do anything or remove the padlock. There were additional officers dispatched and Ms. Klimart stated the officers would not speak to Ms. Klimart. Ms. Klimart stated she believes that the Police are paid by the Township and should be there to protect the rights of the residents, not Camp Meeting. Mr. Martins stated there are people who are going to the beach prior to noon

Shane Martins, Mt Hermon Way

on Sunday based on rights through the Public trust Doctrine and Green Acres. Mr. Martins stated the picture of a padlock stopping a person who was disabled from going on the beach when numerous able-bodied people were

able to go on the beach. Mr. Martins stated he asked the officer if they could call the Camp to ask them to open the chains for this person and the officer stated they were not getting involved in that manner. Mr. Martins proposed a scenario for the Township Committee for their opinion. Mr. Martins made statements from the Public Trust Doctrine.

Ellen Clasik, Waterview Court

Ms. Clasik asked if the permits for the motel were for demolishing or for fixing. Ms. LaPlaca stated the permits are for fixing portions of the property. Ms. Clasik stated she was surprised that Mr. Lane was not aware of the calls to the Police Department.

Mr. Lane stated when he is made aware of the issues, he investigates them and will make sure to look into this matter.
