ITEMS FOR DISCUSSION IN OPEN SESSION

1. Beach Access and Action by NJDEP

Mr. Anthony stated that there has been a discussion about beach access and Mr. Anthony has submitted opinion letters on this matter. Mr. Anthony stated that the beach is under the Green Acres exemption whereas the other exemptions are under religious entities exemption. The Township is in receipt of correspondence that states the Township has the ability to remove a tax exemption.

Mr. Anthony stated the exemption that exists was certified by the NJDEP years ago. The exemption states that if there is an open space for everyone, the property is exempt from tax exemption. This exemption must be reapplied for every three years. This exemption is investigated by the NJDEP, not by the municipality. There are other instances where the investigation was down by the Township Assessor's office. The NJDEP division for Green Acres investigates and determines status. Mr. Anthony cited Milford v. Garfield to challenge a Green Acres exemption. NJDEP re-certified the exemption, and it was appealed in court. The case stated that since the NJDEP creates the examination, they should have insight. The Tax Assessor is noted as having final say. NJDEP

Mr. Anthony stated that even though the legislation offers the powers to the Township Assessor to revoke the exemption, he does not have the basis to revoke the exemption. Mr. Haney indicated that the Township did not do the investigation and if the NJDEP recertifies the exemption, there would be no basis for the Township to remove the exemption. Mr. Anthony stated the Tax Assessor is an agent separate from the Township and cannot be told how to take action under the statute. The State has made an assessment that there is no violation to the Green Acres.

Mr. Anthony stated the focus of the Township should be on the letter from NJDEP Bureau of Coastal and Land Use Compliance and Enforcement on August 10 that was a warning letter for compliance violation. This is an enforcement of the Public Trust Doctrine. Mr. Anthony stated a complaint should be filed with this specific bureau of the NJDEP to ask that they enforce on this violation.

Deputy Mayor York stated she believes the Township Attorney should write the stated letter to NJDEP. Mayor Cafferty and Committeeman Williams were in agreement.

As of our last update, the population of the camp was down to 20 residents from a high of as many as 35 residents. Of those 20 remaining residents, many have applied for housing assistance with various agencies in the area or are either on active waiting lists or awaiting final approvals to determine what type of assistance they may qualify for. Mr. Martin stated he has been before the Township Committee many times about protecting the rights of residents of Neptune Township, especially relating to Camp meeting. This includes issues with the beach badges, pier, tent, and cottage inspections. Mr. Martin stated previously there is nothing the Township can do, but it seems the Township has oversight to the Green Acres exemption. There are multiple police reports regarding access to the beach on Sunday. There was an officer on the beach who advised beach goers to abide by the regulations of the Camp Meeting Association. Mr. Martin stated there is a permit issued for the construction of the pier signed by Michael Badger and there were several parts in the permit, there were multiple statements to the public trust doctrine in the permit documents. There has been nothing done by the Township Committee, Township Attorney or Neptune Police regarding this matter. Mr. Martin stated that if the beach in Ocean Grove was taxed it would bring in about a million dollars a year. That money could be utilized on many aspects of Neptune Township. Mr. Martin stated the Committee has a responsibility to do something about it.

Mr. Martins read an e-mail exchange he had with a representative, Ms. Cook, of the New Jersey DEP. Mr. Martins sent an e-ail to NJDEP confirming that the Township, not the NJDEP has the authority to revoke Green Acres exemption status. Ms. Cook responded that the NJDEP recommends the tax exemption and the Tax Assesor may either approve or deny. Mr. Martins confirmed with Ms. Cook that Tax Assessor's can and have revoked exemption status. Mr. Martins also asked whether the Township requires a recommendation from the NJDEP to revoke the Green Acres exemption. Ms. Cook responded that the Township can revoke the exemption on their own terms and does not require a recommendation from any NJDEP division.

Mr. Anthony stated that Mr. Martin has never handled a tax appeal in Ocean Grove. Mr. Anthony stated that while the Tax Assessor may do it, it would be a mistake because there is not a basis for revoking the exemption.

Ms. Valentine was a previous employee and was provided a copy of the Public Trust Doctrine. Ms. Valentine just wants to address the Public Trust Doctrine and public access to the main high water line. The Public Trust Doctrine must states a municipality must maintain visual and physical access, create ordinances that encourage access and uphold the access requirements of the state and federal government. Ms. Valentine stated she entered a private agreement with Camp Meeting to grant access to swimming on Sundays. The police are not addressing that the violations of the Public Trust Doctrine.

Mr. Anthony stated that the actions of Ms. Valentine prompted an opinion letter from Mr. Anthony. Mr. Anthony stated the Township does not enforce the rules and regulations of Camp Meeting Association. The Township can bring a lawsuit or bring the action to the State of New Jersey, which the Township Committee authorized Ms. Harris asked about the community garden award for \$2,000.

Ms. Remler asked why the chains are there? Mayor Cafferty stated the Attorney has been instructed to write to the State of New Jersey to address this issue.

Mr. Anthony stated that unlike the other beaches in New Jersey are not private beaches.

Cindy Kleinbart, Broadway

Ms, Kleinbart stated the police who are dispatched that they are to be neutral. Mr. Anthony stated the police department has been instructed not to enforce the regulations of the Camp Meeting Association. Ms. Kleinbart's mother could not go to the beach for her father's birthday celebration.

Ms. Kleinbart stated she is concerned that a discussion occurred in workshop that the public was not aware of. Ms. Kleinbart stated she does not believe the Committee is working fast enough.

Eliza Greenblatt, Franklin Ave.

Ms. Greenblatt stated the Township Committee should know about. The Camp Meeting invited a speaker who preached antisemitic thoughts to children. The speaker stated that the Jews hurt Jesus and killed him. This is blatant antisemitism. The Camp Meeting association is toxic in many ways and it is time for Neptune Township to stop the preferential treatment.
