#### **ITEMS FOR DISCUSSION IN OPEN SESSION**

#### 1. Footbridge Regulations

Committeeman Lane stated there was an update to the ordinance that addresses any wheeled vehicle on the boardwalk. Since the regulations have been in place, it has been noted that the footbridges are now being used to traverse the area.

Mr. Anthony stated that the Township can enforce at this time based on the sidewalk ordinance, but Mr. Anthony can also provide an amendment to the ordinance to include the footbridge.

Mayor Cafferty asked if the person would be able to walk wheeled vehicles over the footbridge. Mr. Anthony stated this would allow them to walk the vehicle similar to sidewalks. Mayor Cafferty asked if Committeeman Lane would be able to confirm this is acceptable with Bradley Beach and Asbury Park as we share the bridges.

## REPORT OF THE BUSINESS ADMINISTRATOR

The Business Administrator will report on capital projects and matters of general interest.

- **Spotted Lanternfly Spraying:** Treatment for spotted lanternflies will take place beginning on September 28th at five locations across the Township Veterans Memorial Park, Sunshine Village Park, Beverly Way Park, Liberty Garden and Bert Willis Ballfields. Spraying will occur between 8am-5pm if for any reason it has to be cancelled on that date, it will take place on September 29th and/or 30th during the same timeframe. Treatment is applied directly to the affected trees where spotted lanternfly activity is identified or suspected. The treatment will be conducted by Viking Pest Control.
- 111 New York Road (Neptune Motor Lodge): In light of the severe weather we experienced over the weekend, our Construction Official has made multiple visits to the property to conduct visual inspections and ensure that there is no additional storm damage occurring that may present a hazard to the surrounding neighborhood. He also informed me that the owner of the motel has six months from the date that construction permits were issued to begin the planned renovations, and permits were issued approximately two months ago. On the redevelopment front, the Township to date has only received \*informal\* communications from the subject property owners in the redevelopment area about their intentions to submit a proposed redevelopment plan for our consideration. The Redevelopment Committee looks forward to evaluating their formal submission as soon as it is received.

- Update on Homeless Encampment: On September 13th the Monmouth County Continuum of Care held its monthly case conference, which was attended by myself and representatives of the Police Department. Overall, 20 residents remain but the difference from my previous reports is that a good majority have now expressed the desire to leave the camp and get assistance. Many of them are also on their final steps to being placed in appropriate housing. There has also been an increased police presence in the neighborhood and on the Shop Rite property which seems to be successful in terms of deterring any criminal activity. The next case conference is on October 11th.
- State Treasury Department is engaging in an outreach program to send out canvassers to engage with residents about the Anchor program.

Mr. Martins stated the cannabis retailer was paying taxes on medical cannabis. Mr. Martins asked if this also includes taxes on recreational sales. Ms. LaPlaca stated the resolution is clarifying that the ordinance intended to tax both medical and recreational cannabis.
