Mayor York announces that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in The Coaster and the Asbury Park Press on January 5, 2024, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk. In addition, the meeting agenda is posted on the Township web site (www.neptunetownship.org).

<u>ITEMS FOR DISCUSSION IN OPEN SESSION</u>

1. RFP Listings

Ms. Siboni summarized the list of RFPs that we have advertised or are planning to advertise. Ms. Siboni sought input from committee to confirm the list is representative of what the Township Committee is seeking.

Mr. Anthony stated the Township Committee could utilize a "Special Counsel" for positions like Rent Leveling Attorney, Tax Appeal Attorney, Attorney for Code and Zoning, etc. Mr. Anthony stated this is under the RFPs as the "Assistant Township Attorney"

Mr. Stroud asked for a clarification for a difference between a CFO and financial advisor.

Mr. Jones asked if there was a comprehensive list of the positions that are filled in the Township. Ms. Siboni stated the list was comprehensive and the details in the proposal packet which is publicly available notes the specifics.

2. Animal House Ordinance

Mr. Anthony summarized the amendments previously made to Animal House Ordinance. Mr. Anthony stated that through his research, the legislation on the matter shows that bonding cannot occur without a conviction. A change to the ordinance would not be possible without a legal challenge.

3. Ocean Grove Parking Permit Parking Pilot Program

Mr. Anthony read the previous proposals for parking and there was a subcommittee that submitted a proposal for 2 parking zones; 1 seasonal and 1 annual zone. Mr. Anthony stated the Township Committee can review the proposals and make a recommendation. Mr. Anthony stated the Township Committee did not agree to the proposal to draft and ordinance so if the Township Committee wishes to draft an ordinance it will need to be drafted and submitted to the assignment judge.

Mr. Jones asked for clarification for the process to move forward. Mr. Anthony stated he would need a consensus from the Township Committee on the draft ordinance to submit the ordinance to the assignment judge of Monmouth County before the Township Committee can consider. Mr. Jones asked for confirmation of the timeline on the process for the ordinance. Mr. Anthony summarized his experience and that the timeline is not a set guarantee. Mr. Anthony did encourage the Township Committee to consider it quickly in order to effectuate in time.

Mr. Stroud stated there have been multiple proposals to review for consideration. Mr. Stroud made the following notations:

- Mr. Stroud is against the ability to print passes at home and believes that residents will need to come to Town Hall to receive.
- Mr. Stroud stated he does not agree with the license plate information should not be included on the permit. The permit should only include a permit number or unique identifier instead.

• Mr. Stroud suggested that visitor passes should not be included and that homeowners can use the 2 issued passes

Mr. Jones asked about the process for time limit parking on Main Ave. Mr. Anthony stated this did occur. Mr. Jones asked if the police department would be enforcing the parking permit proposal or would residents be calling on each other. Mr. Anthony stated he believed that the residents would report. Mr. Stroud stated there is an issue with Ocean Grove feeling like a gated community and surrounding towns do not feel welcome or open to partnership.

Mr. Stroud stated there is discourse on Social Media is that there has always been an issue with parking in Ocean Grove, but Mr. Stroud stated that in the History of Ocean Grove, Asbury Park was not always developed the same way. Mr. Stroud wanted to know that the processes that would be used are actually enforceable, applicable and useful. Mr. Stroud asked if there would be a parking authority to take on the concern. Mr. Stroud stated he is not sure that the use of the Police Department to enforce parking permits is for the best use.

Mr. McMillan would like to come to a consensus on the process to progress the consideration. Mr. McMillan asked about the return of the parking permits when residents moved.

Mr. Anthony stated that due to the calendar of the Township Committee Meetings, a new ordinance would not be ready to consider this year.

Mr. Lane stated he agreed with Mr. Stroud that the permits should not be able to be printed at home and they should be annually renewed. Mr. Lane stated that there needs to be a limit to the number issued. Mr. Lane stated that he believes the permits should be provided without cost.

Mr. Stroud had some questions about the requirements to establish the criteria as a resident. Mr. Stroud stated there are parking permits for fire and emergency personnel or Township employee. Mr. Stroud wants to ensure those who are working for the town are not accidently ticketed. Mr. Anthony stated there were some concerns about the proof of residency that needs to be more strict otherwise it may be taken advantage of.

Mr. Jones asked about signage and if approval from the assignment judge. Mr. Anthony will draft an ordinance based on the proposal from the parking subcommittee.

4. Liaison for Community Engagement, community outreach

Mr. Jones wants to encourage sections and organizations in town to attend Township Committee meetings and to bring small presentations. Mr. Jones would like to assist with engagement within the community. Mayor York stated she believes Mr. Jones would like to be appointed as this liaison. Mayor York thinks this would be a positive initiative. Mr. McMillan stated he was for this position, but had believed it would be a paid position. Mr. McMillan stated that as elected officials, they all are liaisons for community engagement and outreach. Mr. Lane believed it was a good idea and would be happy to help Mr. Jones.

5. Ordinance to prohibit the manufacture, sale, advertisement or concealment of any illicit THC product

Mr. Stroud stated there are only limited numbers of licensed establishments who are able to sell any product with THC. Mr. Stroud would like to consider an ordinance that prohibits the sale of THC products. Mr. Lane agreed with Mr. Stroud that this ordinance is necessary in Neptune Township. Mayor York stated the Chief of Police is aware and has been working on this issue, but the sales continue to pop up very quickly.

REPORT OF THE BUSINESS ADMINISTRATOR

The Business Administrator will report on capital projects and matters of general interest.

Homeless Encampment: The Monmouth County Sheriff's Department was out at the encampment on the morning of Wednesday November 6th, informing the remaining residents that they must vacate the property by November 20th, and that Sheriff's Officers would be coming back on that date to ensure that the property has been vacated. Our nonprofit partners continue to work with the remaining residents alternative placement options such as motels or other emergency housing, and have advised them to leave the camp. I have also asked our Special Counsel to set up a meeting through legal counsel for the property owner so we can discuss next steps with respect to clean up and securing of the property.

· Zoning and Land Use Boards Moving to Town Hall: Please be advised that, as of this Friday November 14th, anyone having business with the Zoning Officer or any of our Land Use Boards (Zoning, Planning HPC) may come to Town Hall, as these functions and the employees who perform them are relocating from the OEM/DPW building on Heck Avenue to

25 Neptune Boulevard.

· Eagle Scout Proposal and Presentation: The Committee will receive a presentation from Robert Delaney regarding a proposed Eagle Project that he would like to undertake, with the Township's support, at Shark River Memorial Park. Mr. Delaney made a presentation to the Township Committee about his proposed Eagle Scout Project which includes remulching and planting azaleas, repainting benches. Mr. Delaney is hopeful the Township Committee may donate a tree. Mayor York asked when the project would begin. Mr. Delaney stated he hopes to start in March 2025.

Mr. Jones asked if the Township has a budget for the maintenance of Parks. Mr. Lane stated that the budget is for maintenance. Mr. Lane stated he believes it is a great project and is looking forward to see the project. Mr. McMillan asked if the Township Committee can make personal donations and would be amendable to the Township to consider donating a tree to his project.

Mayor York thanked Mr. Delaney for having an eye to want to beautify the park and the Township Committee is proud to support Mr. Delaney in his progress to an Eagle Scout and on his project.
