## PLANS/APPLICATIONS FOR REVIEW:



- <u>ZBA 15/03 for Block 421 Lot 1 also known as 700 Aktins Avenue</u> Amended Conditional Use Application Suggestions/Comments:

   The Commission does not object to the proposed use variance.
- PB 15/01 for Block 909 Lot 7 also known as 2100 West Lake Avenue
  Minor Subdivision
  Suggestions/Comments:
  - 1) Although the Commission does not object to the minor subdivision, the Commission does request a copy of the tree report. If the Applicant is not required to submit a tree report, the Commission ask the Applicant attempts to preserve as many trees as possible.

Suggestions/Comments:

- 1) The Commission strongly urges the Township of Neptune to re-zone this area as Open Space;
- However, in the event the property is re-zoned as Residential, the Commission encourages the Board to require the applicant to consider off-site drainage structures to improve the well known erosion and draining issues.
- 3) The Impact Statement submitted fails to assess to capacity of adjacent parcels for displaced wildlife.
