DISCUSSIONS/PRESENTATION

- 1. Single Stream Recycling Program: Mr. Longo's letter to Township Mayor and Committee discussed.
- 2. 2014 ANJEC Grant application: Ms. Arcoleo and Ms. Soleil wish to submit a \$1500 open space grant request to ANJEC for Liberty Park. The improvements consist of a three bin composting system, extension of the water supply from spigot to the gardens, and to create a native beneficial garden, attracting beneficial insects. All three projects will have informative signs posted. Ms. Summer offered a motion, second by Mr. Toohey. All were in favor; Ms. Arcoleo will contact Township of Neptune Committee for approval.
- 3. Arbor Day: Ms. Arcoleo recommended a tree planting seminar for Township of Neptune Department of Public Works, contacting Director Wayne Rhode for final approval. Mr. Amborsio offered motion, seconded by Mr. Halifko. All were in favor.
