**Minutes:**

*Anthony DiMaio made a motion to approve the November 14, 2024 Minutes. William Grafton seconded and all approved.*

**Treasurer's Report:**

Pam Reinhardt presented JCPL bills \$41.74, \$227.19, \$148.25.  
The balance of the checking account is currently \$18,952.51

*Anthony DiMaio made a motion to approve paying the bills. Sal Galasetti seconded and all approved.*

Anthony DiMaio presented two invoices from the Canada Geese Management for 2024 (07/10/2024 and 01/01/2025). Both invoices show the client is Borough Administrator, Borough of Bradley Beach. Each is for \$2500.

**New Business:**

Anthony DiMaio spoke to Mayor Larry Fox but did not send an email or letter. He discussed the insufficient check for payment of the BB 2024 Annual Contribution (\$2550 where \$3000 is due per charter). Anthony also told Mayor Fox that BB owes FLC \$2500 reimbursement for our advance to cover their Canada Geese Management fee for 2024.

The members discussed the debt and how best to recover it. Linda Henderson wrote a letter addressed to the Borough of Bradley Beach Administrator with a clear demand for payment from BB. It was decided that we not engage in a discussion of any deductions as that would need to be addressed with Neptune in accordance with the Charter.

*Anthony DiMaio made a motion that he and Pam Reinhardt will sign the letter written by Linda Henderson and Anthony will deliver the letter and check to the Borough of Bradley Beach on Friday December 6 and ask for proof of receipt. William Grafton seconded and all approved.*

*Linda Henderson made a motion for an emergency meeting on December 19, 2024 at 6:00pm to ensure that full payment from Bradley Beach is confirmed. Anthony DiMaio seconded and all approved.*

*Linda Henderson made a motion to cancel the January meeting. Sal Galasetti seconded and all approved.*

*Linda Henderson made a motion to adjourn. Sal Galasetti seconded and all approved.*
