The home is a one story frame structure approximately a	
hundred years old. Demolition of the rear wall, portions	
of the side walls, and a small area of roof towards the	
rear is proposed in order to facilitate architectural	
additions. An existing rear dock, not original, is to be	
demolished. The existing front porch and front wall	
and most of the existing hip roof will remain. An	
existing rear bump-out for mechanical equipment, that	
appears to be a later addition to the home, is to be	
demolished. Most of the exposed raftertails at the	
front and sides will be preserved. The existing shed	
is to be demolished.
