Proposal to replace insulation and rotting sheathing around entire house which necessitates removal of current cedar. Proposing to replace cedar clapboard on four sides of the house with Hardiboard Boothbay Blue color (comparable to Benjamin Moore Phillipsburg Blue HC-159 on the approved list. Hardieboard replacement will match existing 8" reveal. Decorative elements will be repeated.

DISCUSSION ITEMS:

Proposal to replace insulation and rotting sheathing around entire house which necessitates removal of current cedar would require review by the full HPC Commission. Please be prepared to provide testimony as to your proposal to remove and replace the original historic siding.
